THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 207/2009 of 26 February 2009 on the Community trade mark (1), and in particular Article 125(1) and (2) and Article 136 thereof,

Whereas:

- (1) By Decision of 25 May 2010 (2), the Council appointed Mr António-Serge DE PINHO CAMPINOS as President of the Office for Harmonisation in the Internal Market (trade marks and designs) ('the Office').
- (2) On 20 May 2014,the Administrative Board of the Office submitted to the Council its proposals concerning the renewal of the term of office of the President of the Office and the appointment of a Chairman of a Board of Appeal of the Office.
- (3) The term of office of Mr António-Serge DE PINHO CAMPINOS as President of the Office should be renewed for a period of 5 years.

HAS ADOPTED THIS DECISION:

#### Article 1

The term of office of Mr António-Serge DE PINHO CAMPINOS, born in Poitiers (France) on 24 October 1968, as President of the Office is hereby renewed for the period from 1 October 2015 to 30 September 2020.
