## RECOMMENDATION OF THE EUROPEAN CENTRAL BANK

of 16 December 2014

to the Council of the European Union on the external auditors of Lietuvos bankas

(ECB/2014/58)

(2014/C 465/01)

THE GOVERNING COUNCIL OF THE EUROPEAN CENTRAL BANK,

Having regard to the Statute of the European System of Central Banks and of the European Central Bank, and in particular Article 27.1 thereof,

Whereas:

- (1) The accounts of the European Central Bank (ECB) and national central banks of the Member States whose currency is the euro are audited by independent external auditors recommended by the ECB's Governing Council and approved by the Council of the European Union.
- (2) Pursuant to Article 1 of Council Decision 2014/509/EU <sup>(1)</sup> Lithuania fulfils the necessary conditions for the adoption of the euro, and the derogation in favour of Lithuania referred to in Article 4 of the 2003 Act of Accession <sup>(2)</sup> is abrogated with effect from 1 January 2015.
- (3) Pursuant to Article 50 of the Law on Lietuvos bankas, from 1 January 2015 the annual financial statements of Lietuvos bankas will be audited by independent external auditors recommended by the ECB's Governing Council and approved by the Council.
- (4) Lietuvos bankas has selected UAB 'PricewaterhouseCoopers' as its external auditors for the financial years 2015 to 2017,

HAS ADOPTED THIS RECOMMENDATION:

It is recommended that UAB 'PricewaterhouseCoopers' should be appointed as the external auditors of Lietuvos bankas for the financial years 2015 to 2017.

1. On 17 December 2014, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 <sup>(1)</sup> by which Fujitsu Limited ('Fujitsu', Japan), Panasonic Corporation ('Panasonic', Japan) and Development Bank of Japan Inc. ('DBJ', Japan) acquire within the meaning of Article 3(1)(b) and 3(4) of the Merger Regulation joint control of a newly created joint venture ('NewCo', Japan), by way of contribution of assets.
2. The business activities of the undertakings concerned are:
  - for Fujitsu: provision of IT products and services,
  - for Panasonic: provision of IT products and services,
  - for DBJ: provision of investment and loan services,
  - NewCo: design, manufacture and sale of large-scale integration semiconductor products, namely logic integrated circuit devices.
3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the Merger Regulation. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under the Council Regulation (EC) No 139/2004 <sup>(2)</sup> it should be noted that this case is a candidate for treatment under the procedure set out in this Notice.
4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
