On 3 July 2015, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 ⁽¹⁾ by which the Lone Star Funds belonging to the Lone Star Group ('Lone Star', United States/Bermuda) acquire within the meaning of Article 3(1)(b) of the Merger Regulation control of the whole of the undertaking Balta Finance S.à.r.l, the holding company of the Balta Group ('Balta', Luxembourg) by way of purchase of shares.

2. The business activities of the undertakings concerned are:

- for Lone Star: investment in real estate equity, credit and other financial assets,
- for Balta: manufacturing and sale of textile floor coverings.

3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the Merger Regulation. However, the final decision on this point is reserved. Pursuant to the Commission Notice on a simplified procedure for treatment of certain concentrations under the Council Regulation (EC) No 139/2004 ⁽²⁾ it should be noted that this case is a candidate for treatment under the procedure set out in this Notice.

On 6 July 2015, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 ⁽¹⁾ by which the undertaking Horizon Holdings III S.A.S. (United Kingdom), controlled by investment funds managed by Apollo Management, L.P. (United States), acquires within the meaning of Article 3(1)(b) of the Merger Regulation control of the whole of the undertakings Saint-Gobain Emballage S.A. (France), Saint-Gobain Vicasa S.A. (Spain), Saint-Gobain Vidros S.A. (Brazil) and Obale S.A.S. (France) which together form the Verallia Group by way of purchase of shares.

2. The business activities of the undertakings concerned are:

- Apollo Management, L.P. invests in companies and debt issued by companies involved in various businesses throughout the world, for example in the chemical, financial services, and media industries,
- Verallia Group manufactures and supplies glass bottles and jars for the food and beverage industries worldwide.

3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the Merger Regulation. However, the final decision on this point is reserved.
