Prior notification of a concentration
(Case M.10343 – Discovery/WarnerMedia)

(Text with EEA relevance)

(2021/C 484/07)

1. On 17 November 2021, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 ⁽¹⁾.

This notification concerns the following undertakings:

- Discovery, Inc. ('Discovery', United States),
- The business, operations, assets and liabilities constituting the WarnerMedia segment of AT&T Inc. ('WarnerMedia', United States).

Discovery will acquire within the meaning of Article 3(1)(b) of the Merger Regulation control over WarnerMedia. The concentration is accomplished by way of purchase of shares.

2. The business activities of the undertakings concerned are:

- for Discovery: a global media company that provides content, largely non-fiction, including a variety of genres such as natural history, sports, food and travel, to viewers worldwide through multiple distribution platforms,
- for WarnerMedia: a global media and entertainment business that develops, produces, and distributes films, television content, and other content globally.

3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the Merger Regulation. However, the final decision on this point is reserved.

4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.

Observations must reach the Commission not later than 10 days following the date of this publication. The following reference should always be specified:
