## MINUTES OF THE SITTING OF 27 JANUARY 2022

IN THE CHAIR: Roberta METSOLA

The session adjourned on Thursday 20 January 2022 was resumed.

The sitting opened at 12.32.

## 7. Formal sitting — International Holocaust Remembrance Day

From 12.33 to 13.49, a formal sitting of Parliament was held on the occasion of International Holocaust Remembrance Day.

The President made a speech.

The guitarist Ferenc Snétberger played *Hallgató — In Memory of my People*, dedicated to the Sinti and Roma people persecuted under the Nazi regime.

Margot Friedländer, writer and Holocaust survivor, Charles Michel (President of the European Council) and Ursula von der Leyen (President of the Commission) made speeches.

Parliament observed a minute's silence.

The violinist Philippe Graffin and the cellist Raphael Wallfisch played *Kaddish* by Maurice Ravel.
