COMMISSION OPINION

of 12 January 2023

relating to the plan for the disposal of radioactive waste arising from the decommissioning and dismantling of the Grohnde (KWG) nuclear power plant in the Federal State of Lower Saxony,

Germany

(Only the German text is authentic)

(2023/C 14/01)

The assessment below is carried out under the provisions of the Euratom Treaty, without prejudice to any additional assessments to be carried out under the Treaty on the Functioning of the European Union and the obligations stemming from it and from secondary legislation (1).

On 24 February 2022, the European Commission received from the Government of Germany, in accordance with Article 37 of the Euratom Treaty, the General Data relating to the plan for the disposal of radioactive waste (²) arising from the decommissioning and dismantling of the Grohnde (KWG) nuclear power plant.

On the basis of these data and additional information requested by the Commission on 16 June 2022 and provided by the German authorities on 27 July 2022, and following consultation with the Group of Experts, the Commission has drawn up the following opinion:

- 1. The distance from the site to the nearest border of another Member State, in this case the Netherlands, is 160 km.
- 2. During normal decommissioning and dismantling operations of the Grohnde (KWG) nuclear power plant, the discharges of liquid and gaseous radioactive effluents are not liable to cause an exposure of the population in another Member State that would be significant from the point of view of health, in respect of the dose limits laid down in the Basic Safety Standards Directive (3).
- 3. Solid radioactive waste is temporarily stored on site (in the new Transport preparation hall) before shipment to licensed treatment or disposal facilities located in Germany.

Non-radioactive solid waste and residual materials in compliance with clearance levels will be released from regulatory control for disposal as conventional waste or for reuse or recycling. This will be done in compliance with the criteria laid down in the Basic Safety Standards Directive.

4. In the event of unplanned releases of radioactive effluents that may follow the accidents of the type and magnitude considered in the General Data, the doses likely to be received by the population of another Member State would not be significant from the point of view of health, in respect of the reference levels laid down in the Basic Safety Standards Directive.

In conclusion, the Commission is of the opinion that the implementation of the plan for the disposal of radioactive waste in whatever form, arising from the decommissioning and the dismantling of the Grohnde (KWG) nuclear power plant, located in the Federal State of Lower Saxony, Germany, both in normal operation and in the event of the accidents of the type and magnitude considered in the General Data, is not liable to result in a radioactive contamination, significant from the point of view of health, of the water, soil or airspace of another Member State, in respect of the provisions laid down in the Basic Safety Standards Directive.

New national side of euro coins intended for circulation

(2023/C 14/04)



National side of the new commemorative 2-euro coin intended for circulation and issued by France

Euro coins intended for circulation have legal tender status throughout the euro area. For the purpose of informing the public and all parties who handle the coins, the Commission publishes a description of the designs of all new coins (¹). In accordance with the Council conclusions of 10 February 2009 (²), euro-area Member States and countries that have concluded a monetary agreement with the European Union providing for the issuing of euro coins are allowed to issue commemorative euro coins intended for circulation, provided that certain conditions are met, particularly that only the 2-euro denomination is used. These coins have the same technical characteristics as other 2-euro coins, but their national face features a commemorative design that is highly symbolic in national or European terms.

Issuing country: France

Subject of commemoration: Olympic Games 2024

Description of the design: One hundred years after the 1924 Olympic Games, France is once again hosting the Summer Games, which will take place in Paris in 2024, an event with international echo whose intensity gradually builds in the years leading up to the event.

On the occasion of the countdown to the Olympic Games, Monnaie de Paris wishes to celebrate the road to the Games. It therefore plans to issue each year 2022, 2023 and 2024 a commemorative two-euro coin with an original face celebrating the Games, through the heritage of France and Paris.

The design represents the genius, a national figure and icon of French numismatics. It is depicted practicing discus throwing in an 'ancient' way in reference to the Olympic Games of the Antique era. His silhouette blends with the one of the Arc de Triomphe, a key element of Parisian heritage. It forms a common axis with this emblematic monument of victory. In the background, an athletics track in which the emblem of Paris 2024 is inserted on the right side, is represented. The year date, the mention RF and the mintmarks are inserted under the arch and around the foot of the Arc.

The coin's outer ring depicts the 12 stars of the European flag.

Estimated number of coins to be issued: 260 000

Date of issue: September 2022

Prior notification of a concentration (Case M.10807 – VIASAT / INMARSAT)

(Text with EEA relevance)

1. On 9 January 2023, the Commission received notification of a proposed concentration pursuant to Article 4 and following a referral pursuant to Article 22 of Council Regulation (EC) No 139/2004 (1).

This notification concerns the following undertakings:

- Viasat, Inc. ('Viasat', US),
- Inmarsat Group Holdings Limited ('Inmarsat', UK), controlled by Connect Topco Limited ('Connect Topco', Guernsey).

Viasat will acquire within the meaning of Article 3(1)(b) of the Merger Regulation sole control of Inmarsat.

The concentration is accomplished by way of purchase of shares.

The concentration has been referred to the Commission by the Spanish National Markets and Competition Commission ('CNMC') pursuant to Article 22(3) of the Merger Regulation. The referral was subsequently joined by Belgium, Bulgaria, Cyprus, Denmark, Finland, France, Ireland, Italy, the Netherlands, Norway, Romania and Sweden.

- 2. The business activities of the undertakings concerned are the following:
- for Viasat: publicly-listed company which provides two-way satellite-based communications services globally, and owns
 and operates 4 geostationary earth orbit satellites. Viasat has three core business segments: satellite services, commercial
 networks, and government systems,
- for Inmarsat: privately-held company which offers two-way satellite-based communications services globally, and owns and operates 15 geostationary earth orbit satellites. Inmarsat is organised into four business unit: maritime, government, aviation, and enterprise.
- 3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope of the Merger Regulation. However, the final decision on this point is reserved.
- 4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
