joint range and of the MAN range of commercial vehicles. As a rule these importers carry the name of 'VW-MAN Truck and Bus' or an equivalent in the language of the country concerned. VW has a shareholding of 5 to 13% in these import companies. The remaining shares are held by MAN and other persons and companies, including VW and MAN importers.

- 11. The parties undertake for the duration of the agreement not to compete in any way, directly or indirectly, against vehicles in the joint range with lorries of six to nine tonnes maximum gross weight.
- 12. An arbitration clause covers disputes arising out of the agreements; the clause foresees the possibility of having recourse to the ordinary legal means. The cooperation agreement is

- concluded for an indefinite period, and may be terminated by giving 36 months notice at the end of any calendar year, but not before 31 December 1987.
- 13. The Commission intends to take a favourable decision on the agreement in its amended version, a summary of which is published here. Before doing so it invites all interested third parties to submit their observations within one month from the date of this notice, quoting reference No IV/29.329, to:
