

MINUTES OF PROCEEDINGS OF THE SITTING OF THURSDAY,
11 OCTOBER 1984

RESOLUTION

on the arrest in Afghanistan of Mr Jacques Abouchar

The European Parliament,

- A. having regard to the news of the arrest in Afghanistan of the French television reporter, Jacques Abouchar, and to the secrecy surrounding his detention,
- B. concerned at the fate of a media professional whose work involves independent research and the dissemination of information,
- C. disturbed at the isolation and secrecy in which this reporter is being held, with neither his family, nor his employer nor his home government being able to meet him and at least obtain information on his state of health and the conditions under which he is being kept by Soviet and Afghan troops,
- D. outraged that once again, the provisions of the Final Act of the Conference on Security and Cooperation in Europe and of the Human Rights Charter have been set at nought,
 1. Condemns the arbitrary detention of Mr Jacques Abouchar;
 2. Denounces this attack on the freedom of information by a regime which fears that the world at large should know the truth about its internal situation;
 3. Calls on the governments responsible to allow Mr Abouchar the assistance of a lawyer of his choice for his defence and if, as seems obvious, it is not possible to bring charges, to release him without further delay;
 4. Hopes that similar steps will be taken on behalf of all the other people taken prisoner by Soviet and Afghan forces whilst working in their professional capacities;
 5. Requests that the French consular authorities be permitted to contact Mr Abouchar at an early date so that they may check on the conditions under which he is being held and may intervene if it appears that he is not being humanely treated and cared for;
 6. Instructs its President to forward this resolution to the Governments of Afghanistan and the Soviet Union and to the Council, the Commission, the Foreign Ministers meeting in political cooperation and the Governments and Parliaments of the Member States.

on death sentences in Turkey

The European Parliament,

- A. deeply dismayed at the execution of Ilyas Hag, the first death sentence to be carried out since the elections in November 1983,

- B. fearing that more death sentences will be passed, in particular on Hidir Aslan, and on a further 18 Turkish political prisoners,
 - C. whereas the Turkish military courts are passing death sentences on opponents of the regime in a 'conveyor belt' procedure,
 - D. whereas the 'elections' have in no way alleviated the brutality of political repression in Turkey,
1. Calls on the Turkish authorities to suspend the carrying out of any further death sentences with immediate effect;
 2. Instructs its President to prevail upon the Turkish Head of State, General Evren, to this effect;
 3. Instructs its President to forward this resolution to the Council, the Foreign Ministers meeting in political cooperation and the Turkish Government.

RESOLUTION

on the release of Mr Dikerndem

The European Parliament,

- A. whereas the Turkish diplomat, Mr Mahmoud Dikerndem, President of the Turkish Peace Committee and Vice-Chairman of the World Council of Peace, is still being held in Turkish prisons despite international protests,
 - B. aware that the state of health of Mr Dikerndem, who is suffering from cancer, has deteriorated, owing to the barbaric conditions of detention prevailing in Turkish prisons under the military dictatorship,
 - C. aware that the Community has a moral obligation to espouse the cause of Mr Dikerndem, since he was for a number of years Turkish Ambassador to Paris under democratic governments, and having regard to the answer of the Foreign Ministers meeting in political cooperation to a question on this subject (H-161/84) to the effect that the Ten will continue closely to monitor human rights developments in Turkey,
1. Calls on the Foreign Ministers meeting in political cooperation to make representations to the Turkish Government for the immediate release of Mr Mahmoud Dikerndem, who enjoys an international reputation, so that he can spend his last days in peace;
 2. Instructs its President to take similar action;
 3. Instructs its President to forward this resolution to the Foreign Ministers meeting in political cooperation, the Turkish Government, the Council and the Commission.

RESOLUTION

on the abuse of psychiatry in the Soviet Union

The European Parliament,

- A. appalled by the widespread and repeated abuse of psychiatry in the Soviet Union and by the persecution of those who have exposed these crimes,
- B. aware that a member of the Moscow Working Commission to Investigate the Use of Psychiatry for Political Purposes, Mrs Irina Vladimirovna Grivnina, and her family, are asking permission to leave the Soviet Union to accept an invitation to live in the Netherlands repeatedly endorsed by the Parliament of the Netherlands,
- C. gravely perturbed that the Soviet authorities have refused to grant Mrs Grivnina and her family exit visas,
- D. welcoming the efforts being made on her behalf by members of the Bundestag, the Folketing and the House of Commons as well as by the American Psychiatric Association Committee on International Abuse of Psychiatry and Psychiatric,
- E. recalling the Helsinki Final Act of which the Soviet Union is a signatory,
 1. Urges the Soviet Government to grant Mrs Grivnina and her family immediate permission to emigrate;
 2. Calls on the Governments of the 10 Member States of the European Community to support this request by all appropriate means;
 3. Instructs its President to forward this resolution to the Commission, the Council, the Foreign Ministers meeting in political cooperation and to the Soviet Government.

RESOLUTION

on the need for an immediate ban on the use of plastic bullets

The European Parliament,

- A. recalling its resolutions of 13 May 1982 ⁽¹⁾, which all categorically condemned the use of plastic bullets,
- B. anxious to promote justice and peace in the Member States,
- C. considering Community efforts to improve the intolerable social and economic conditions in Northern Ireland,
- D. anxious to safeguard human life and in particular the lives of children,
- E. noting that Member States accept that the use of plastic bullets can be fatal,
- F. considering the unnecessary brutal use of strength by the Royal Ulster Constabulary during a peaceful 'Internment Day Rally' in Belfast on Sunday, 12 August last,
- G. noting with regret that a young man aged 22, Mr Sean Downes, was shot dead at what was planned and proceeding as a peaceful demonstration,
- H. noting that several other people were seriously injured by plastic bullets on this occasion,
- I. noting that all those who have died as a result of plastic bullets were hit either in the head or in the heart regions, which is totally contrary to the British authorities' own official instructions for use,
- J. noting that others have been blinded or have received permanent injuries from plastic bullet wounds,
- K. noting that some 60 to 70 000 plastic bullets have been used in Northern Ireland to date,
- L. noting that Member States are capable of controlling crowds, when necessary and justified, through methods and means which are not lethal as in the case of plastic bullets,
- M. noting with grave concern the development of the Arwen 37 — a rapid fire plastic bullet gun — by the British Ministry for Defence,
- N. considering the continued use of plastic bullets to be intolerable,
 1. Condemns the use of plastic bullets at all times in Northern Ireland and in particular on Sunday, 12 August 1984 in Belfast;
 2. Calls on the British Government to respect human life and ban the use of lethal weapons against civilians;
 3. Calls on the Council to intervene with the Member State concerned to abolish the use of plastic bullets before there are any more unnecessary deaths;
 4. Instructs its President to forward this resolution to the Council and Commission.

The European Parliament,

- A. having read of the increasingly tense and deteriorating situation in Malta regarding freedom of education,
- B. alarmed at the forms of violence aimed against people and objects in the Catholic world,
- C. recalling its previous deliberations on the rights deriving from educational freedom, the Helsinki declaration and decisions taken by Unesco on the subject,
- D. bearing in mind the European Community's relations with the island of Malta,
 1. Resolves to reaffirm its intention to support the basic rights of freedom of education in Malta;
 2. Instructs the Council to contact the Government of Malta with the aim of ensuring that such rights are respected and to exhort the Government of Malta, in the light of existing Malta/European Community relations, to ensure that it defuses the dangerous situation by displaying the required goodwill and entering immediately into discussions with the local authorities and parental representatives concerned, with the real and genuine intent of

reaching a just and equitable settlement in the true national interest, in the shortest time possible;

on the appointment of women to the new Commission

The European Parliament,

- A. having regard to its resolution of 17 January 1984 ⁽¹⁾, in which it calls for a fairer distribution of positions of responsibility in the decision-making centres and, more particularly, in paragraph 69 calls on the Member States to prove their commitment to the attainment of full equality for women on the occasion of the next appointments to the Commission,
 - B. having regard to its resolution of 17 April 1980 ⁽²⁾ on relations between the European Parliament and the Commission of the Community with a view to the forthcoming appointment of a new Commission, in particular paragraph 4 thereof,
 - C. in the belief that the advancement of women must go beyond mere words and must find practical expression in decisions,
 - D. convinced of the importance of the role of the Commission as an institution with the power to propose legislation and to monitor its application,
 - E. convinced that this dual role of the Commission must be put into practice particularly in the field of women's rights,
1. Urges the Governments of the Member States once again to appoint an appropriate number of women to the new Commission thereby displaying their common determination to devise and carry out positive measures in favour of women;

RESOLUTION

on world hunger

The European Parliament,

A. recalling the European Parliament's initiatives to combat hunger in the world, notably its resolution of 18 September 1980 ⁽¹⁾,

B. noting that 16 October is designated World Food Day by the United Nations' Food and Agriculture Organization,

1. Expresses its deep concern about the deteriorating global food situation, notably in many parts of Africa currently severely affected by drought;

2. Stresses the need for sustained action by the Community to combat world hunger, malnutrition and poverty;
3. Calls on the Commission to provide details of special action taken in response to the current famine in Africa;
4. Emphasizes the need for the Commission's response for emergency food aid to be swift and flexible;
5. Calls on the Commission to increase its provision of cereals within the food-aid budget and to make intervention stocks of cereals available to NGOs wishing to purchase cereals for despatch to Africa;
6. Calls on the Commission to submit to it as a matter of the greatest urgency a precise and detailed statement of the payments actually made during the current year as compared with the sums entered against Chapter 9 of the EEC budget;
7. Encourages the Commission to concentrate its efforts on the longer term provision of technical assistance to stimulate rural development and local food production, as well as to improve distribution and transport links in less-developed countries;
8. Calls for the expansion of the Commission's food-strategy programme under the new Lomé Convention;

3. Urges the Ethiopian Government to begin negotiations with the liberation movements in Eritrea with a view to restoring peace to the region;

- B. recalling its previous resolutions on the subject,
 1. Urges the Council finally to implement at an early date the proposals submitted by the Commission and by Parliament, in particular those aimed at
 - strengthening and broadening the role of the ECU within the EEC and in relations with third countries,
 - encouraging its use in intra-Community trade, in trade with countries linked to the Community by association agreements and for certain large-scale purchase of energy resources and raw materials,

Instructs its Committee on Economic and Monetary Affairs and Industrial Policy to arrange a meeting with the EEC Monetary Committee and representatives of other financial and international organizations, as appropriate, in order to obtain further information on the role of the ECU and its possible development;
 3. Instructs its President to forward this resolution to the Council, the Commission and the Governments of the Member States.

 - B. whereas, in view of world fluctuations in exchange rates, it is essential to proceed to a second formal phase in order to strengthen the mechanisms of the EMS,
 - C. whereas it is essential to promote the role of the ECU as a real Community currency, extending its use to the whole of the Community and thereby reflecting the economic power of the EEC,
 - D. whereas Community monetary 'sovereignty' will only be effective to the extent that convergence between economic policies is successfully attained,
1. Calls on the Commission to submit proposals to Parliament and the Council to broaden the basis of the EMS in order to ensure the greatest possible cohesion and the wider use of the system;
 2. Calls on the Commission, with a view to establishing a future common currency, to propose as a matter of priority that the Member States unreservedly recognize the currency status of the ECU and the principle of the free movement of capital in ECU;
 3. Calls on the Commission to institute binding arrangements designed to promote convergence between the economic policies of the Member States;
 4. Instructs its President to forward this resolution to the Commission and the Council.

on the international monetary situation and the use of the ECU

The European Parliament,

A. having particular regard to its resolutions of

- 27 March 1984 on the programme for European economic recovery ⁽¹⁾,
- 16 February 1984 on the consolidation and completion of the EMS ⁽²⁾,
- 9 April 1984, on the need to implement the European internal market ⁽³⁾,

B. having regard to the agreements reached by the European Council meeting in Fontainebleau and, in particular, the decisions on the EMS taken by the Council of Ministers meeting in Dublin,

1. Calls on the Commission to submit the necessary proposals for the further development of the European Monetary System as an essential precondition for the attainment of the free movement of capital and services and, in particular, to update the graduated plan laid down in Bremen in order to develop the EMS further;

The next step is to urge the Republics of France and Italy to abolish their currency controls and to call on the Federal Republic of Germany to allow private individuals to open bank accounts in ECU as they are entitled to do in other Member States of the Community;

2. Calls on the British Government to incorporate the pound sterling in the mechanisms of the Monetary System.

It is particularly desirable that the pound should be incorporated in the exchange rate mechanisms in view of the present monetary and economic situation, the position of the pound sterling against the other EMS currencies and the gradual decline of the role of the pound as a petro-currency and the relative stability recorded over the last five and a half years;

3. Calls on the Commission to submit a proposal for the setting up of an autonomous European central bank system with the means to control the money supply so as to ensure the stability of the ECU;

The presidents of the central banks are urged to consider stepping up the coordination of the EMS mechanisms in the light of the recommendations of the European Parliament;

4. Calls on the Commission and the Council to take up the proposals set out in the abovementioned resolution of the European Parliament on the consolidation and completion of the EMS and to ensure their implementation;

5. Instructs its President to forward this resolution to the Commission, the Council and the Governments of the Member States.

The European Parliament,

- A. having regard to the economic difficulties facing the EEC because of the permanent instability of the international monetary system and the dominant role of the dollar,
- B. whereas it is necessary to increase European financial integration and the free movement of capital in the Community,
 1. Calls on the Commission and the Council to speed up current work on financial integration and the promotion of the role of the ECU (on the basis of the Commission communications of April and May 1983), in particular that Member States should give the ECU currency status on all the exchange markets;
 2. Stresses in particular the need for the ECU to be quoted on all the exchange markets in order ultimately to establish a common financial market;
 3. Considers that the Member States should give priority to transactions in ECU in the 10 countries and without discrimination for all European residents;
 4. Calls for a greater official role for the ECU, in particular in the monetary policy of the central banks;
 5. Calls on the Commission and the Council to decide as quickly as possible on measures for the establishment of a common European financial market, which will be based on the EMS, the ECU, the free movement of capital and a common monetary policy with regard to the rest of the world;
 6. Hopes that the Governments of the United Kingdom and Greece will join the EMS as soon as possible;
 7. Instructs its President to forward this resolution to the Commission, the Council and the Governments of the Member States.

RESOLUTION

closing the procedure for consultation of the European Parliament on the proposal from the Commission of the European Communities to the Council for a Regulation amending Regulation (EEC) No 1603/83 laying down special measures for the disposal of dried grapes and dried figs held by storage agencies

The European Parliament,

- having regard to the proposal from the Commission to the Council ⁽¹⁾,
- having been consulted by the Council pursuant to Article 43 of the EEC Treaty (Doc. 1-276/84),
- having regard to the report of the Committee on Agriculture, Fisheries and Food and the opinion of the Committee on Budgets (Doc. 2-616/84),
- having regard to its resolution of 10 June 1983 on a similar proposal concerning the 1981 harvest, and the favourable opinion delivered thereon ⁽²⁾,
- having regard to the result of the vote on the Commission's proposal,

A. considering that the recent changes to the basic rules on processed fruit and vegetable products as applied to dried grapes and dried figs, and in particular the introduction of

guarantee thresholds, will bring about a final rationalization of the market in these products,

- B. considering that these changes include the fixing of a minimum price for imports from third countries and will consequently encourage sales of Community produce,
- C. considering that the proposal to earmark stocks from the 1982 harvest for use as animal feed may be viewed as contributing to this final rationalization of the market,
- D. considering that the cost of introducing this measure will be offset in part by cancellation of the considerable expenditure on storage,
- E. considering that the natural deterioration of produce in storage makes it increasingly difficult to sell for human consumption,
 1. Approves the Commission's proposal;
 2. Emphasizes, however, that it will not be able to accept similar measures in future unless a serious effort is made by all interested parties to achieve a final rationalization of the market;
 3. Considers it necessary to devote particular attention to improving the quality categories of dried grapes in order to meet the needs of the market and also to the better disposal of the products concerned by improving marketing methods;
 4. Instructs its President to forward to the Council and Commission, as Parliament's opinion, the Commission's proposal as voted by Parliament and the corresponding resolution.

19. Written declarations (Rule 49)

In accordance with Rule 49 ⁽⁵⁾, the President informed Parliament of the number of signatures obtained by these declarations (*see Annex I*).

With the agreement of Parliament, he announced that he would forward the resolutions that had just been adopted forthwith to the bodies specified by the authors.
