

Notice of special invitation to tender No IRL P 54 for the sale of frozen boned beef held in stock by the Irish intervention agency

(89/C 53/12)

1. The Irish Intervention agency shall sell 1 000 tonnes of frozen boned beef as follows:
 - 660 tonnes of 'forequarters',
 - 340 tonnes of 'briskets',being 1 000 tonnes from the category C.
2. These goods shall be sold in accordance with Regulation (EEC) No 2326/79 (¹) and the rules laid down in the general notice of invitation to tender (²).
The beef was stored before 1 May 1988.
