PART I

Proceedings of the sitting

IN THE CHAIR: MR BARÓN CRESPO

President

(The sitting was opened at 5 p.m.)

1. Resumption of session

The President declared resumed the session of the European Parliament which had been adjourned on 15 March 1991.

2. Approval of minutes

The following spoke:

- Mr Cot, Chairman of the SOC Group, who asked whether the Presidency of the Council had responded to Parliament's request to be consulted on the question of lifting sanctions affecting South Africa (the President, recalling that this question had been raised in Brussels at the Enlarged Bureau meeting open to all members, pointed out that he had had contacts with the President-in-Office of the Council during which he had conveyed Parliament's concern);
- Mr Donnelly, who congratulated the EPP Group for rejecting the British Prime Minister's proposal that the ED Group should join the EPP Group;

— Mrs Banotti who, in reference to the topical and urgent debate, asked to know what had resulted from the contacts which the President had been asked to make with the Iranian, Syrian and Lebanese Governments with regard to the hostages in the Middle East, especially Mr McCarthy (part II, item 5 (a) of minutes of 14 March 1991) the President replied that unfortunately he had no positive news to give).

The minutes of the previous sitting were approved.

The President read out an announcement to Parliament in which he condemned recent acts of terrorism in Europe, and especially those in Northern Ireland, Germany and Spain. He emphasized that the European Parliament wished to put on record once more its commitment to freedom, democracy and respect for human rights and the right to life as the most basic of those rights. There was no place in a democratic and pluralist society for the use of force or violence. Terrorist viol-

ence should never further a political objective. Parliament would never allow terrorism to take the place of universal suffrage and the free handover of political power.

He concluded by announcing that, on Parliament's behalf, he had expressed his sympathy to the families of the victims and the governments and political parties concerned.

3. Membership of Parliament

The President announced that Mr Goria, who had been appointed Minister for Agriculture in the Italian Government, had informed him in writing of his resignation as Member of Parliament with effect from 13 April 1991.

In accordance with Article 12 (2), second subparagraph of the Act concerning the election of representatives to the European Parliament, Parliament established that there was a vacancy; the Member State would be informed accordingly.

He also announced that the competent Spanish authorities had informed him that Mr Garaikoetxea Urriza's replacement would be Mr Barrere I Costa, with effect from 21 March 1991.

He welcomed the new colleague and drew attention to the provisions of Rule 6 (3).

4. Request for the waiver of a member's immunity

The President announced that he had received from the Italian authorities a request for the waiver of Mr Pannella's parliamentary immunity.

In accordance with Rule 5, the request had been referred to the appropriate committee, in this instance the Committee on the Rules of Procedure, the Verification of Credentials and Immunities.

11. Texts of treaties forwarded by the Council

The President announced that he had received from the Council certified true copies of the following documents:

Decision No 1/90 of the EEC-EFTA Joint Committee on Common Transit amending Appendices I

and II to the Convention of 20 May 1987 on a common transit procedure;

- Agreement between the European Economic Community and the Swiss Confederation on the simplification of inspections and formalities in respect of the carriage of goods;
- Protocol on financial and technical cooperation between the European Economic Community and the Syrian Arab Republic;
- Agreement in the form of an exchange of letters between the European Economic Community and the Republic of Tunisia laying down the arrangements applicable from 1 January 1991 to imports into the Community of untreated olive oil originating in Tunisia.

The following spoke:

- Mr Crampton, who referred to difficulties facing British Members as a result of the cancellation by Air France of a flight to London City Airport which they usually took on a Friday (the President noted these remarks);
- Mrs Ewing, who called for the Council to make a statement on the lifting of sanctions against South Africa;
- Mr Fitzgerald, who informed Parliament that yet another Irish trawler had been rammed by another vessel off the coast of Ireland.

12. Order of business

The next item was the order of business.

The President announced that the draft agenda for that part-session (PE 149.663) had been distributed, and that the following changes had been made or proposed to it (Rules 73 and 74):

Monday, 15 April 1991:

the Lataillade report on hot-water boilers (A 3-0063/91, item 29) would be postponed to a future part-session so that Parliament could debate it together with the SAVE Programme as a whole;

a Commission statement on shipbuilding would be added to the end of the agenda.

The following spoke:

- Mr Patterson, who protested at the postponement of the Lataillade report and wanted to know who had requested this postponement (the President replied that the request had been made by the Committee on Energy);
- Mr Lataillade, who also regretted that his report would not be taken at the current part-session and

asked, in general, for the Bureau to look carefully into referrals to committee;

— Mr Donnelly, who also argued in favour of keeping the report on the agenda.

The President consulted Parliament on whether or not to postpone the report to a future part-session.

Parliament decided to keep the report on the agenda.

Tuesday, 16 April:

depending on the outcome of the meeting of the Committee on Budgets that evening, Mr von der Vring, Chairman of the committee, would make an announcement on the emergency financial aid for the Kurds proposed by the European Council on 8 April;

the Hughes report on the European Year of Safety, Hygiene and Health Protection at Work (item 39) had not been adopted in committee and had therefore been taken off the agenda;

the Lamassoure report on the revision of the financial perspective (item 47) had not been adopted in committee and had therefore been taken off the agenda;

as there would be two formal sittings at this partsession, there would be an exceptional voting time from 6 to 7 p.m. on Tuesday and the sitting would continue until 8 p.m.

Wednesday, 17 April:

in addition to the Council, the Commission would also make a statement on the Intergovernmental Conference on Political Union (item 49). The debate would continue until 11.30 a.m.

due to lack of time, the joint debate under items 52 and 53 would be confined to a statement by the President-in-Office of the European Council on the Luxembourg European Council, with special emphasis on the situation of the Kurds, a statement by the President of the Commission and, possibly, the introduction of Oral Question B 3-0275/91 by Mrs Cassanmagnago Cerretti. The debate itself would be on Thursday.

the following five oral questions would be included in the joint debate on oral questions to EPC on arms exports (items 54 to 58):

by the RB Group (0-0086/91),

by the EDA Group (0-0092/91),

by Mr Pannella and others (0-0093/91),

by the ER Group (0-0094/91),

by the LDR Group (0-0097/91).

Given the heavy load on the agenda, speaking time for authors of questions would be reduced to two minutes.

The following spoke:

- Mr Bourlanges, who asked for the vote on his report on the nature of Community acts (A 3-0085/91) to be taken on Wednesday evening rather than on Thursday evening;
- Mr Cot, Chairman of the SOC Group, who said that the political group chairmen had thoroughly studied this question and concluded that, since the positions of the Luxembourg Presidency were not yet available but were due to be tabled that day, it would be more prudent to leave the votes on all these political questions, including the Bourlanges report, until voting time on Thursday;
- Mrs Aglietta, who objected to the procedure proposed for examining items 52 and 53, which meant there would be no debate on the oral question from Mrs Cassanmagnago Cerretti;
- Mr von der Vring, Chairman of the Committee on Budgets, who stressed the need to distinguish between humanitarian aid and political decisions with regard to the situation of the Kurds:
- Mr Chanterie, who pointed out that the Enlarged Bureau had only authorized one question by the Political Affairs Committee to be included on the agenda for joint debate with the statement on the Luxembourg European Council;
- Mrs Aglietta, who proposed that this question should be followed by a debate during the next partsession, acknowledging that the heavy load on the agenda did not allow it to take place during the current part-session:
- Mr Cot, who agreed with this proposal which was accepted;
- the President, who asked Mrs Aglietta whether she wanted Mrs Cassanmagnago Cerretti's oral question (B 3-0275/91) to be taken off agenda for the present part-session;
- Mrs Aglietta, who made it clear that she had not at any time asked for the question to be withdrawn.

Thursday, 18 April:

- there would be a debate of one and a half hours (10 to 11.30 a.m.) on the statements made to Parliament the previous day by the European Council and the Commission on the extraordinary meeting of the European Council in Luxembourg, and more especially on the situation of the Kurds (the topical and urgent debate would therefore be from 11.30 a.m. to 1 p.m.);
- the oral question by Mr Collins, on behalf of the Committee on the Environment, on food hygiene (B 3-

0274/91), which had initially been included as a footnote in the joint debate on health conditions (items 64 to 73), would be entered as the first item in the joint debate.

The following spoke: Mrs Crawley, who asked whether an oral question with debate on the same subject by the Committee on Women's Rights had in fact been tabled, and Mr Collins, Chairman of the Committee on the Environment, who pointed out that the question she was referring to was in fact about infant milk, which was another subject altogether; he added that a motion for a resolution on infant milk had been tabled under Rule 41 (4) for inclusion in the agenda of the current part-session.

- the Bombard report on molluscs (item 67) and the Scott-Hopkins report on meat products (item 69) had not been adopted in committee and had therefore been taken off the agenda;
- the author of the report on intra-Community trade in fresh meat (item 73) was Sir James Scott-Hopkins and not Mr Collins, as indicated on the draft agenda.

Friday, 19 April:

- a report by Mrs Pollack on childcare and equality of opportunity (A 3-0072/91) would be included after the votes, in application of Rule 37;
- a motion for a resolution on infant formulae and follow-up milks, pursuant to Rule 41 (4) (B 3-0530/91), would be included after any reports entered under urgent procedure.

The following spoke:

- Mrs Crawley, who asked whether the oral question by the Committee on Women's Rights on the same subject could be taken jointly with this motion for a resolution;
- Mr Collins, Chairman of the Committee on the Environment, who asked for this motion for a resolution to be entered for any other day except Friday (the President replied that all sittings had equivalent status; he proposed to Mrs Crawley that the oral question she had referred to should be included in the debate on the motion for a resolution tabled by the Environment Committee;
- Mr Bangemann, Vice-President of the Commission, who proposed dealing with the question raised by the abovementioned motion for a resolution in the Commission statement on action taken on Parliament's opinions on Wednesday evening;

- Mr Collins, who said that he would prefer to leave the motion for a resolution on Friday's agenda rather than have it dealt with at the night sitting on Wednesday;
- Mrs Crawley, who expressed agreement with the President's suggestion of including the oral question in the debate.

The Fontaine report on youth exchanges and mobility (item 75) had been taken off the agenda, since the committee responsible, the Youth Committee, was disputing the legal base of the Commission proposal and the Legal Affairs Committee would therefore be examining the question pursuant to Rule 36 (3).

Mr McMahon and other members had requested the inclusion of a Commission statement on poverty in the Community, on the basis of Rule 74.

Mr McMahon and Mr Donnelly spoke on this request.

Parliament agreed to the request.

The President announced that this item would therefore be included at the end of Friday's agenda.

Mr Bangemann, Vice-President of the Commission, pointed out that if Parliament wanted this statement to be made by the Commissioner responsible, Mrs Papandreou, it would have to be made on a different day, since Mrs Papandreou could not be present on Friday.

The President suggested taking this item at the Enlarged Bureau meeting open to all Members to be held on Wednesday, 24 April.

Mr Bangemann agreed in principle with this suggestion.

The order of business was thus established.

Application of Rule 116 (1) (procedure without report)

This procedure had been requested by:

A. the Committee on the Environment, for a proposal for a directive amending Directive 76/769/EEC on the approximation of the laws, regulations and administrative provisions of the Member States relating to restrictions on the marketing and use of certain dangerous substances and preparations (C 3-0091/91 — SYN 325). (This proposal would be put to the vote at 5 p.m. on Wednesday evening.)

B. the Committee on Agriculture for

a proposal for a regulation amending Regulation (EEC) No 426/86 on the common organization of the

market in products processed from fruit and vegetables (C 3-0089/91);

a proposal for a regulation amending Regulation (EEC) No 1191/89 derogating from Regulation (EEC) No 797/85 as regards certain investment aids in the pig production sector (C 3-0102/91). (These proposals would be put to the vote at the beginning of the sitting on Friday.)

13. Topical and urgent debate (subjects proposed)

The President proposed the following four subjects for the next topical and urgent debate to be held on Thursday:

- famine in Africa,
- Western Sahara,
- human rights,
- accidents at sea.

The following spoke:

- Mr Rogalla who, referring to remarks made on the subject in the past, noted that the public gallery was full and that there were also visitors in the gallery reserved for diplomats, following a decision by the Secretary-General which he welcomed;
- Mr Speciale who, in reference to the disasters at sea off Livorno and Genoa, argued that immediate action was required and that there should be a debate with Commission participation on the question of port security (the President replied that there was no question now of holding an impromptu debate, that he had sent messages of sympathy on Parliament's behalf, first and foremost to the families of the victims, and that, as regards the substance of the question, the committee responsible was the Committee on Transport);
- Mrs Magnani Noya, who thanked the President for sending messages of sympathy, but deplored the environmental damage caused by these disasters and called for a debate (the President replied that the Italian coast was not alone in being affected by pollution problems of this kind and that the situation was being monitored by the Italian authorities; he added that there would be a statement but no debate);
- Mr Bettini, who called for a debate on this subject (the President replied that the Italian Government's committee of inquiry had first to complete its investigations);
- Mr Stewart, who criticized the lack of measures governing security at sea and also called for a debate;

- Mr Speciale, who also called for a Commission statement on these problems, along with a debate (the President replied that the Community bodies had not so far been involved in the matter and that the situation was currently being dealt with by the Italian authorities);
- Mr Bangemann, Vice-President of the Commission, in support of the President's reply, and to point out that, although it was a European issue, it was currently the responsibility of the Italian authorities;
- Mrs Aglietta, on the list of subjects proposed for the topical and urgent debate and on the conduct of business;
- Mr Coimbra Martins who, referring to the disasters off the Italian coast, argued that they raised a basic issue going beyond exclusively Italian interests and affected the Mediterranean as a whole. He added his voice to the demands for an urgent debate on this matter.

The President reminded members that they could table objections in relation to the topical and urgent debate.
