

before the Court of First Instance of the European Communities on 5 July 1994 by H. J. ten Hagen, of Winterswijk (Netherlands), represented by H. J. Bronkhorst, *advocaat* with a right of audience before the Hoge Raad der Nederlanden, and E. H. Pijnacker Hordijk, of the Amsterdam Bar, with an address for service in Luxembourg at the Chambers of L. Frieden, 62 avenue Guillaume.

The applicant claims that the Court should:

- order the Community to pay the applicant a specific sum together with interest at the rate of 8% per annum on the principal sum from 19 May 1992 until the date of full settlement,
- order the Community to pay the applicant such damages as the Court deems fit, but not less than the sum calculated pursuant to Council Regulation (EEC) No 2187/93 of 22 July 1993, together with interest at the rate of 8% per annum on the principal sum from 19 May 1992 until the date of full settlement,
- order the Community to pay the costs.

Pleas in law and main arguments adduced in support:

The pleas in law and main arguments are largely the same as those in Case C-104/89 *Mulder v. Council and Commission of the European Communities* and Case C-37/90 *Heinemann v. Council and Commission of the European Communities*.
