PART I

Proceedings of the sitting

IN THE CHAIR: Mr HÄNSCH,

President

(The sitting opened at 3.05 p.m.)

1. Resumption of session

The session, adjourned on 7 April 1995, was resumed.

2. Statement by the President

At the request of the group chairmen the President made a statement on the massacre of 2 000 refugees in the Kibeho camp in Rwanda.

3. Approval of Minutes

The Minutes of the previous sitting were approved.

The following spoke:

Mr Langer, who noted that Italy was celebrating that day the fiftieth anniversary of its liberation and asked the President to send a message to the speakers of the two chambers of the Italian Parliament informing them that the European Parliament shared in the celebration of this event; on behalf of the Green Group, he paid tribute to all those who had fought against fascism and for democracy (the President, noting that the other group chairmen backed this suggestion, agreed to do so);

Mr Carnero González, who referred to the President's statement and asked him also to demand the immediate and unconditional release of Mr Severo Moto, who had been sentenced in Equatorial Guinea to 28 years in prison; this was in accordance with Parliament's request in its resolution of 16 March 1995 on the situation in Equatorial Guinea (Part II, Item 10 of that day's Minutes) (the President established there was no opposition and agreed to this request).

4. Referral to committees

5. Transfer of appropriations

At its meeting of 19 April 1995, the Committee on Budgets considered the proposal for the transfer of appropriations No 4/95, SEC(95)0460: 'Building for the Committee of the Regions and part of the joint organizational structure'.

The committee had noted that the Commission had not annexed its opinion to the proposal. It had also taken into account the Council's deliberations and had then considered the underlying questions with the help of the supplementary information forwarded to it on 10 April 1995 by the services of the Economic and Social Committee and the Committee of the Regions.

The Committee on Budgets, despite having examined in depth the legal and financial aspects and the extent of the planned building in relation to actual needs, had not authorized the proposed transfer.

Nevertheless, the Committee on Budgets had decided to allocate to the services concerned extra floor space (about 4 000 m²) which would enable them to transfer the translation service and the typing pools. The Committee on Budgets believed that this solution would avoid calling into question the provisions of the Treaty concerning the joint organizational structure, would allow the Committee of the Regions to take advantage of the current facilities enjoyed by the Economic and Social Committee and would guarantee observance of the financial resources of category 5 'administrative expenditure' of the financial perspectives currently in force.

The Committee on Budgets had consequently undertaken to examine swiftly a further proposal for transfer of appropriations taking into account these considerations.
