Proceedings of the sitting

IN THE CHAIR: Mr HÄNSCH

President

3. Deliberations of the Committee on Petitions

(The sitting opened at 3.05 p.m.)

The President announced that the Committee on Petitions had informed him of its deliberations on petitions forwarded to it since its last annual report, i.e. from 14 March to 14 September 1995, pursuant to Rule 157(5).

I. Resumption of session

The session, adjourned on 17 November 1995, was resumed.

During this period the committee had received 663 petitions (compared with 622 for the same period in 1994). 264 petitions had been ruled inadmissible and 309 had been ruled admissible (compared to 169 and 249 for the same period in 1994).

2. Approval of Minutes

The Minutes of the previous sitting were approved.

Mr Dell' Alba referred to a hearing on drugs due to be held on 7-8 December 1995 organized by Parliament, the Commission and the Council, following requests by Parliament in its resolutions of 15 June and 20 September 1995, and asked for the House to be informed of the composition of Parliament's delegation, if any, to the hearing (the President replied that the issue had been discussed by the Bureau that morning and that a proposal would very shortly be forthcoming).

Consideration had been closed on 309 petitions examined during this period (293 for the same period in 1994).

The Commission had been asked for information concerning 189 petitions and for further information concerning another 57 (170 and 129 for the same period in 1994).

A total of 877 petitions were being considered at the end of this period (compared with 712 for the same period in 1994).
