

COMMISSION DECISION

of 17 April 1975

fixing minimum selling prices for boned beef put up for tender by the French intervention agency pursuant to Regulation (EEC) No 79/75

(75/284/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68 ⁽¹⁾ of 27 June 1968 on the common organization of the market in beef and veal, as last amended by Regulation (EEC) No 1855/74 ⁽²⁾, and in particular Article 7 (3) thereof;

Whereas Article 11 of Commission Regulation (EEC) No 216/69 ⁽³⁾ of 4 February 1969 on detailed rules of application for the disposal of frozen beef and veal bought in by intervention agencies, provides that minimum selling prices for the products tendered for must be fixed in the light of the tenders received;

Whereas, in accordance with Article 1 of Commission Regulation (EEC) No 79/75 ⁽⁴⁾ of 14 January 1975 on the sale by periodic tendering procedure of boned beef held by the intervention agencies, a certain quantity of boned beef has been put up for tender by the French intervention agency ⁽⁵⁾; whereas, having regard to the tenders received for forequarters from steers and cows presented in 'caisses A', 'caisses B' and 'caisses M', and for hindquarters from cows presented as 'bavette', 'boules de gîtes/jarrets', 'entrecôtes', 'faux-filets', 'filets', 'gîtes à la noix', 'romstecks', 'tendes de tranches' and 'tranches grasses', and to the market situation, it is appropriate to fix the minimum selling prices for those products at the levels given below;

Whereas the measures provided for in this Decision are in accordance with the Opinion of the Management Committee for Beef and Veal,

HAS ADOPTED THIS DECISION:

Article 1

For the purposes of contracts awarded pursuant to Regulation (EEC) No 79/75 the minimum selling prices for boned beef held by the French intervention agency shall be as follows:
