

COMMISSION REGULATION (EEC) No 2518/86
of 6 August 1986
correcting the monetary compensatory amounts

THE COMMISSION OF THE EUROPEAN COMMUNITIES,
Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 1677/85 of 11 June 1985 on monetary compensatory amounts in agriculture ⁽¹⁾, as amended by Regulation (EEC) No 2502/86 ⁽²⁾, and in particular Article 9 (2) thereof,

Having regard to Council Regulation (EEC) No 1678/85 of 11 June 1985 fixing the conversion rates to be applied in agriculture ⁽³⁾, as last amended by Regulation (EEC) No 2332/86 ⁽⁴⁾,

Having regard to Council Regulation (EEC) No 3155/85 of 11 November 1985 providing for the advance fixing of monetary compensatory amounts ⁽⁵⁾, as last amended by Regulation (EEC) No 1002/86 ⁽⁶⁾,

Whereas the monetary compensatory amounts introduced by Regulation (EEC) No 1677/85 were fixed by Commission Regulation (EEC) No 1057/86 ⁽⁷⁾, as amended by Regulation (EEC) No 2333/86 ⁽⁸⁾;

Whereas a check has shown that an error relating to Portugal was made in Annex II to Regulation (EEC) No 2333/86;

Whereas the Regulation in question should be corrected accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

In Annex II to Regulation (EEC) No 2333/86 amending Regulation (EEC) No 1057/86, the monetary coefficient to be applied to import duties for processed products covered by Council Regulation (EEC) No 3033/80 ⁽⁹⁾ shall be replaced by '1,037' for Portugal.

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply, at the request of the party concerned, from 28 July to 3 August 1986.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
