

## COMMISSION REGULATION (EEC) No 3861/86

of 16 December 1986

correcting certain amounts of the export refund for oilseeds applicable from 1 October 1986

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats <sup>(1)</sup>, as last amended by Regulation (EEC) No 1454/86 <sup>(2)</sup>,Having regard to Council Regulation 142/67/EEC of 21 June 1967 on export refunds on colza, rape and sunflower seeds <sup>(3)</sup>, as last amended by Regulation (EEC) No 2429/72 <sup>(4)</sup>, and in particular the first sentence of Article 2 (3) thereof,Whereas a check has shown that a mistake was made in calculating the final refunds in national currency of certain Member States set out in the Annex to Commission Regulation (EEC) No 2992/86 <sup>(5)</sup>, (EEC) No 3328/86 <sup>(6)</sup> and (EEC) No 3630/86 <sup>(7)</sup>; whereas the final refunds in question should therefore be corrected from the date of entry into force of this Regulation for all the Member States concerned and from the date of entry into force of the amounts to be corrected for the Member States for which the amounts should be increased,

HAS ADOPTED THIS REGULATION:

*Article 1*

1. The amounts of the final refund set out in the Annex to Regulation (EEC) No 3630/86 for seeds harvested and exported from BLEU, Denmark, Ireland, the United Kingdom, Italy and Greece are hereby replaced by the amounts set out in Annex A to this Regulation.

2. The amounts of the final refund for seeds harvested and exported from Germany and the Netherlands:

- set out in the Annex to Regulation (EEC) No 2992/86 are hereby replaced, as from 1 October 1986, by the amounts set out in Annex B (1) hereto,
- set out in the Annex to Regulation (EEC) No 3328/86 are hereby replaced, as from 1 November 1986, by the amounts set out in Annex B (2) hereto,
- set out in the Annex to Regulation (EEC) No 3630/86 are hereby replaced, as from 1 December 1986, by the amounts set out in Annex B (3) hereto.

*Article 2*

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
