## COUNCIL REGULATION (EEC) No 1661/80

of 27 June 1980

on the safeguard measures provided for in the Cooperation Agreement and the Interim Agreement concerning trade and commercial cooperation between the European Economic Community and the Socialist Federative Republic of Yugoslavia

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 43 and 113 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament<sup>(1)</sup>,

Whereas a Cooperation Agreement between the European Economic Community and the Socialist Federative Republic of Yugoslavia, hereinafter referred to as 'the Cooperation Agreement', was signed on 2 April 1980 and an Interim Agreement concerning trade and commercial cooperation, hereinafter referred to as 'the Interim Agreement', was concluded on 30 May 1980;

Whereas for the purpose of implementing the safeguard clauses and precautionary measures provided for in Articles 35 to 38 and Article 55 of the Cooperation Agreement and in Articles 22 to 25 and Article 36 of the Interim Agreement, detailed rules should be laid down for the application of Community Regulations, in particular Council Regulation (EEC) No 926/79 of 8 May 1979 on common rules for imports<sup>(2)</sup> and Council Regulation (EEC) No 3017/79 of 20 December 1979 on protection against dumped or subsidized imports from countries not members of the European Community<sup>(3)</sup>,

for in Article 35 of the Cooperation Agreement and Article 22 of the Interim Agreement, the introduction of anti-dumping or countervailing duties shall be decided upon in accordance with the procedure and detailed rules laid down in Regulation (EEC) No 3017/79.

*Article 2*

In cases liable to warrant the application by the Community of the measures provided for in Articles 36 and 55 of the Cooperation Agreement and Articles 23 and 36 of the Interim Agreement, appropriate safeguard measures may, on the conditions laid down in those Articles, be adopted by the Council in accordance with the procedure and detailed rules laid down in Regulation (EEC) No 926/79 and in particular Article 13 thereof.

In urgent cases and subject to the conditions laid down in Article 36 of the Cooperation Agreement and Article 23 of the Interim Agreement:

- the Commission may adopt the appropriate safeguard measures in accordance with the procedure and detailed rules laid down in Regulation (EEC) No 926/79, and in particular Article 12 thereof,
- any Member State may take interim safeguard measures in conformity with the procedure described in Article 14 of Regulation (EEC) No 926/79.

HAS ADOPTED THIS REGULATION:

*Article 1*

In the case of dumping, or subsidies liable to warrant the application by the Community of the measures provided

*Article 3*

1. This Regulation shall not preclude the application of Regulations on the common organization of agricultural markets or of Community or national administrative provisions resulting therefrom or of the special Regulations adopted under Article 235 of the Treaty for processed agricultural products; this Regulation shall apply in addition to such measures.

## COUNCIL REGULATION (EEC) No 1662/80

of 27 June 1980

## establishing indicative ceilings and Community supervision for imports of certain goods originating in Yugoslavia (1980)

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

HAS ADOPTED THIS REGULATION:

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to the proposal from the Commission,

Whereas an Interim Agreement between the European Economic Community and the Socialist Federative Republic of Yugoslavia <sup>(1)</sup> was signed on 6 May 1980;

Whereas under Article 1 of Protocol 1 annexed to that Agreement imports of the goods therein set out are limited to annual ceilings above which the customs duties applicable to third countries may be reintroduced; whereas, therefore, the ceilings to be applied in 1980 must be established; whereas in this situation it is necessary that the Commission be regularly informed of the trend of the imports of the goods in question and, in consequence, it is necessary to subject these imports to supervision;

Whereas this objective may be achieved by means of an administrative procedure based on setting off imports of the products in question against the ceilings at Community level, as and when these products are entered with customs authorities for free circulation; whereas this administrative procedure must make provision for the reintroduction of customs tariff duties as soon as the ceilings have been reached at Community level;

Whereas this administrative procedure requires close and particularly rapid cooperation between the Member States and the Commission; whereas the latter must, in particular, be able to follow the progress of amounts set off against the ceilings and keep the Member States informed; whereas this cooperation must be all the closer since the Commission must be able to take adequate measures to reintroduce customs tariff duties whenever one of the ceilings has been reached;

Whereas the trend of imports should be followed for certain goods; whereas it is therefore desirable that imports of such goods should be subject to supervision,

*Article 1*

1. From 1 July to 31 December 1980, imports of certain goods originating in Yugoslavia and indicated in Annexes I, II, III and IV shall be subject to ceilings and to Community supervision.

The description of the goods referred to in the preceding subparagraphs, their tariff headings and statistical numbers and the levels of the indicative ceilings are given in the abovementioned Annexes.

2. Amounts shall be set off against the indicative ceilings as and when the goods are entered with customs authorities for free circulation and accompanied by a movement certificate conforming to the rules contained in Protocol 2 to the Agreement.

Goods shall be set off against the ceiling only if the movement certificate has been submitted before the date on which customs duties are reimposed.

The reaching of a ceiling shall be determined at Community level on the basis of imports set off against it in the manner defined in the preceding subparagraphs.

The Member States shall periodically inform the Commission of imports effected in accordance with the above rules; such information shall be supplied under the conditions laid down in paragraph 4.

3. As soon as the ceilings have been reached, the Commission may adopt a Regulation reimposing until the end of the calendar year the customs duties applicable to third countries.

However, if customs duties are reimposed, imports of the goods listed in Annex V, which within the meaning of Protocol 2 annexed to the Agreement have obtained originating status in the free zone established by the Agreements signed at Osimo shall continue to benefit from exemption of duties provided that this originating status is certified on the movement certificate by the competent Yugoslav authorities.

4. Member States shall forward to the Commission not later than the 15th day of each month statements of the amounts set off during the preceding month. They shall, if the Commission so requests, make up such statements for periods of 10 days and forward them within five clear days of expiry of the preceding 10-day period.

*Article 2*

From 1 July to 31 December 1980 imports of the goods originating in Yugoslavia referred to in Annex I for which the ceiling level is not specified shall be subject to Community supervision.

Member States shall forward to the Commission not later than the 15th day of each month statements of imports of the products in question effected during the preceding month; to this end, only products submitted to

the customs authorities under cover of an entry for free circulation and accompanied by a movement certificate conforming to the rules contained in Protocol 2 to the Agreement shall be taken into consideration.

They shall, if the Commission so requests, make up import statements for periods of 10 days and forward them within five clear days of expiry of the preceding 10-day period.

*Article 3*

The Member States and the Commission shall cooperate closely to ensure that this Regulation is complied with.

*Article 4*

This Regulation shall enter into force on 1 July 1980.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

### COMMISSION DECISION

of 27 June 1980

authorizing Member States to apply intra-Community surveillance to imports of products originating in a third country which have been put into free circulation in the Community and which may be the subject of protective measures under Article 115 of the Treaty

(80/605/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 115, first paragraph, thereof,

Having regard to Commission Decision 80/47/EEC of 20 December 1979 on surveillance and protective measures which Member States may be authorized to take in respect of imports of certain products originating in third countries and put into free circulation in another Member State <sup>(1)</sup>, and in particular Articles 1 and 2 thereof,

Whereas the abovementioned Decision requires Member States to have prior authorization from the Commission before introducing intra-Community surveillance of the imports concerned;

Whereas the Member States have made 3 066 such applications for authorization to the Commission, including *inter alia* details of the product in question, the country of origin, the rules governing direct imports from the country of origin and other third countries, the volume and quantity of the imports and the economic difficulties of which there is alleged to be a danger;

Whereas the information given in support of these applications has been subjected to close examination by the Commission;

Whereas the Commission, in view of the differences in the commercial policy measures applied by the Member States, examined first whether the products named in the Member States' applications could legally be made subject to surveillance measures under Article 2 of Decision 80/47/EEC;

Whereas the information received was then examined as regards the economic difficulties alleged, that is in relation to the development of such factors as national production, imports, consumption, the market share held by national production, by imports from third countries and the third country concerned in the application, prices charged by national producers and by importers on the domestic markets, and employment in the sector concerned;

Whereas the Commission also examined, for the reference years set out in Decision 80/47/EEC, whether there had been deflection of trade, or whether intra-Community licence applications had been submitted; whereas the Commission took the view that, in the absence of such elements, there is little risk of a worsening or prolongation of economic difficulties arising out of the circumstances referred to in Article 115, and that consequently the surveillance measures requested in those cases should not be agreed to;

Whereas, however, such measures may be authorized for Group 1 textiles as defined by Council Regulation (EEC)

No 3059/78<sup>(1)</sup>, as last amended by Regulation (EEC) No 3063/79<sup>(2)</sup>, even if there has been no trade deflection or intra-Community licence applications, in view of the inherent risk of economic difficulties in trade in these products, which are highly sensitive to imports;

Whereas, in cases where there is an import limitation at Community level for a specific product in relation to certain third countries, the risk that economic difficulties will become worse or be prolonged may generally be considered as negligible as regards all those third countries from which the total possible imports to the Community taken together are less than 1% of the quantitative limit at Community level;

Whereas this examination has shown that there is a risk that the imports set out in the Annexes hereto could worsen or prolong the existing economic difficulties in the different Member States; whereas, therefore, the Member States should be authorized to make them subject to intra-Community surveillance until the end of 1981;

Whereas for those imports not listed in the Annexes, Member States remain entitled to keep account of the imports made and later put forward applications for surveillance;

Whereas, to enable Member States to implement this Decision, the time limit laid down in Article 5 (3) of Decision 80/47/EEC should be extended as regards the surveillance of imports not listed in the Annexes,

HAS ADOPTED THIS DECISION:

*Article 1*

The Member States named in Annexes 1 to 8 are authorized, in so far as each is concerned, to introduce until 31 December 1981 and in accordance with Decision 80/47/EEC, intra-Community surveillance of the products listed in the said Annexes.

*Article 2*

The time limit laid down in Article 5 (3) of Decision 80/47/EEC is hereby extended to 31 July 1980 as regards the surveillance of imports not listed in the Annexes.

*Article 3*

This Decision is addressed to the Member States.
