COMMISSION REGULATION (EEC) No 2536/86**of 25 July 1986****fixing for the 1985/86 marketing year the yields of olives and olive oil**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,
Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats⁽¹⁾, as last amended by Regulation (EEC) No 1454/86⁽²⁾, and in particular Article 5 (5) thereof,

Having regard to Council Regulation (EEC) No 2261/84 of 17 July 1984 laying down general rules on the granting of aid for the production of olive oil and of aid to olive oil producer organizations⁽³⁾, and in particular Article 19 thereof,

Whereas, for the purpose of granting production aid to olive-growers who produce less than 100 kilograms of oil or are not members of a producers' organization, Article 18 of Council Regulation (EEC) No 2261/84⁽³⁾ provides that yields of olives and olive oil should be fixed for each homogeneous production zone on the basis of information supplied by the producer Member States;

Whereas, in view of the information received, it is appropriate to fix these yields as specified in the Annex hereto;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Oils and Fats,

HAS ADOPTED THIS REGULATION:

Article 1

1. For the 1985/86 marketing year, yields of olives and olive oil and the relevant production zones shall be as specified in Annex I hereto.
2. The production zones are defined in Annex II.

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 337/79 of 5 February 1979 on the common organization of the market in wine ⁽¹⁾, as last amended by Regulation (EEC) No 3805/85 ⁽²⁾, and in particular Articles 14a (4) and 65 thereof,

Having regard to Council Regulation (EEC) No 1676/85 of 11 June 1985 on the value of the unit of account and the conversion rates to be applied for the purposes of the common agricultural policy ⁽³⁾,

Having regard to the Council Regulation (EEC) No 1678/85 of 11 June 1985 fixing the conversion rates to be applied in agriculture ⁽⁴⁾, as last amended by Regulation (EEC) No 2332/86 ⁽⁵⁾,

Whereas, under the second and third indents of the first subparagraph of Article 14a (1) of Regulation (EEC) No 337/79, an aid system was introduced for the use of grape musts and concentrated grape musts produced in wine-growing zones C III (a) and C III (b) for the preparation in the United Kingdom and Ireland of certain products, falling within heading No 22.07 of the Common Customs Tariff and for the use of concentrated grape musts produced in the Community for the manufacture of certain products marketed in the United Kingdom and in Ireland with instructions for obtaining from them a beverage in imitation of wine;

Whereas the products falling within heading No 22.07 of the Common Customs Tariff referred to in the second indent of the first subparagraph of Article 14a (1) of the abovementioned Regulation are at the moment produced exclusively from concentrated grape must; whereas, at present, aid should therefore be fixed for the use of concentrated grape must alone;

Whereas implementation of the aid system requires administrative arrangements for checking both the origin of the products for which aid is given and the use to which they are put;

Whereas, to ensure that the aid system and the controls operate properly, operators concerned must be required to submit written applications giving the information necessary to identify the product and enable the operations to be checked;

Whereas, so that the aid system can have an appreciable effect on the quantity of Community products used, a minimum quantity for which applications may be submitted should be fixed;

Whereas it should also be stated that aid will be granted only for products having the minimum quality characteristics required for use for the purposes indicated in the second and third indents of the first subparagraph of Article 14a (1) of Regulation (EEC) No 337/79;

Whereas Article 14a (3) of that Regulation sets criteria for fixing the aid; whereas application of those criteria gives the aid amounts fixed below;

Whereas, to enable the competent authorities of the Member States to make the necessary checks, obligations on operators in regard to the keeping of stock records should be laid down in addition to the provisions of Title II of Commission Regulation (EEC) No 1153/75 ⁽⁶⁾, as last amended by Regulation (EEC) No 3203/80 ⁽⁷⁾;

Whereas it should be laid down that entitlement to aid is established at the moment when the processing operations are completed; whereas, to allow for technical losses, the quantity actually used should be allowed to be up to 10 % less than that shown in the application;

Whereas for technical reasons operators lay in their stocks a long time before manufacturing the marketed products; whereas arrangements should accordingly be made to enable advance payment of the aid to be made to operators, the competent authorities being guaranteed by an appropriate security against the risk of incorrect payment; whereas the period within which advance payment is to be made and the procedure for release of the security should be specified;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Wine,

HAS ADOPTED THIS REGULATION :

Article 1

Aid shall be granted for the 1986/87 wine year in accordance with the conditions laid down in this Regulation :

- to manufacturers, hereinafter referred to as 'manufacturers', who use concentrated grape must made entirely from grapes produced within wine-growing zones C III (a) and C III (b) for the manufacture in the United Kingdom and Ireland, of products falling within heading No 22.07 of the Common Customs Tariff for which, by virtue of the first subparagraph of Article 54 (1) of Regulation (EEC) No 337/79, the use of composite names including the word 'wine' may be permitted by those Member States,
- to processors, hereinafter referred to as 'processors' who use concentrated grape must made entirely from grapes produced within the Community as the main component in a range of products marketed in the United Kingdom and Ireland by the said processors, with clear instructions enabling the consumer to obtain therefrom a beverage in imitation wine.

Article 2

1. Manufacturers or processors who wish to qualify for the aid provided for in Article 1 shall submit a written application, between 1 September 1986 and 31 August 1987, to the competent authority of the Member State in which the concentrated grape must is employed.

2. The application for aid shall show :

- (a) the name or business name and the address of the manufacturer or processor ;
- (b) the wine-growing zone from which the concentrated grape must comes, as defined in Annex IV to Regulation (EEC) No 337/79 ;
- (c) the following technical particulars :
 - the place of storage,
 - the place where the operations referred to in Article 1 are carried out,
 - the quantity (in kilograms and, if the concentrated grape must referred to in the second indent of Article 1 is packed in containers with contents not exceeding 5 kilograms, the number of containers),
 - the density,
 - the prices paid.

The Member States may require further particulars for the purposes of identifying the concentrated grape must.

3. A copy of the accompanying document(s) covering transport of the concentrated grape must from the producer's plant to the manufacturer's or processor's plant, drawn up by the competent agency of the Member State, shall be attached to the application for aid. The Member States may not make use of the provisions of the second

subparagraph of Article 4 (2) of Regulation (EEC) No 1153/75.

The wine-growing zone where the fresh grapes employed were harvested shall be entered in column 15 of the document.

Article 3

1. Applications for aid shall cover a minimum quantity of 50 kilograms of concentrated grape must.
2. The concentrated grape must in respect of which aid is applied for must be of sound, fair and merchantable quality and suitable for use for the purposes listed in Article 1.

Article 4

The aid shall be at a fixed rate of :

- 0,15 ECU per kilogram of concentrated grape must used for the purposes referred to in the first indent of Article 1,
- 0,26 ECU per kilogram of concentrated grape must used for the purposes referred to in the second indent of Article 1.

Article 5

The manufacturer or processor shall be bound to use, for the purposes referred to in Article 1, the total quantity of the concentrated grape must in respect of which an aid application has been made. A shortfall of 10 % of the quantity of concentrated grape must stated in the application shall be tolerated.

Article 6

The manufacturer or processor shall keep stock records in accordance with the provisions of Title II of Regulation (EEC) No 1153/75, showing in particular :

- the consignment of concentrated grape must purchased and brought each day into his plant, together with the particulars indicated in Article 2 (2) (b) and (c) and the name and address of the seller(s),
- the quantities of concentrated grape must used each day for the purposes listed in Article 1,
- the consignments of finished products listed in Article 1 obtained and dispatched each day from his plant, together with the name and address of the consignee(s).

Article 7

The manufacturer or processor shall inform the competent authority in writing, within one month, of the date when all the concentrated grape must covered by an application for aid has been used for the purposes listed in Article 1 allowing for the shortfall provided for in Article 5.

Article 8

1. Entitlement to the aid shall be acquired at the moment when the concentrated grape must has been used for the purposes indicated in Article 1.
2. The amount of aid shall be that applicable for the wine year during which it was applied for.
3. The amounts set out in Article 4 shall be converted into national currencies using the agricultural conversion rate applying on 1 September 1986.

Article 9

1. The competent authority shall pay the aid for the quantity of concentrated grape must actually used not later than three months after receipt of the information indicated in Article 7.
2. Manufacturers and processors as referred to in Article 1 may apply for advance payment of an amount equal to the aid specified in Article 4 provided they have lodged a security for 110 % of the said amount in favour of the competent authority.
Such securities shall be lodged in the form of a guarantee by an establishment satisfying criteria set by the Member State to which the competent authority belongs.
3. The advance payment referred to in paragraph 2 shall be paid within three months of the security being lodged provided that evidence that the concentrated grape must has been paid for is provided.
4. When the information referred to in Article 7 has been received by the competent authority, the security mentioned in paragraph 2 shall be released in whole or in part depending on the amount of aid to be paid pursuant to the provisions of Article 10.

Article 10

1. Except in case of *force majeure*, the aid shall not be payable if the manufacturer or processor does not fulfil the requirement set out in Article 5.
2. Except in case of *force majeure*, if the manufacturer or processor does not comply with any of the requirements of this Regulation other than those referred to in Article 5, the aid payable shall be reduced by an amount to be fixed by the competent authority depending on the seriousness of the infringement.
3. In cases of *force majeure*, the competent authority shall determine the measures which it deems necessary having regard to the circumstances invoked.

4. The Member States shall inform the Commission of cases in which paragraph 2 has been applied, and of how requests for recourse to the *force majeure* clause have been dealt with.

Article 11

1. The Member States concerned shall take all measures necessary for the application of this Regulation and, in particular, measures to ascertain the identity of the concentrated grape must in respect of which an application for aid is made and measures to prevent its being put to improper use.
2. To that end the competent authority shall :
 - carry out a verification in the manufacturer's or processor's plant which shall consist of at least a spot check,
 - inspect each manufacturer's or processor's stock records as referred to in Article 6.

Article 12

The Member States concerned shall notify to the Commission, before the 20th of each month, in respect of the preceding month, and for each intended use referred to in Article 1, of :

- (a) the quantities of concentrated grape must in respect of which an application for aid has been made, with a breakdown to show the wine-growing zone from which they have come ;
- (b) the quantities of concentrated grape must in respect of which aid has been granted with a breakdown to show the wine-growing zone from which they have come ;
- (c) the prices to be paid by manufacturers and processors for the concentrated grape must.

Article 13

The Member States concerned shall designate a competent authority to be responsible for applying this Regulation, and shall notify the Commission without delay of their names and addresses.

Article 14

The provisions of this Regulation shall not apply to Portugal.

Article 15

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall apply from 1 September 1986.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Whereas Commission Regulation (EEC) No 2390/86⁽³⁾ introduced a countervailing charge on aubergines originating in Spain (except in the Canary Islands);

Whereas for aubergines originating in Spain (except in the Canary Islands) there were no prices for six consecutive working days; whereas the conditions specified in Article 26 (1) of Regulation (EEC) No 1035/72 are therefore fulfilled and the countervailing charge on imports of

aubergines originating in Spain (except in the Canary Islands) can be abolished;

Whereas, pursuant to Article 136 (2) of the Act of Accession of Spain and Portugal⁽⁴⁾, the arrangements applicable to trade between, on the one hand, a new Member State and, on the other, the Community as constituted at 31 December 1985, must be those which were applicable before accession,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 2390/86 is hereby repealed.

Article 2

This Regulation shall enter into force on 12 August 1986.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Having regard to Council Regulation No 1676/85 of 11 June 1985 on the value of the unit of account and the exchange rates to be applied for the purposes of the common agricultural policy⁽⁵⁾ and in particular Article 3 thereof,

Having regard to the advice of the Monetary Committee,

Whereas the import levies on products processed from cereals and rice were fixed by Commission Regulation (EEC) No 2418/86⁽⁶⁾, as last amended by Regulation (EEC) No 2529/86⁽⁷⁾;

Whereas Council Regulation (EEC) No 1588/86⁽⁸⁾ as amended by Council Regulation (EEC) No 2744/75⁽⁹⁾ as regards products falling within subheading 23.02 A of the Common Customs Tariff;

Whereas, if the levy system is to operate normally, levies should be calculated on the following basis:

— in the case of currencies which are maintained in relation to each other at any given moment within a band

of 2,25 %, a rate of exchange based on their central rate, multiplied by the corrective factor provided for in the last paragraph of Article 3 (1) of Regulation (EEC) No 1676/85,

— for other currencies, an exchange rate based on the arithmetic mean of the spot market rates of each of these currencies recorded over a given period in relation to the Community currencies referred to in the previous indent, and the aforesaid coefficient;

Whereas these exchange rates being those recorded on 8 August 1986;

Whereas the aforesaid corrective factor affects the entire calculation basis for the levies, including the equivalence coefficients;

Whereas the levy on the basic product as last fixed differs from the average levy by more than 3,02 ECU per tonne of basic product; whereas, pursuant to Article 1 of Commission Regulation (EEC) No 1579/74⁽¹⁰⁾ the levies at present in force must therefore be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1'

The import levies to be charged on products processed from cereals and rice covered by Regulation (EEC) No 2744/75, as last amended by Regulation (EEC) No 1588/86, as fixed in the Annex to amended Regulation (EEC) No 2418/86 are hereby altered to the amounts set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 12 August 1986.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COUNCIL DIRECTIVE

of 24 July 1986

**on the implementation of the principle of equal treatment for men and women
in occupational social security schemes**

(86/378/EEC)

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 100 and 235 thereof,

Having regard to the proposal from the Commission ⁽¹⁾,

Having regard to the opinion of the European Parliament ⁽²⁾,

Having regard to the opinion of the Economic and Social Committee ⁽³⁾,

Whereas the Treaty provides that each Member State shall ensure the application of the principle that men and women should receive equal pay for equal work ; whereas 'pay' should be taken to mean the ordinary basic or minimum wage or salary and any other consideration, whether in cash or in kind, which the worker receives, directly or indirectly, from his employer in respect of his employment ;

Whereas, although the principle of equal pay does indeed apply directly in cases where discrimination can be determined solely on the basis of the criteria of equal treatment and equal pay, there are also situations in which implementation of this principle implies the adoption of additional measures which more clearly define its scope ;

Whereas Article 1 (2) of Council Directive 76/207/EEC of 9 February 1976 on the implementation of the principle

of equal treatment for men and women as regards access to employment, vocational training and promotion, and working conditions ⁽⁴⁾ provides that, with a view to ensuring the progressive implementation of the principle of equal treatment in matters of social security, the Council, acting on a proposal from the Commission, will adopt provisions defining its substance, its scope and the arrangements for its application ; whereas the Council adopted to this end Directive 79/7/EEC of 19 December 1978 on the progressive implementation of the principle of equal treatment for men and women in matters of social security ⁽⁵⁾ ;

Whereas Article 3 (3) of Directive 79/7/EEC provides that, with a view to ensuring implementation of the principle of equal treatment in occupational schemes, the Council, acting on a proposal from the Commission, will adopt provisions defining its substance, its scope and the arrangements for its application ;

Whereas the principle of equal treatment should be implemented in occupational social security schemes which provide protection against the risks specified in Article 3 (1) of Directive 79/7/EEC as well as those which provide employees with any other consideration in cash or in kind within the meaning of the Treaty ;

Whereas implementation of the principle of equal treatment does not prejudice the provisions relating to the protection of women by reason of maternity,

HAS ADOPTED THIS DIRECTIVE :

Article 1

The object of this Directive is to implement, in occupational social security schemes, the principle of equal treatment for men and women, hereinafter referred to as 'the principle of equal treatment'.

Article 2

1. 'Occupational social security schemes' means schemes not governed by Directive 79/7/EEC whose purpose is to provide workers, whether employees or self-employed, in an undertaking or group of undertakings, area of economic activity or occupational sector or group of such sectors with benefits intended to supplement the benefits provided by statutory social security schemes or to replace them, whether membership of such schemes is compulsory or optional.

2. This Directive does not apply to :

- (a) individual contracts,
- (b) schemes having only one member,
- (c) in the case of salaried workers, insurance schemes offered to participants individually to guarantee them :
 - either additional benefits, or
 - a choice of date on which the normal benefits will start, or a choice between several benefits.

Article 3

This Directive shall apply to members of the working population including self-employed persons, persons whose activity is interrupted by illness, maternity, accident or involuntary unemployment and persons seeking employment, and to retired and disabled workers.

Article 4

This Directive shall apply to :

- (a) occupational schemes which provide protection against the following risks :
 - sickness,
 - invalidity,
 - old age, including early retirement,
 - industrial accidents and occupational diseases,
 - unemployment ;
- (b) occupational schemes which provide for other social benefits, in cash or in kind, and in particular survivors' benefits and family allowances, if such benefits are accorded to employed persons and thus constitute a

consideration paid by the employer to the worker by reason of the latter's employment.

Article 5

1. Under the conditions laid down in the following provisions, the principle of equal treatment implies that there shall be no discrimination on the basis of sex, either directly or indirectly, by reference in particular to marital or family status, especially as regards :

- the scope of the schemes and the conditions of access to them ;
- the obligation to contribute and the calculation of contributions ;
- the calculation of benefits, including supplementary benefits due in respect of a spouse or dependants, and the conditions governing the duration and retention of entitlement to benefits.

2. The principle of equal treatment shall not prejudice the provisions relating to the protection of women by reason of maternity.

Article 6

1. Provisions contrary to the principle of equal treatment shall include those based on sex, either directly or indirectly, in particular by reference to marital or family for :

- (a) determining the persons who may participate in an occupational scheme ;
- (b) fixing the compulsory or optional nature of participation in an occupational scheme ;
- (c) laying down different rules as regards the age of entry into the scheme or the minimum period of employment or membership of the scheme required to obtain the benefits thereof ;
- (d) laying down different rules, except as provided for in subparagraphs (h) and (i), for the reimbursement of contributions where a worker leaves a scheme without having fulfilled the conditions guaranteeing him a deferred right to long-term benefits ;
- (e) setting different conditions for the granting of benefits of restricting such benefits to workers of one or other of the sexes ;
- (f) fixing different retirement ages ;
- (g) suspending the retention or acquisition of rights during periods of maternity leave or leave for family reasons which are granted by law or agreement and are paid by the employer ;
- (h) setting different levels of benefit, except insofar as may be necessary to take account of actuarial calculation factors which differ according to sex in the case of benefits designated as contribution-defined ;

- (i) setting different levels of worker contribution ;
 setting different levels of employer contribution in the case of benefits designated as contribution-defined, except with a view to making the amount of those benefits more nearly equal ;
- (j) laying down different standards or standards applicable only to workers of a specified sex, except as provided for in subparagraphs (h) and (i), as regards the guarantee or retention of entitlement to deferred benefits when a worker leaves a scheme.

2. Where the granting of benefits within the scope of this Directive is left to the discretion of the scheme's management bodies, the latter must take account of the principle of equal treatment.

Article 7

Member States shall take all necessary steps to ensure that :

- (a) provisions contrary to the principle of equal treatment in legally compulsory collective agreements, staff rules of undertakings or any other arrangements relating to occupational schemes are null and void, or may be declared null and void or amended ;
- (b) schemes containing such provisions may not be approved or extended by administrative measures.

Article 8

1. Member States shall take all necessary steps to ensure that the provisions of occupational schemes contrary to the principle of equal treatment are revised by 1 January 1993.

2. This Directive shall not preclude rights and obligations relating to a period of membership of an occupational scheme prior to revision of that scheme from remaining subject to the provisions of the scheme in force during that period.

Article 9

Member States may defer compulsory application of the principle of equal treatment with regard to :

- (a) determination of pensionable age for the purposes of granting old-age or retirement pensions, and the possible implications for other benefits :
 — either until the date on which such equality is achieved in statutory schemes,

— or, at the latest, until such equality is required by a directive.

- (b) survivors' pensions until a directive requires the principle of equal treatment in statutory social security schemes in that regard ;
- (c) the application of the first subparagraph of Article 6 (1) (i) to take account of the different actuarial calculation factors, at the latest until the expiry of a thirteen-year period as from the notification of this Directive.

Article 10

Member States shall introduce into their national legal systems such measures as are necessary to enable all persons who consider themselves injured by failure to apply the principle of equal treatment to pursue their claims before the courts, possibly after bringing the matters before other competent authorities.

Article 11

Member States shall take all the necessary steps to protect worker against dismissal where this constitutes a response on the part of the employer to a complaint made at undertaking level or to the institution of legal proceedings aimed at enforcing compliance with the principle of equal treatment.

Article 12

1. Member States shall bring into force such laws, regulations and administrative provisions as are necessary in order to comply with this Directive at the latest three years after notification thereof⁽¹⁾. They shall immediately inform the Commission thereof.

2. Member States shall communicate to the Commission at the latest five years after notification of this Directive all information necessary to enable the Commission to draw up a report on the application of this Directive for submission to the Council.

Article 13

This Directive is addressed to the Member States.

COUNCIL RECOMMENDATION

of 24 July 1986

on the employment of disabled people in the Community

(86/379/EEC)

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 235 thereof,

Having regard to the draft recommendation submitted by the Commission,

Having regard to the opinion of the European Parliament⁽¹⁾,

Having regard to the opinion of the Economic and Social Committee⁽²⁾,

Whereas the Council Resolution of 21 January 1974 concerning a social action programme⁽³⁾ provides for, *inter alia*, the implementation of a programme for the vocational and social integration of handicapped persons ;

Whereas the Council Resolution of 27 June 1974⁽⁴⁾ established the initial Community action programme for the vocational rehabilitation of handicapped persons ;

Whereas the Resolution of the Council and of the Representatives of the Governments of the Member States, meeting within the Council, of 21 December 1981 on the social integration of handicapped people⁽⁵⁾ invites Member States to ensure that handicapped people do not shoulder an unfair burden of the effects, in particular from the point of view of employment, of economic difficulties and to promote measures to prepare handicapped people for an active life, but does not provide for a concerted or concentrated Community effort in this regard ;

Whereas, for the purpose of this Recommendation, 'disabled people' includes all people with serious disabilities which result from physical, mental or psychological impairments ;

Whereas disabled people have the same right as all other workers to equal opportunity in training and employment ;

Whereas, in a period of economic crisis, action at European and Community levels should be not only continued but also intensified in order to promote the achieve-

ment of equal opportunity by means of positive and coherent policies ;

Whereas these policies should take account of the aspirations of disabled people for a fully active and independent life ;

Whereas the European Parliament, in its resolution of 11 March 1981⁽⁶⁾, stressed the need to promote at Community level the economic, social and vocational integration of disabled people ;

Whereas the provision of fair opportunities for disabled people in the field of employment and vocational training appears necessary for the achievement of one of the objectives of the Community ; whereas the Treaty has not provided for the powers of action required for the adoption of this Recommendation, other than those of Article 235,

I. HEREBY RECOMMENDS MEMBER STATES :

1. To take all appropriate measures to promote fair opportunities for disabled people in the field of employment and vocational training, including initial training and employment as well as rehabilitation and resettlement.

The principle of fair opportunity for disabled people should be applied in respect of :

- (a) access to employment and vocational training, whether normal or special, including guidance, placement and follow-up services ;
- (b) retention in that employment or vocational training and protection from unfair dismissal ;
- (c) opportunities for promotion and in-service training.

2. To this end, to continue and, if necessary, intensify and re-examine their policies to help disabled people, where appropriate after consulting disabled people's organizations and both sides of industry ; such policies should take account of measures and specific activities implemented in the other Member States which have proved effective and worthwhile.

These policies should provide in particular for :

(a) *Elimination of negative discrimination by:*

- (i) reviewing laws, regulations and administrative provisions to ensure that they are not contrary to the principle of fair opportunity for disabled people ;

- (ii) taking appropriate measures to avoid as far as possible dismissals linked to a disability ;
 - (iii) limiting exceptions to the principle of equal treatment in access to training or employment to the cases justified on the ground of a specific incompatibility between a particular activity forming part of a job or course of training and a particular disability ; if necessary, it should be possible to have this incompatibility confirmed by a medical certificate ; any such exception should be reviewed periodically in order to establish whether it continues to be justified ;
 - (iv) seeking to ensure that any tests required for access to vocational training courses and any tests required during or at the end of such courses are designed in such a way that candidates with disabilities are not thereby disadvantaged ;
 - (v) seeking to ensure that disabled people can go before the competent bodies to establish their rights and can receive the necessary assistance to do so in accordance with national law and practice.
- (b) *Positive action for disabled people, including :*
- (i) bearing in mind differences in sectors and enterprises, the fixing by Member States, where appropriate and after consultation of disabled people's organization and both sides of industry, of realistic percentage targets for the employment of disabled people in public or private enterprises having a minimum number of employees ; such a minimum might be set at between 15 and 50. Measures should also be adopted for making these targets public and achieving them ;
 - (ii) the making available, in each Member State, of a guide or code of good practice for the employment of disabled people, incorporating positive measures already adopted in the Member State concerned and corresponding in spirit with the provisions of this Recommendation ; the Annex comprises a guideline framework for such a guide or code, setting out examples of positive action ;
- the guide or code of good practice should be circulated as widely as possible and refer to the public and private sectors ;

it should describe clearly the contribution which the recipients of the guide or code can and should make in putting into practice the national policy on disabled people ; it should include information and advice on the support that is available from public services ;

- (iii) provision whereby the Member States encourage the public and private enterprises to take all appropriate measures for the employment of disabled people which correspond in spirit with the guide or code of good practice ; Member States should establish the means for making these policies, and the annual progress made in their implementation, known to the public, according to existing procedures for disseminating information in the social field ;
 - (iv) provision whereby the employer and the rehabilitation services cooperate in the resettlement, with the same enterprise as far as possible, of any employee who becomes disabled.
3. To report to the Commission on the measures they have taken to implement this Recommendation with a view to enabling the Commission to present the report referred to in II.3.

II. INVITES THE COMMISSION :

1. To co-ordinate the exchange of information and experience on the rehabilitation and employment of disabled people between national authorities ; agencies designated for the purpose by the Member States will also be involved in this exchange.
2. To maintain appropriate aid from the European Social Fund to assist disabled people of whatever age.
3. To report to the Council on the application of this Recommendation within two years of its adoption.

ANNEX

Guideline framework for positive action to promote the employment and vocational training of disabled people

Set out below are a number of possible measures, proposed by the Commission, which Member States should consider in implementing this Recommendation and in particular in drawing up a guide or code of good practice.

SECTION I

ASPECTS CONCERNING THE WORKING LIFE OF DISABLED PEOPLE

1. Job creation*(a) Concerted projects*

Ensuring that disabled people are given a full and fair opportunity to benefit from projects such as regional development programmes, local employment initiatives and action to promote the setting-up of cooperatives or of smaller medium-sized enterprises.

(b) New technology

Stimulating new employment opportunities by means of national initiatives both in the new technology sector itself and in the use of new technologies as aids to make employment possible in other fields.

In this connection, promoting projects to enable disabled people to take on tele-work.

Studying the specific risks to employment resulting from new technological developments and taking appropriate action.

Adapting work stations to the needs of disabled people.

(c) Other activities

Promoting and supporting projects which train and prepare disabled people to create their own business or which identify new employment opportunities in the media or in services on behalf of other disabled people.

Identifying other sectors (such as tertiary services, including tourism and catering, agriculture or horticulture and forestry) which have good pros-

pects and are suitable for people with various disabilities.

Implementing schemes for creating new jobs for disabled people in these fields.

Drawing up special national policies for the re-employment of mentally handicapped workers who lose their jobs because of changes in the character of the employment market.

Creating more opportunities for part-time employment for disabled workers.

2. Sheltered employment*(a) General*

Reviewing the situation in each Member State in regard to sheltered employment and sheltered occupation and drawing up plans for the future of this sector.

(b) Quantitative side

Arranging that plans should assess future demand and the need to develop or reduce such provision.

(c) Qualitative side

Seeing that the review takes into consideration the following points:

- improving the quality of less successful workshops or centres so that they approximate to the best;
- introducing new forms of activity (for example, in the computer sector) which are both more interesting and likely to be more successful commercially;
- increasing the amount of training available in workshops;
- developing the transitional role of workshops, i.e. their function as assessment and personal development centres coming between basic education or a period of unemployment and entry to the open labour market;
- reducing segregation by developing sheltered posts or groups within normal enterprises, or mixed cooperatives.

3. Transition, vocational rehabilitation and vocational training

Enabling disabled trainees to enrol in integrated training courses in normal establishments wherever possible and desirable.

Giving a high priority to improving the availability and quality of vocational preparation and training for disabled people, with particular regard to the following aims :

- giving equal consideration to the needs of workers who incur disability through accident or disease and to the needs of young people whose disability is congenital or was incurred in childhood or adolescence ;
- adapting the content of the training courses available to match more realistically the needs of the labour market ;
- strengthening direct links between training establishments and local representatives of both sides of industry ;
- improving training methods, in particular by developing the use of new technologies as training aids and by introducing modular training and, where appropriate, distant learning facilities ;
- encouraging experimentation in course structure and design so as to facilitate the coordination of theoretical and practical training ;
- improving all aspects of access to training courses ;
- encouraging disabled trainees to take, as far as possible, a more active part in planning their own training programmes ;
- guaranteeing continuity of vocational training and preparation for employment by promoting inter-professional cooperation and creating multidisciplinary teams.

4. Guidance, assessment and placement

(a) *Guidance*

Providing at regional level, as part of the general guidance services, educational and vocational guidance services with a clear responsibility to meet the needs of disabled people.

Providing, in the case of general, rather than specialized, guidance services, for staff to be trained to

understand and deal with the special needs of people with disabilities.

(b) *Assessment*

Identifying effective assessment methods and introducing those methods as far as possible.

Giving priority to the principles that :

- the disabled person himself (and, where appropriate, his family) should participate actively in assessment ;
- every client should be encouraged to opt for the best level of training and highest vocational goal of which he is capable.

(c) *Placement services*

Setting up at regional level, as part of the general placement services, placement services to help suitably trained disabled people to find a job.

Ensuring that these services also follow and support the disabled person in the job, at least for an initial period.

Implementing training programmes for disabled people's placement officers.

5. Employers and workers' organizations

(a) *Incentives to employers*

Encouraging employers to make greater use of funds from public sources.

Where appropriate, making such funds available, in accordance with national policies and situations, to cover, or contribute towards covering, the special costs to an employer of taking on a disabled worker.

The eligible expenditure should include adaptations to machinery or equipment, provision of access facilities and additional staff costs.

The grants should apply both when a worker is re-employed after incurring a disability and for new recruitments.

In the case of new recruitments, envisaging a contribution from public funds to the worker's salary over a given period of induction training.

(b) *Workers' organizations*

Encouraging trade unions to give any necessary support to disabled workers and to ensure that their interests are properly catered for in representative structures.

6. Social security

Ensuring that disabled workers who lose their jobs or who cannot find employment after vocational rehabilitation do not find themselves thereafter, purely because of their disability, financially worse off than other workers in similar circumstances.

Ensuring that benefit systems do not act as disincentives to part-time employment, to trial periods of employment or to the gradual take-up of a job or return to it, whenever any of these patterns is desirable from the disabled worker's and employer's point of view.

SECTION II**GENERAL ASPECTS****1. The supporting environment**

Ensuring that disabled people live in an environment which makes it possible for them to benefit from further education and training and to make their full contribution to the economy.

Effectively implementing existing legislation and where necessary introducing new legislation to promote :

- suitable housing (wherever possible integrated in the open community),
- adequate transport to places of training and work,
- access to and within the workplace, especially in the office sector.

Ensuring that measures aimed at guaranteeing fair opportunities for the disabled are not regarded as discriminatory against the able-bodied.

Recognizing the need for flexibility in the conditions of employment of persons looking after a disabled person.

2. Information and advice**(a) Assistance for disabled people**

Developing, for the benefit of disabled people, their families and the professionals (whether case-workers or administrators) concerned, a system of information and advice covering technical aids and other questions of importance to disabled people.

Extending the system, which could consist of specialized centres or of services developed in existing centres with wider functions, below the national level to regional and local levels over time as resources permit.

(b) Information campaign

Undertaking coordinated action to inform and advise politicians, both sides of industry and the general public of the capacities and the needs of disabled people.

In particular, making audio-visual material on disability problems widely available through appropriate channels such as interest groups and training schemes run by both sides of industry.

3. Social research

Encouraging and coordinating social research — for which national data bases should be established — both in order to analyse needs and possibilities and to evaluate the effectiveness of measures undertaken.

4. Consultation, coordination and participation

Continuing and developing systems of national, regional and local authorities' consultation, coordination and participation, including in this exercise the public services and agencies, the voluntary organizations, independent professionals, the two sides of industry and the media as well as disabled people and their families.

Giving particular priority to the active involvement of disabled people, whether in a representative or personal capacity, in the taking and implementation of decisions concerning them.
