COUNCIL REGULATION (EEC) No 1889/87

of 2 July 1987

amending Regulation (EEC) No 1677/85 as regards the rules for calculating monetary compensatory amounts in agriculture

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 42 and 43 thereof,

Having regard to the proposal from the Commission ⁽¹⁾,

Having regard to the opinion of the European Parliament ⁽²⁾,

Having regard to the opinion of the Monetary Committee,

Whereas Article 6 of Council Regulation (EEC) No 1677/85 of 11 June 1985 on monetary compensatory amounts in agriculture ⁽³⁾, as last amended by Commission Regulation (EEC) No 90/87 ⁽⁴⁾, lays down arrangements applicable for the calculation of monetary compensatory amounts until the end of the 1986/87 marketing year; whereas the experience gained suggests that those arrangements should be maintained;

Whereas it appears appropriate to take advantage of the extension of the calculation arrangements also in order to dismantle existing positive monetary compensatory amounts by reducing them by 1,0 percentage points; whereas, to this end, it is necessary to increase the correcting factor;

Whereas, however, applying those arrangements may, in view of the current priorities of the common agricultural policy, give rise to problems; whereas, desirable though it may be in principle, eliminating negative monetary compensatory amounts raises prices expressed in national currency, and may lead to further overproduction; whereas this runs counter to a policy aimed at controlling agricultural production; whereas the existing arrangements should be supplemented by rules designed to reconcile those divergent objectives;

Whereas the arrangements currently applicable differ from the standard method only as regards the

application of the correcting factor; whereas the other components used in the calculation are identical; whereas those components include the neutral margin applied in respect of the real monetary gap;

Whereas the experience gained in certain agricultural sectors shows that monetary gaps can be higher than those corresponding to the present neutral margins without trade necessarily being disrupted by the lack of monetary compensatory amounts;

Whereas Article 5 (5) of the Regulation in question provides, in the case of pigmeat, for two specific equivalent calculation methods applicable for a certain period; whereas, in the light of experience, the calculation method using the basic price of pig carcasses should become the definitive method; whereas, having regard to the features peculiar to this sector, provision should be made for specific arrangements for dismantling monetary compensatory amounts;

Whereas Regulation (EEC) No 1677/85 should be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

Article 5 and 6 of Regulation (EEC) No 1677/85 are hereby replaced by the following Articles:

Article 5

1. For basic products, the monetary compensatory amounts shall be equal to the amounts obtained by applying to the prices a percentage, hereinafter referred to as the "monetary gap".

For derived products, the monetary compensatory amounts shall be equal to the effect, on the price of the product concerned, of the application of the monetary compensatory amount to the price of the basic product or products on which they depend.

2. The monetary gap shall be equal to the real monetary gap minus the neutral margin as defined in paragraph 3.

The real monetary gap shall be equal:

(a) in respect of those Member States whose currencies are maintained as between themselves within a spread at any given time of a maximum of 2,25 %, to the percentage representing, for the currency of the Member State concerned, the difference between:

- the agricultural conversion rate, and
- the central rate;

(b) in respect of Member States other than those referred to in (a), to the average of the percentage differences between:

- the rate resulting from the relationship between the agricultural conversion rate for the currency of the Member State concerned and the central rate of each of the currencies of the Member States referred to in (a), and
- the rate corresponding to the average spot exchange rate for the currency of the Member State concerned in terms of each of the currencies of the Member States referred to in (a), recorded over a period to be determined according to the procedure in Article 12.

3. For the purposes of calculating the monetary compensatory amounts, the neutral margin shall be 1,50 percentage points, except for the Netherlands, for which it shall be 1,0 percentage point.

However:

(a) a percentage of:

- 0 shall be applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 0,50 but exceeds 0,
- 1,0 shall be applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 1,0 but exceeds 0,50;

(b) following the procedure provided for in Article 12, the neutral margin may be set at a maximum level of:

- five percentage points for the monetary compensatory amounts applicable in the wine and poultry raising sectors,
- 10 percentage points for the monetary compensatory amounts applicable in the olive oil sector.

4. Should the market price for adult bovine animals remain below the intervention price for a relatively long period, the monetary compensatory amounts applicable in the beef and veal sector may be altered accordingly, following the procedure provided for in Article 12.

Article 6

1. For the purposes of applying Articles 1, 2, 3 and 5, the central rates shall be multiplied by a coefficient, which shall be called a "correcting factor".

The market rates shall be established allowing for the correcting factor applied to the central rates.

The correcting factor shall be 1,137282 with effect:

- at the beginning of the 1987/88 marketing year for those products for which such marketing year has not yet started on the date on which Regulation (EEC) No 1890/87 takes effect,
- on the date on which Regulation (EEC) No 1890/87 takes effect for the remaining products.

The correcting factor shall be altered whenever parities are realigned within the European Monetary System, on the basis of the revaluation of the central rate of that currency, among the currencies maintained among themselves within a maximum spread at any given time of 2,25 %, the revaluation of which *vis-à-vis* the ECU is the highest. The procedure followed shall be that laid down in Article 12.

2. For the purposes of this Article, "transferred-negative monetary compensatory amounts" shall mean those amounts resulting from the application of paragraph 1, being supplementary as compared with those which would have resulted from the application of Article 5 alone.

The agriculture conversion rates shall be adjusted in such a way as to eliminate any newly created monetary gaps, for each of the currencies concerned. The said elimination shall be carried out by instalments as follows:

- (a) in the case of transferred negative monetary compensatory amounts created during a marketing year:
- 25 % at the beginning of the marketing year which follows the realignment or realignments of parities,
 - 37,5 % at the beginning of the second and third years which follow the realignment or realignments of parities;
- (b) in the case of the other negative monetary compensatory amounts created since the last realignment of parities:
- a maximum of 30 % when parities are realigned,

- at the beginning of the two years following realignment of parities: in two equal instalments for monetary compensatory amounts which are not dismantled.

The abovementioned adjustments shall be carried out following the procedure in Article 12. However, the negative monetary gaps which are eliminated shall in no case exceed the negative real monetary gap obtaining when the agricultural conversion rate was adjusted.

3. When the amendment of the agricultural conversion rates takes effect, under the first indent of (a) of the second subparagraph of paragraph 2, the prices fixed in ECUs under the common agricultural policy shall be reduced in accordance with the procedure provided for in Article 12 so as to neutralize the increase in the prices in national currency which arises as a result of the amendment of the agricultural conversion rates.

Those Member States in which prices in national currency fall as a result of the first subparagraph's being applied shall be authorized, according to a procedure to be determined by the Council, acting by a qualified majority on a proposal from the Commission, to grant national compensation aid. Such aid must be directed towards the socio-structural field and may not be linked to production.

4. For the purposes of applying the first subparagraph of paragraph 3:

- (a) a coefficient shall be established which expresses the relationship between the new and old correcting factor, allocated, as appropriate, on the basis of the dismantling stages envisaged;
- (b) the prices fixed under the common agricultural policy shall be divided by the coefficient referred to in (a). The other amounts fixed in ECU under the common agricultural policy shall, as far as the need arises, be amended as appropriate.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

5. This Article shall apply without prejudice to:

- Article 2 of Regulation No 1676/85⁽¹⁾, where an additional dismantling of monetary compensatory amounts is being contemplated,
- Regulation (EEC) No 129/78⁽²⁾.

6. Where this Article provides that a measure is to take effect from the beginning of a marketing year, the date concerned shall, in the case of products or sectors for which there is no marketing year, be fixed in accordance with the procedure introducing the measure in question.

7. The arrangements provided for in this Article will be re-examined before 1 July 1988.

Article 6a

The following provisions shall apply in the pigmeat sector:

- (1) the monetary compensatory amounts shall be fixed on the basis of a price equal to 35 % of the basic price;
- (2) in accordance with the procedure provided for in Article 12, the agricultural conversion rate of a Member State shall be adjusted so as to avoid new compensatory amounts being created. However, such adjustment may not bring about a situation whereby, for the Member State concerned, the difference between the monetary gap applicable in the pigmeat sector, on the one hand, and the gap applicable in the cereals sector, on the other, exceeds eight percentage points.

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall be applicable with effect from 1 July 1987.

COUNCIL REGULATION (EEC) No 1890/87

of 2 July 1987

amending in particular Regulation (EEC) No 1678/85 fixing the conversion rates to be applied in agriculture

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 42 and 43 thereof,

Having regard to the Act of Accession of Spain and Portugal, and in particular Articles 80, 91, 247 and 258 thereof,

Having regard to Council Regulation (EEC) No 1676/85 of 11 June 1985 on the value of the unit of account and the conversion rates to be applied for the purposes of the common agricultural policy⁽¹⁾, and in particular Article 2 (3) thereof,

Having regard to the proposal from the Commission⁽²⁾,

Having regard to the opinion of the European Parliament⁽³⁾,

Having regard to the opinion of the Monetary Committee,

Whereas the conversion rates currently applicable were fixed by Regulation (EEC) No 1678/85⁽⁴⁾, as last amended by Regulation (EEC) No 409/87⁽⁵⁾;

Whereas it seems advisable, in addition, to fix new agricultural conversion rates:

- for the 1987/88 marketing year, with regard to the Belgian/Luxembourg franc, the Danish krone, the French franc, the Irish pound, the pound Sterling, the Spanish peseta, the Portuguese escudo, the Italian lira, the Greek drachma and the Dutch florin,
- for the 1988/89 marketing year, with regard to the German mark and the Dutch florin,

so as to bring them closer into line with economic reality, on the one hand, and to eliminate, for the currencies mentioned in the first indent, the effect of the adjustment of the correction factor referred to in Article 1 (3) of Regulation (EEC) No 1677/87⁽⁶⁾, as last amended by Regulation (EEC) No 1889/87⁽⁷⁾, on the other hand;

Whereas, in order to avoid differing treatment of interdependent products, provision should be made for the new agricultural conversion rates to apply in the cereals, eggs and poultry, ovalbumin and lactalbumin sectors with effect from the same date;

Whereas the adjustment of agricultural conversion rates in Germany entails, for the 1988/89 marketing year a drop in prices in terms of the national currency and, in consequence, a drop in agricultural income; whereas, by way of compensation, provision should be made for the possibility of granting national aid under a procedure to be laid down;

Whereas, in addition, it should be specified on this occasion that the agricultural conversion rate is also to apply for the conversion of the amounts fixed under Regulations (EEC) No 3773/85⁽⁸⁾ and (EEC) No 3774/85⁽⁹⁾ concerning certain national aids which are incompatible with the common market but which the Kingdom of Spain and the Portuguese Republic are authorized to maintain on a transitional basis in the agricultural sector,

HAS ADOPTED THIS REGULATION:

Article 1

1. The Annexes to Regulation (EEC) No 1678/85 are hereby replaced by the Annexes to this Regulation.

2. With effect from the start of the 1988/89 marketing year, the agricultural conversion rates appearing in Annex IX shall be replaced by those appearing in Annex IXa.

Article 2

The following Article shall be inserted in Regulation (EEC) No 1678/85:

Article 2a

1. A special aid granted to German farmers under the following conditions shall be considered as being compatible with the common market.
2. The Federal Republic of Germany shall be authorized to grant as from 1 January 1989 a national aid equivalent to that granted in the form of relief on value added tax, for the 2 % which expires on 31 December 1988.
3. The Council, acting by a qualified majority on a proposal from the Commission, shall lay down the detailed rules for the aid; however the latter may not be production-linked.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

Article 3

The following Article is hereby inserted in Regulations (EEC) No 3773/85 and (EEC) No 3774/85:

Article 2a

The rate to be used to convert the amounts fixed under this Regulation into national currency shall be the agricultural conversion rate.

Article 4

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

Whereas the guide price must be fixed in accordance with the criteria laid down in Article 3 (2) of Regulation (EEC) No 805/68; whereas Regulation (EEC) No 653/87 ⁽⁶⁾ provides for the application of the common prices in Spain at the beginning of the 1987/88 marketing year;

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Article 1

Member States shall record prices on the basis of the Community scale for the classification of carcasses of adult bovine animals as established by Regulation (EEC) No 1208/81 in parallel with the method that they apply, pursuant to Article 12 (6) of Regulation (EEC) No 805/68 on the date of entry into force of this Regulation.

Whereas the intervention prices for butter and for skimmed-milk powders are intended to contribute to the achievement of the target price for milk; whereas it is necessary to determine price levels in the light of the overall supply and demand situation on the Community market in milk and the opportunities for disposal of butter and skimmed-milk powder on the Community and world markets;

Whereas the intervention prices for Grana Padano and Parmigiano Reggiano cheeses must be fixed in accordance with the criteria laid down in Article 5 (2) of Regulation (EEC) No 804/68;

Whereas, under Article 5b of Regulation (EEC) No 804/68, the Council, when fixing the target price for milk and the intervention prices, fixes a guarantee threshold for milk; whereas, however, the initial objective in fixing a guarantee threshold is achieved *inter alia* by means of the system of quotas, together with an additional levy on deliveries of milk or milk products which exceed the reference quantities determined;

Whereas Article 68 of the Act of Accession has led to prices in Spain being set at a level differing from that of the common prices; whereas, pursuant to Article 70 (1) of the Act of Accession, the Spanish prices should be aligned with the common prices at the beginning of each marketing year; whereas the criteria laid down for alignment lead to the Spanish prices being set at the level mentioned hereinafter,

Whereas Regulation (EEC) No 1079/77 ⁽⁴⁾, as last amended by Regulation (EEC) No 1338/86 ⁽⁵⁾, introduced a co-responsibility levy to apply until the end of the 1986/87 milk year and covering, in principle, all milk supplied to dairies and certain sales of milk products at the farm;

Whereas this levy was designed to establish a better balance on the milk market by creating a more direct link between production and outlets for milk products while taking account of the importance of the interests of the public; whereas the information and forecasts currently available indicate that the aforesaid aims will probably not be reached at the end of the period provided for; whereas it is therefore necessary, on the one hand, to extend the application of the said levy for

the 1987/88 milk year and, on the other hand, to fix the rate of the levy for the said milk year at 2 % of the target price for milk,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 1079/77 is hereby amended as follows:

1. In Article 1 (1), the expression 'during the 1980/81, 1981/82, 1982/83, 1983/84, 1984/85, 1985/86 and 1986/87 milk years' shall be replaced by the expression 'during the 1980/81, 1981/82, 1982/83, 1983/84, 1984/85, 1985/86, 1986/87 and 1987/88 milk years';
2. The following paragraph 8 shall be added to Article 2:
'8. For the 1987/88 milk year, the levy shall be 2 % of the target price for milk.'

Having regard to the proposal from the Commission ⁽³⁾,

Whereas Regulation (EEC) No 985/68 ⁽⁴⁾, as last amended by Regulation (EEC) No 3790/85 ⁽⁵⁾, lays down that intervention measures shall only apply to butter which is classed as top quality in the Member States; whereas Article 1 (3) of Regulation (EEC) No 985/68 lays down that salted butter manufactured from sweet cream with a minimum butterfat content, by weight, of 80 % may be sold into intervention; whereas, in light of the situation on the market for butter and, in particular, the difficulties encountered by the intervention agencies in selling that type of butter on the Community or world market, that possibility should be abolished; whereas, however, in order to enable the industry concerned to adjust to the new rules, the buying-in of that until the end of the 1988/89 marketing year should be authorized as a transitional measure in those Member States where use is currently made of the possibility of buying in salted butter; whereas authorization should also be given to buy in for intervention butter manufactured from sweet cream, having a minimum butterfat content, by weight, of 82 %.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

on the protection of designations used in marketing of milk and milk products

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission ⁽¹⁾,

Having regard to the opinion of the European Parliament ⁽²⁾,

Having regard to the opinion of the Economic and Social Committee ⁽³⁾,

Whereas Council Regulation (EEC) No 804/68 ⁽⁴⁾, as last amended by Regulation (EEC) No 773/87 ⁽⁵⁾, introduced the common organization of the market in the milk products sector;

Whereas the situation of the milk and milk products sector is characterized by structural surpluses and whereas the disposal of these products should therefore be improved by promoting their consumption;

Whereas the natural composition of milk and milk products should be protected in the interests of Community producers and consumers;

Whereas regulations which ensure appropriate labelling and prevent the consumer from being misled will help this objective to be achieved;

Whereas milk and milk products should, therefore, be defined and the designations needing to be reserved for them should be clarified;

Whereas, apart from the case of products the exact nature of which is known through traditional usage, it is also necessary to avoid any confusion in the mind of the consumer between milk products and other food products, including those consisting partly of milk components;

Whereas this Regulation aims at protecting the consumer and at establishing conditions of competition between milk products and competing products in the field of product designation, labelling and advertising which avoid any distortion;

Whereas competing products enjoy a competitive advantage in terms of production cost due to the fact that many of them are frequently manufactured from raw materials imported at zero duty rates, whereas milk products have a higher production cost which is dictated by the need to safeguard agricultural producer incomes;

Whereas it is essential for the Commission to follow closely developments in the market for milk products and competing substitute products and to report back to the Council;

Whereas, pending the report from the Commission, Member States having already taken national measures to curb the manufacture and marketing of these products on their territory must maintain their regulations, in compliance with the general rules of the Treaty, until the end of the fifth 12-month period of application of the supplementary levy in the milk sector,

HAS ADOPTED THIS REGULATION:

Article 1

1. This Regulation shall apply to foodstuffs intended for human consumption which are marketed in the Community.
2. For the purposes of this Regulation:
 - (a) 'marketing' shall mean holding or display with a view to sale, offering for sale, sale, delivery or any other manner of placing on the market;
 - (b) 'designation' shall mean the name used at all stages of marketing.

Article 2

1. The term 'milk' shall mean exclusively the normal mammary secretion obtained from one or more milkings without either addition thereto or extraction therefrom.

However, the term 'milk' may be used:

- (a) for milk treated without altering its composition, or for milk the fat content of which has been standardized under Council Regulation (EEC) No 1411/71 of 29 June 1971 laying down additional

rules on the common organization of the market in milk and milk products for products falling within CCT heading No 04.01 ⁽¹⁾, as last amended by Regulation (EEC) No 566/76 ⁽²⁾;

- (b) in association with a word or words to designate the type, grade, origin and/or intended use of such milk or to describe the physical treatment or the modification in composition to which it has been subjected, provided that the modification is restricted to an addition and/or withdrawal of natural milk constituents.

2. For the purposes of this Regulation, 'milk products' shall mean products derived exclusively from milk, on the understanding that substances necessary for their manufacture may be added provided that those substances are not used for the purpose of replacing, in whole or in part, any milk constituent.

The following shall be reserved exclusively for milk products:

— the designations listed in the Annex hereto,

— designations or names within the meaning of Article 5 of Council Directive 79/112/EEC of 18 December 1978 on the approximation of the laws of the Member States relating to the labelling, presentation and advertising of foodstuffs for sale to the ultimate consumer ⁽³⁾, as last amended by Directive 85/7/EEC ⁽⁴⁾, actually used for milk products.

3. The term 'milk' and the designations used for milk products may also be used in association with a word or words to designate composite products of which no part takes or is intended to take the place of any milk constituent and of which milk or a milk product is an essential part either in terms of quantity or for characterization of the product.

4. The origin of milk and milk products to be defined in accordance with the procedure referred to in Article 30 of Regulation (EEC) No 804/68 must be stated if it is not bovine.

Article 3

1. The designations referred to in Article 2 may not be used for any product other than those referred to in that Article.

However, this provision shall not apply to the designation of products the exact nature of which is clear from traditional usage and/or when the designations are clearly used to describe a characteristic quality of the product.

2. In respect of a product other than those described in Article 2, no label, commercial document, publicity material or any form of advertising (as defined in Article 2 (1) of Directive 84/450/EEC ⁽⁵⁾) or any form of presentation, may be used which claims, implies or suggests that the product is a dairy product.

However, in respect of a product which contains milk or milk products, the designation 'milk' or the designations referred to in the second subparagraph of Article 2 (2) may be used only to describe the basic raw materials and to list the ingredients in accordance with Directive 79/112/EEC.

Article 4

1. Member States shall send the Commission by 1 October 1987 an indicative list of the products which they regard as corresponding in their territory to the products referred to in the second subparagraph of Article 3 (1).

Member States shall, where necessary, make additions to this list subsequently.

2. In accordance with the procedure laid down in Article 30 of Regulation (EEC) No 804/68, the Commission shall:

- (a) adopt the detailed rules for the application of this Regulation;
- (b) draw up and, where necessary, supplement the list of the products referred to in the second subparagraph of Article 3 (1) on the basis of the lists sent to it by the Member States;
- (c) make additions, where necessary, to the list of designations given in the Annex hereto.

3. Each year before 1 October and for the first time before 1 October 1988, the Member States shall report to the Commission on developments in the market in milk products and competing products in the context of the implementation of this Regulation so that the Commission is in a position to report to the Council by 1 March of the ensuing year.

Article 5

Member States may, until the end of the fifth period of application of Article 5c of Regulation (EEC) No 804/68 and in compliance with the general provisions of the Treaty, maintain their national regulations which

restrict the manufacture and marketing in their territory of products not fulfilling the conditions referred to in Article 2 of this Regulation.

Article 6

This Regulation shall enter into force on 1 July 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

amending Regulation (EEC) No 857/84 adopting general rules for the application of the levy referred to in Article 5c of Regulation (EEC) No 804/68 in the milk and milk products sector

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products ⁽¹⁾, as last amended by Regulation (EEC) No 773/87 ⁽²⁾, and in particular Article 5c (6)

Having regard to the proposal from the Commission,

Whereas Regulation (EEC) No 1336/86 ⁽³⁾, as last amended by Regulation (EEC) No 776/87 ⁽⁴⁾, introduced a Community scheme for the definitive discontinuation of milk production; whereas Article 4 (1) (a) of Regulation (EEC) No 857/84 ⁽⁵⁾, as last amended by Regulation (EEC) No 774/87 ⁽⁶⁾, provides for a national scheme for the discontinuation of milk production; whereas, in cases where the producer may have been unable to take advantage of either of these two schemes and in order not to impede the restructuring process, provision should be made for a subsidiary arrangement for the permanent discontinuation of milk production and the reallocation of the quantities thus freed,

HAS ADOPTED THIS REGULATION:

Article 1

Article 4 of Regulation (EEC) No 857/84 shall be amended as follows:

(1) The following point shall be added to paragraph 1:

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

(d) determine the regions and collecting areas where the producers referred to in Article 3 (2) and points (b) and (c) of this paragraph may obtain, in return for payment, and on the basis of objective criteria, at the beginning of a 12 month period, the reallocation of quantities freed, at the end of the preceding 12 month period, by producers who have not made use of the Community scheme for the definitive discontinuation of milk production provided for in Regulation (EEC) No 1336/86 or of the national scheme provided for in Article 4 (1) (a) of this Regulation and who undertake to discontinue all milk production in return for compensation which shall be equivalent in amount to the payment referred to above, and which shall be paid in one or more annual instalments; this amount:

- shall be less than the compensation amount paid pursuant to Regulation (EEC) No 1336/86,
- may vary, within the limit fixed in the first indent, so as to take account of the restructuring of milk production at the national or regional level or at that of the collecting areas.

(2) Paragraph 2 shall be replaced by the following:

'2. The reference quantities freed pursuant to paragraphs 1 (a) and (d) shall, as necessary, be added to the reserve referred to in Article 5.'

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

COUNCIL REGULATION (EEC) No 1900/87

of 2 July 1987

amending Regulation (EEC) No 2727/75 on the common organization of the market in cereals

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

HAS ADOPTED THIS REGULATION:

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission ⁽¹⁾,

Having regard to the opinion of the European Parliament ⁽²⁾,

Having regard to the opinion of the Economic and Social Committee ⁽³⁾,

Whereas under Article 4 (5) of Regulation (EEC) No 2727/75 ⁽⁴⁾, as last amended by Regulation (EEC) No 1579/86 ⁽⁵⁾, the co-responsibility levy is to be collected at the following stages: first processing, intervention buying or export; whereas in order to take into account difficulties that have arisen in the application of this mechanism, and pending a report on the functioning of the said levy, that provision should be provisionally amended, by providing, for the 1987/88 marketing year, for the possibility of also collecting the said levy when cereals are put on the market by the producers, whilst avoiding any distortion of competition;

Whereas the difficulties which, moreover, have led to small producers being granted aid in the form of compensation for the co-responsibility levy still obtain; whereas Member States which have already applied the provision in question during the 1986/87 marketing year should, therefore, be authorized to make use of it again for the 1987/88 marketing year;

Whereas stabilization of the conditions on the cereals market can only be achieved by increasing restrictions on recourse to intervention; whereas to that end, provision should be made firstly that no buying-in may be carried out if market prices in certain areas and for a certain period are lower than the intervention price; whereas, to the same end, provision should, in addition, be made that the prices at which the intervention agencies buy in are at a lower level than the intervention price,

Article 1

Regulation (EEC) No 2727/75 is hereby amended as follows:

(1) In Article 4:

— the following subparagraph shall be added to paragraph 5:

'However, at their request, Member States may, for the 1987/88 marketing year, be authorized to collect the co-responsibility levy when cereals are put on the market by the producers.'

— the first indent of paragraph 7 shall be replaced by the following:

'— the definition of the first processing and that of being put on the market.'

(2) In Article 4a (4), the subparagraph shall be replaced by the following:

'4. During the 1987/88 marketing year, Member States which granted aid to small producers during the previous marketing year in the form of compensation for the co-responsibility levy, may continue to grant such aid in that form, under conditions to be determined in accordance with the procedure laid down in paragraph 5.'

(3) In Article 6 (1) shall be replaced by the following:

'1. Without prejudice to the provisions of Article 5, the intervention prices, the buying-in prices referred to in Article 7 (4), the target prices and the threshold prices shall be the subject of monthly increases, phased over all or part of the marketing year.'

(4) Article 7 shall be replaced by the following:

Article 7

1. Where, during a certain period, the market price for common wheat, durum wheat, rye, barley, maize and sorghum is, in certain representative export ports, lower than the intervention price, a decision shall be taken that, under the procedure laid down in Article 26, the intervention agencies shall buy in the quantities offered them, provided that the offers comply with conditions, in particular in respect of quantity and quality, to be determined.

For the application of the first subparagraph:

- the market price in the ports shall be corrected by a flat-rate amount representing the forwarding costs between the principal zones of production and those ports,
- common fodder wheat shall be differentiated from common wheat for which the intervention price is fixed. In that case the intervention price shall be reduced by the amount fixed for that purpose pursuant to the third indent of paragraph 7.

2. The buying-in referred to in paragraph 1 may only take place during the following periods:

- from 1 August to 31 May with regard to Italy, Spain, Greece and Portugal,
- from 1 October to 31 May with regard to the other Member States.

3. Cessation of buying in for intervention shall be decided upon in accordance with the procedure laid down in Article 26, where the cereal market prices in question in the zones referred to in paragraph 1 are, during a period to be determined, above the intervention price.

4. The buying-in referred to in paragraph 1 shall be carried out on the basis of a price equal to 94 % of the intervention price for the cereals in question, as altered by any price increase or reduction fixed pursuant to Article 3 or paragraph 7 of this Article, irrespective of the agency to which the cereals are offered under the conditions adopted pursuant to paragraphs 6 and 7 hereof.

5. Under the conditions adopted pursuant to paragraphs 6 and 7, the intervention agencies shall offer for sale, for export to third countries or for supply to the internal market, the product bought in pursuant with paragraph 1.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

6. The Council shall, acting by a qualified majority on a proposal from the Commission, adopt the general rules governing intervention.

7. Detailed rules for the application of this Article shall be fixed in accordance with the procedure laid down in Article 26 and in particular with regard to:

- the representative ports, the forwarding costs and the period to be taken into consideration for the establishment of the market prices,
- the minimum quality and quantity required at intervention for each cereal and in addition for durum wheat, the technological qualities which that cereal must satisfy,
- the scales of price increases and reductions applicable to intervention, including a special reduction applicable to common fodder wheat,
- the specific quality criteria with which common wheat and rye, both of breadmaking quality, must comply in order to be able to benefit from the special price increase provided for in Article 3 (1),
- the procedures and conditions for taking over by the intervention agencies,
- the procedures and conditions for disposal by the intervention agencies.

5. Article 10 (3) shall be replaced by the following:

'3. The amount of aid shall be fixed in accordance with the procedure laid down in Article 43 (2) of the Treaty.'

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 July 1987.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the Act of Accession of Spain and Portugal, and in particular Article 89 (1) thereof,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals ⁽¹⁾, as last amended by Regulation (EEC) No 1900/87 ⁽²⁾, and in particular Article 3 (5) thereof,

Having regard to the proposal from the Commission ⁽³⁾,

Having regard to the opinion of the European Parliament ⁽⁴⁾,

Having regard to the opinion of the Economic and Social Committee ⁽⁵⁾,

Whereas the markets and prices policy, based on modern farms, is the main instrument of the incomes policy in agriculture; whereas full advantage cannot be drawn from such a policy unless it is integrated into the common agricultural policy as a whole, including a dynamic social and structural policy and the application of the rules on competition contained in the Treaty;

Whereas, in many cases, surpluses can no longer be disposed of on normal terms either inside or outside the Community; whereas, in order to reduce the cost to the budget of disposing of surpluses on markets of third countries and to encourage greater consumption within the Community, the restrictive price policy should continue to be applied; whereas this objective can be attained, taking into account the new intervention arrangements, by maintaining, for the 1987/88

marketing year, the intervention price for common wheat, barley, rye, maize and sorghum applied during the previous marketing year;

Whereas, as part of a quality policy, production of common wheat of higher breadmaking quality and production of rye of breadmaking quality should be supported; whereas, accordingly, the special premium for common wheat and of rye, both of breadmaking quality should be left unaltered;

Whereas in 1986/87 the Council began a process of aligning the intervention price of durum wheat on that of common wheat; whereas in view of, on the one hand, the present ratio between the prices of those cereals and, on the other, the imbalance recorded on the durum wheat market, it is advisable to pursue that process; whereas, accordingly, the intervention price of durum wheat should again be reduced; whereas, however, in order to improve that cereal's fluidity on the Community market, the target price should remain unchanged;

Whereas application of Article 68 of the Act of Accession of Spain and Portugal has meant that prices in Spain differ from the common prices; whereas, pursuant to Article 70 (1) of the Act of Accession, Spanish prices should be aligned with common prices each year at the start of the marketing year; whereas, as a result of applying the criteria for this alignment, Spanish prices are fixed at the level set out below,

HAS ADOPTED THIS REGULATION:

Article 1

For the 1987/88 marketing year, the prices applicable in the cereals sector shall be as indicated in the Annex.

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 July 1987.

fixing for the 1987/88 marketing year the amount of the aid for durum wheat

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the Act of Accession of Spain and Portugal, and in particular Article 89 (1) thereof,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals⁽¹⁾, as last amended by Regulation (EEC) No 1900/87⁽²⁾, and in particular Article 10 (3) thereof,

Having regard to the proposal from the Commission⁽³⁾,

Having regard to the opinion of the European Parliament⁽⁴⁾,

Having regard to the opinion of the Economic and Social Committee⁽⁵⁾,

Whereas the purpose of the aid for durum wheat is to ensure a fair standard of living for farmers in regions of the Community where such production constitutes a traditional and important part of agricultural production; whereas these areas were specified by Council Regulation (EEC) No 3103/76 of 16 December 1976 on aid for durum wheat⁽⁶⁾, as last amended by Regulation

(EEC) No 1583/86⁽⁷⁾; whereas, to cushion the impact of the reduction in the intervention price for durum wheat on producers' incomes, the aid for the 1987/88 marketing year should be increased;

Whereas the rules regarding the alignment of aid as laid down in Article 79 (2) of the Act of Accession mean that for Spain the amount of aid to be fixed should be that laid down in this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

For the 1987/88 marketing year, the aid for durum wheat referred to in Article 10 of Regulation (EEC) No 2727/75 is hereby fixed for the regions listed in the Annex to Regulation (EEC) No 3103/76 at:

- 121,80 ECU per hectare for the Community of Ten, and
- 33,85 ECU per hectare for Spain.

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 July 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COUNCIL REGULATION (EEC) No 1905/87

setting, for the 1987/88 cereals marketing year, the minimum price for potatoes to be paid by the starch manufacturer to the potato producer

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals ⁽¹⁾, as last amended by Regulation (EEC) No 1900/87 ⁽²⁾, and in particular Article 11 (a) (2) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 1008/86 of 25 March 1986 laying down detailed rules for production refunds applicable to potato starch ⁽³⁾ requires that the Council should fix a minimum price for potatoes used for the manufacture of starch, to be paid on a 'factory gate' basis by the starch manufacturer to the potato producer; whereas qualification for the premium payable to manufacturers of potato starch is conditional on the payment of this minimum price;

Whereas the supply prices of raw materials for the manufacture of starch should remain linked in order to maintain equality of competition between the various starch industries,

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

HAS ADOPTED THIS REGULATION:

Article 1

1. The minimum price for potatoes, to be paid by the manufacturer of potato starch to the potato producer for the quantity of potatoes required to manufacture one tonne of potato starch, on a 'factory gate' basis, shall be 272,93 ECU for the 1987/88 cereals marketing year.

2. The price referred to in paragraph 1 shall be adjusted according to the starch content of the potatoes.

Article 2

The detailed rules for application of this Regulation shall be adopted in accordance with the procedure provided for in Article 26 of Council Regulation (EEC) No 2727/75.

Article 3

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 July 1987.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals⁽¹⁾, as last amended by Regulation (EEC) No 1900/87⁽²⁾, and in particular Article 14 (3) thereof,Having regard to the proposal from the Commission⁽³⁾,

Whereas Council Regulation (EEC) No 2744/75 of 29 October 1975 on the import and export system for

products processed from cereals and from rice⁽⁴⁾, as last amended by Regulation (EEC) No 1588/86⁽⁵⁾, laid down the components to be used for calculating the levy applicable to imports of cereal brans with special provisions as from the 1982/83 marketing year;

Whereas these temporary provisions currently in force have served to stabilize bran imports; whereas it is therefore appropriate to make them permanent;

Whereas Regulation (EEC) No 2744/75 should be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

That part of Annex I to Regulation (EEC) No 2744/75 relating to heading No 23.02 of the Common Customs Tariff reads as follows:

COUNCIL REGULATION (EEC) No 1907/87

of 2 July 1987

amending Regulation (EEC) No 1418/76 on the common organization of the market in rice

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission (1),

Having regard to the opinion of the European Parliament (2),

Having regard to the opinion of the Economic and Social Committee (3),

Whereas in order to give to the market in rice itself a more active and direct role in the quantitative pattern of supply with regard to demand, the role of intervention should be restricted to that of a simple safety net; whereas from that viewpoint the intervention price should function as a trigger threshold for buying in for intervention as soon as the prices recorded on representative markets fall during a certain period below that level; whereas the buying-in price paid for paddy rice delivered for intervention should be situated at a level below that of the fixed intervention price;

Whereas, as regard the rice supply situation in the Community, there is, on the one hand, a shortage of certain types of rice for which demand exists on the part of some consumers and, on the other hand, a surplus of other types of rice;

Whereas the varieties for which demand exists are of the indica type or profile which normally have lower crop yields than those of the varieties that are traditionally grown; whereas appropriate measures should therefore be taken to encourage varietal conversion by granting crop aids;

Whereas, on account of the characteristics of the rice produced in the Community, much of this rice is unable to find an outlet on the Community market; whereas there is therefore a risk of large quantities of this product being bought into intervention at the beginning of the marketing year; whereas, to encourage growers to sow varieties which are more in line with market requirements, the amounts taken over by intervention agencies should be restricted for a limited and specified period of the marketing year;

Whereas under Article 18 of Regulation (EEC) No 1418/76 (4), as last amended by Regulation (EEC) No 1449/86 (5), it is possible to disallow in whole or in part the use of inward processing arrangements for products listed in Article 1 of that Regulation that are to be turned into products as specified at point (c) of Article 1 (1) thereof;

Whereas given the actual situation for rice this provision is inadequate; whereas the effectiveness of the common organization of the market may in particular be jeopardized by the manufacture of products as specified at point (a) of Article 1 (1) of Regulation (EEC) No 1418/76; whereas the scope of the abovementioned Article 18 should therefore be widened,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 1418/76 is hereby amended as follows:

1. Article 5 is replaced by the following:

Article 5

1. Where, during a certain period, the market price for paddy rice is, in representative zones, lower than the intervention price, a decision shall be made that, under the procedure laid down in Article 27, the intervention agencies shall buy in the quantities of paddy rice offered them, provided that the offers comply with conditions, in particular in respect of quantity and quality, to be determined in accordance with paragraph 6.

Buying-in may only take place during the period from 1 December to 31 July.

2. The buying-in referred to in paragraph 1 shall be carried out on the basis of a price equal to 94 % of the intervention price applicable for the marketing centre at which the paddy rice is offered under the conditions adopted pursuant to paragraphs 5 and 6.

If the quality of the paddy rice differs from the standard quantity for which the intervention price was fixed, the latter shall be adjusted by the application of price increases or reductions.

3. Cessation of buying-in for intervention shall be decided upon in accordance with the procedure laid down in Article 27, where the paddy rice market price in the zones referred to in paragraph 1 are, during a period to be determined, above the intervention price.

4. Under the conditions adopted pursuant to paragraphs 5 and 6, the intervention agencies shall offer for sale, for export to third countries or for supply to the internal market, the paddy rice bought in accordance with paragraph 1.

5. The Council shall, by a qualified majority, acting on a proposal from the Commission adopt the general rules governing intervention.

6. Detailed rules of application of this Article shall be adopted in accordance with the procedure laid down in Article 27 and in particular with regard to:

- the representative zones to be taken into consideration for the establishment of the market prices,
- the minimum quality and quantity required for intervention,
- the price increases and reductions applicable to intervention,
- the procedures and conditions for taking over by the intervention agencies,
- the procedures and conditions for disposal by the intervention agencies.

2. The following Article is inserted:

Article 8a

1. An aid shall be granted for the production of certain varieties of rice of the indica type or profile grown in those areas of the Community where rice of

the japonica type forms a traditionally large part of rice production.

2. The amount of the aid shall be fixed per hectare of the areas sown and harvested.

The aid shall only be granted for certain varieties of rice of the indica type or profile to be defined.

3. The amount of the aid shall be fixed in accordance with the procedure laid down in Article 43 (2) of the Treaty.

4. The Council, acting by a qualified majority on a proposal from the Commission, shall adopt general rules for the application of this Article and, in particular, the areas of production referred to in paragraph 1 and the morphological characteristics of the rice that may qualify for this aid.

5. Detailed rules for the application of this Article shall be adopted in accordance with the procedure laid down in Article 27.

3. Article 18 is replaced by the following:

Article 18

To the extent necessary for the proper working of the common organization of the market in rice, the Council, acting by a qualified majority on a proposal from the Commission, may prohibit in whole or in part the use of inward processing arrangements in respect of products listed in Article 1.

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 September 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

amending Regulation (EEC) No 1424/76 laying down general rules for intervention on the market in rice

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

HAS ADOPTED THIS REGULATION:

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice ⁽¹⁾, as last amended by Regulation (EEC) No 1907/87 ⁽²⁾, and in particular Article 5 (5) thereof,

Having regard to the proposal from the Commission,

Whereas Article 5 (2) of Regulation (EEC) No 1418/76 lays down that the intervention agencies shall buy in on the basis of a price equal to 94 % of the intervention price; whereas Regulation (EEC) No 1424/76 ⁽³⁾ should be adapted accordingly,

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

Article 1

Article 2 (2) of Regulation (EEC) No 1424/76 is replaced by the following:

'2. If the intervention agency does not take over the paddy rice at the marketing centre specified by the seller but at the place where the paddy rice is located, the price to be paid shall be equal to the buying-in price referred to in Article 5 (2) of Regulation (EEC) No 1418/76 valid for the marketing centre indicated by the seller, less the most advantageous transport costs between the place where the paddy rice is when the offer is made and the marketing centre. These costs shall be determined by the intervention agency.'

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 September 1987.

fixing rice prices for the 1987/88 marketing year

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the Act of Accession of Spain and Portugal, and in particular Article 89 (1) thereof,

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice ⁽¹⁾, as last amended by Regulation (EEC) No 1907/87 ⁽²⁾, and in particular Article 3 (3) thereof,

Having regard to the proposal from the Commission ⁽³⁾,

Having regard to the opinion of the European Parliament ⁽⁴⁾,

Having regard to the opinion of the Economic and Social Committee ⁽⁵⁾,

Whereas the markets and prices policy, based on modern farms, is the main instrument of the incomes policy in agriculture; whereas full advantage cannot be drawn from such a policy unless it is integrated into the common agricultural policy as a whole, including a dynamic social and structural policy and the application of the rules on competition contained in the Treaty;

Whereas the intervention price for paddy rice must be fixed at a rate which takes account of the policy in respect of rice production, with a view to the uses to which it is put;

Whereas the target price for husked rice must be derived from the intervention price for paddy rice, in accordance with the criteria set out in Article 4 (3) of Regulation (EEC) No 1418/76;

Whereas, for the products referred to in this Regulation, the application of the criteria for the fixing of the different prices and the application of the measures provided for in respect of the exchange rates to be applied in agriculture entail fixing those prices at the levels indicated below;

Whereas, pursuant to Article 68 of the Act of Accession of Spain and Portugal, prices in Spain were set at a level differing from that of the common prices; whereas, pursuant to Article 70 (1) of the Act, these prices should be aligned with the common prices in annual steps at the beginning of each marketing year; whereas the rules on this alignment laid down give the Spanish prices set below,

HAS ADOPTED THIS REGULATION:

Article 1

For the 1987/88 marketing year, rice prices are as follows:

1. Community of Ten:
 - (a) intervention price, paddy rice: 314,19 ECU per tonne;
 - (b) target price, husked rice: 548,37 ECU per tonne.
2. Spain:
 - (a) intervention price, paddy rice: 259,76 ECU per tonne;
 - (b) target price, husked rice: 548,37 ECU per tonne.

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 September 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

fixing the monthly price increases for paddy rice and husked rice for the 1987/88 marketing year

Having regard to the Treaty establishing the European Economic Community,

Having regard to Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice ⁽¹⁾, as last amended by Regulation (EEC) No 1907/87 ⁽²⁾, and in particular Article 7 (2) thereof,

Having regard to the proposal from the Commission ⁽³⁾,

Whereas, when the number and amount of the monthly increases and the first month during which these increases are to apply are fixed, account should be taken of the storage costs and financing charges for storing rice in the Community and of the need to ensure that the disposal of stocks of rice conforms to market requirements,

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 2 July 1987.

HAS ADOPTED THIS REGULATION:

Article 1

1. For the 1987/88 marketing year, the amount of each of the monthly increases provided for in Article 7 (1) of Regulation (EEC) No 1418/76 is:

- 3,14 ECU per tonne for the intervention price,
- 3,93 ECU per tonne for the target price.

2. The monthly increases apply to the intervention price from 1 January 1988 to 1 July 1988, the price thus obtained for July 1988 remaining valid until 31 August 1988.

The monthly increases apply to the target price from 1 October 1987 to 1 July 1988, the price thus obtained for the month of July 1988 remaining valid until 31 August 1988.

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 September 1987.

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice ⁽¹⁾, as last amended by Regulation (EEC) No 1907/87 ⁽²⁾, and in particular Article 8 (a) (2) thereof,Having regard to the proposal from the Commission ⁽³⁾,Having regard to the opinion of the European Parliament ⁽⁴⁾,Having regard to the opinion of the Economic and Social Committee ⁽⁵⁾,

Whereas the objective of the production aid is to encourage varietal conversion of rice production to certain types of rice for which greater demand exists on

the Community market; whereas the varieties for which demand exists normally have lower crop yields than those of the varieties that are traditionally grown;

Whereas the production aid must be fixed at a level which enables the lower revenue resulting from the decreased yields to be offset,

HAS ADOPTED THIS REGULATION:

Article 1

The production aid for certain varieties of rice sown in 1987/88, referred to in Annex 8a of Regulation (EEC) No 1418/76 is 330,0 ECU per hectare.

*Article 2*This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 September 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
