COUNCIL REGULATION (EEC) No 3904/87

of 22 December 1987

amending Regulation (EEC) No 804/68 on the common organization of the market in milk and milk products

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 42 and 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament (1),

Having regard to the opinion of the Economic and Social Committee (2),

Whereas the Community is a Contracting Party to the International Convention on the Harmonized Commodity Description and Coding System, hereinafter referred to as the 'harmonized system', which replaces the Convention of 15 December 1950 on Nomenclature for the Classification of Goods in Customs Tariffs;

Whereas Council Regulation (EEC) No 2658/87 (3) established, from 1 January 1988, a combined goods nomenclature based on the harmonized system which will meet the requirements both of the Common Customs Tariff and of the external trade statistics of the Community;

Whereas, as a result, it is necessary to express the descriptions of goods and tariff heading numbers which

appear in Regulation (EEC) No 804/68 (4), as last amended by Regulation (EEC) No 773/87 (5), according to the terms of the combined nomenclature, based on the harmonized system;

Whereas numerous regulations in the milk and milk products sector must be adapted in the light of the new nomenclature; whereas, under Article 15 of Regulation (EEC) No 2658/87, the changes made may be of a technical nature only; whereas, accordingly, a provision should be introduced whereby all other adjustments to Council or Commission regulations on the common organization of the market in the milk products sector should be made in accordance with the procedure laid down in Article 30 of Regulation (EEC) No 804/68, provided that such adjustments are required solely as a result of the introduction of the harmonized system,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 804/68 is hereby amended as follows:

1. Article 1 is replaced by the following:

'Article 1

The common organization of the market in milk and milk products shall cover the following products:

2. Article 4 is replaced by the following:

'Article 4

The Council, acting in accordance with the voting procedure laid down in Article 43 (2) of the Treaty on a proposal from the Commission, shall fix each year for the following milk year Community threshold prices for certain of the products listed in Article 1, hereinafter called "pilot products". The threshold prices shall be fixed so that, account being taken of the protection required for the Community processing industry, the prices of imported milk products shall correspond to the level of the target price for milk.'

- 3. Article 13 (2) is replaced by the following:
 - '2. Member States may issue a licence to any applicant irrespective of the place of his establishment in the Community.

The licence shall be valid for a transaction carried out in the Community from a date to be fixed by the Council, acting in accordance with the voting procedure laid down in Article 43 (2) of the Treaty on a proposal from the Commission. The issue of such licence shall be conditional on the lodging of a deposit guaranteeing that exportation is effected during the period of validity of the licence; the deposit shall be forfeited in whole or in part if the transaction is not effected, or is only partially effected, within that period.'

- 4. Article 17 (1) is replaced by the following:
 - '1. To the extent necessary to enable the products listed in Article 1 to be exported either in the unaltered state or in the form of goods listed in the Annex in the case of products listed in Article 1 (a), (b), (c), (d), (e) and (g), on the basis of the prices for those products in international trade, the difference between those prices and prices in the Community may be covered by an export refund.'
- 5. The final subparagraph of Article 17 (2) is replaced by the following:

'The refund may be fixed by tender for skimmed-milk powder falling within subheading 0402 10 19 of the combined nomenclature exported in bulk and for butter falling within heading No 0405 00 thereof exported in bulk.'

- 6. Article 26 (1) is replaced by the following:
 - '1. Subject to the conditions laid down in paragraphs 3 and 4, Community aid shall be granted for supplying to pupils in educational establishments certain processed milk products falling within heading Nos 0401 and 0403, subheading 0404 90 and heading No 0406 or subheading 2202 90.'
- 7. The following paragraph is added to Article 26:
 - '5. Paragraphs 1 to 4 may be applied, through the agency of charitable organizations recognized by the Member State concerned, or if no recognition has been granted in that Member State to such organizations, by the Commission to those persons most in need.

In such cases, the aid

 shall be granted so as to permit the free distribution of the products referred to in paragraph 1,

- may also be granted for the free distribution of products falling within subheading 0405 00 of the combined nomenclature.'
- 8. The Annex is replaced by the Annex to this Regulation.

Article 2

The Commission, in accordance with the procedure provided for in Article 30 of Regulation (EEC) No 804/68, shall make the necessary adaptations to Council or Commission acts concerning the common organization of the market in milk and milk products which result from the application of Article 1.

Article 3

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

Article 1 shall apply with effect from 1 January 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

amending Regulation (EEC) No 805/68 on the common organization of the market in beef and veal

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 42 and 43 thereof.

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament (1),

Having regard to the opinion of the Economic and Social Committee (2),

Whereas the Community is a Contracting Party to the International Convention on the Harmonized Commodity Description and Coding System, hereinafter referred to as the 'harmonized system', which is intended to replace the Convention of 15 December 1950 on Nomenclature for the Classification of Goods in Customs Tariffs;

Whereas Council Regulation (EEC) No 2658/87 (³) established, from 1 January 1988, a combined goods nomenclature based on the harmonized system which will meet the requirements both of the Common Customs Tariff and of the external trade statistics of the Community;

Whereas, as a result, it is necessary to express the descriptions of goods and tariff heading numbers which appear in Regulation (EEC) No 805/68 (4), as last amended by Regulation (EEC) No 467/87 (5), according to the terms of the combined nomenclature based on the harmonized systems;

Whereas edible flours and meals of meat or meat offal may be classified, according to their essential character, in various subheadings of heading No 02.06 of the Common Customs Tariff at present in force; whereas, in the combined nomenclature, by way of simplification, a single subheading has been established to cover all edible flours and meals of meat or meat offal; whereas it is desirable that the said edible flours and meals of meat or meat offal be covered by Regulation (EEC) No 805/68;

Whereas certain homogenized preparations of meat, meat offal or blood, preparations of animal blood, and stuffed pasta containing more than 20 % by weight of sausages and the like, meat and meat offal, including fats, are classified in subheadings of heading No 16.02 of the Common Customs Tariff at present in force, which are covered by Regulation (EEC) No 805/68; whereas in the combined nomenclature, by way of simplification, single subheadings have been established for each of the aforementioned preparations; whereas it is desirable that the said preparations be covered by Council Regulation (EEC) No 2759/75 of 29 October 1975 on the common organization of the market in pigmeat (6), as last amended by Regulation (EEC) No 3906/87 (7); whereas, as a result, they should no longer be covered by Regulation (EEC) No 805/68;

Whereas numerous regulations in the beef and veal sector must be adapted in the light of the new nomenclature; whereas, under Article 15 of Regulation (EEC) No 2658/87, the changes made may be of a technical nature only; whereas, accordingly, a provision should be introduced whereby all other adjustments to Council or Commission regulations on the common organization of the market in beef and veal should be made in accordance with the procedure laid down in Article 27 of Regulation (EEC) No 805/68, provided that such adjustments are required solely as a result of the introduction of the harmonized systems,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 805/68 is hereby amended as follows:

- 1. Article 1 is amended as follows:
 - (a) Paragraph 1 is replaced by the following:
 - 1. The common organization of the market in beef and veal shall comprise a price and trading system and cover the following products:

- 4. The second subparagraph of Article 10 (2) is replaced by the following:

'The free-at-Community-frontier offer price shall be established by reference to the most representative purchasing possibilities, as regards quality and quantity, recorded over a period to be fixed preceding the determining of the basic levy, for bovine animals and for fresh and chilled meat of the types set out in subheadings 0201 10 and 0201 20 11 to 0201 20 59 of Section (a) of the Annex, taking into account *inter alia*:

- (a) the supply and demand situation;
- (b) the world market prices for frozen meat of a category which is competitive with fresh or chilled meat;
- (c) past experience.'
- 5. Article 11 is amended as follows:
 - (a) In paragraph 2, the introductory words are replaced by the following:
 - '2. The levy shall be determined for frozen meat of the types set out in subheadings 0202 10 00 and 0202 20 10 of Section (b) of the Annex, by reference to the difference between:'
 - (b) Paragraph 4 is replaced by the following:
 - '4. For frozen meat of the types set out in subheadings 0202 20 30, 0202 20 50, 0202 20 90, 0202 30 and for thick skirt and thin skirt of subheading 0206 29 91 of Section (b) of the Annex, the basic levy shall be equal to the basic levy determined for the product referred to in

paragraph 2, multiplied by a flat-rate coefficient fixed for each of the products in question.'

- 6. In Article 14 (1), the introductory words are replaced by the following:
 - '1. Frozen meat intended for processing and listed in Section (b) of the Annex under subheadings 0202 20 30, 0202 30 and thick skirt and thin skirt of subheading 0206 29 91 shall qualify, under the conditions laid down in this Article:'
- 7. The first and second indents of Article 16 (2) are replaced by the following:
 - '— products falling within heading No 0201 and subheading 0206 10 95 originating in and coming from non-member countries which, by reason of the length of the sea voyage involved, comply with an agreement concluded with the Community in this matter which provides for adequate safeguards,
 - products falling within heading No 0202 and subheading 0206 29 91 originating in and coming from non-member countries which comply with an agreement concluded with the Community in this matter which provides for adequate safeguards.'
- 8. The Annex is replaced by the Annex to this Regulation.

Article 2

The Commission, in accordance with the procedure provided for in Article 27 of Regulation (EEC) No 805/68, shall make the necessary adaptations to Council or Commission acts concerning the common organization of the markets in beef and veal which result from the application of Article 1.

Article 3

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

Article 1 shall apply with effect from 1 January 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Whereas Council Regulation (EEC) No 2658/87 (³) established, from 1 January 1988, a combined goods nomenclature based on the harmonized system which will meet the requirements both of the Common Customs Tariff and of the external trade statistics of the Community;

Whereas, as a result, it is necessary to express the descriptions of goods and tariff heading numbers which appear in Regulation (EEC) No 2759/75 (4), as last amended by Regulation (EEC) No 1475/86 (5), according to the terms of the combined nomenclature based, on the harmonized system;

Whereas certain edible flours and meals of meat or meat offal are classified in subheadings of heading No 02.06 of the Common Customs Tariff at present in force, which are covered by Regulation (EEC) No 2759/75; whereas, in the combined nomenclature based on the harmonized system, by way of simplification, a single subheading has been established to cover all edible flours and meals of meat or

meat offal; whereas it is desirable that the said flours and meals be covered by Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal (6), as last amended by Regulation (EEC) No 3905/87 (7); whereas, as a result, they should no longer be covered by Regulation (EEC) No 2759/75;

Whereas since pig fats from bones or waste are not listed in Annex II to the Treaty they are excluded from application of the provisions therein concerning agriculture, whilst lard and other pig fats obtained from other parts of the animal are subject thereto; whereas in the harmonized system fats from bones or waste are classified in the same heading of the nomenclature as lard and other pig fats; whereas, because of the technical development in the processing of animal fats, it is impossible to distinguish between fats from bones or waste and lard and other fats obtained from swine; whereas measures adopted for lard and other pig fats in respect of trade with third countries and the marketing rules adopted for lard and other pig fats should therefore be extended to fats from bones or waste of swine;

Whereas homogenized preparations of meat, meat offal or blood, preparations of animal blood, and stuffed pasta containing more than 20% by weight of sausages and the like, meat and meat offal, including fats, may be classified, according to their essential character, in various subheadings of heading No 16.02 of the Common Customs Tariff at present in force; whereas, in the combined nomenclature, single subheadings have been established to cover all homogenized preparations, preparations of blood of any animal and stuffed pasta containing more than 20% by weight of sausages and the like, meat and meat offal, including fats of any kind or origin; whereas it is desirable that the said preprations falling within the aforementioned subheadings of the combined nomenclature be covered by Regulation (EEC) No 2759/75;

Whereas the formulation of the description of goods and tariff numbers in terms of the combined nomenclature implies, *inter alia*, the adaptation of Regulation (EEC) No 2766/75 (8), as last amended by Regulation (EEC) No 1905/83 (9), as well as of Council Regulation (EEC) No 2767/75 of 29 October 1975 laying down general rules for the system of 'pilot products and derived products'

enabling additional amounts to be fixed for pigmeat (¹), as last amended by Regulation (EEC) No 1906/83 (²); whereas Regulation (EEC) No 2767/75 no longer reflects economic reality as regards the fixing of additional amounts; whereas it is appropriate, consequently, to fix sluice-gate prices for all products covered by Regulation (EEC) No 2759/75 and to repeal Regulation (EEC) No 2767/75;

Whereas numerous regulations in the pigmeat sector must be adapted to take account of use of the new nomenclature; whereas, under Article 15 of Regulation (EEC) No 2658/87, the changes made may be of a technical nature only; whereas, accordingly, a provision should be introduced whereby all other adjustments to Council and Commission regulations on the common organization of the market in pigmeat should be made in accordance with the procedure laid down in Article 24 of Regulation (EEC) No 2759/75, provided

Whereas Council Regulation (EEC) No 2658/87 (3) established, from 1 January 1988, a combined goods nomenclature based on the harmonized system which will meet the requirements both of the Common Customs Tariff and of the external trade statistics of the Community;

Whereas, as a result, it is necessary to express the descriptions of goods and tariff heading numbers which appear in Council Regulation (EEC) No 426/86 of 24 February 1986 on the common organization of the market in products processed from fruit and vegetables (4), as last amended by Regulation (EEC) No 1928/87 (5), according to the terms of the combined nomenclature, based on the harmonized system;

Whereas mixtures of dried fruits, or of dried fruits and nuts, may be classified, according to their essential character, in various subheadings of Chapter 8 of the Common Customs Tariff at present in force; whereas, in the combined nomenclature, by way of simplification, a single subheading has been established to cover all other mixtures of dried fruits and of dried fruits and nuts; whereas it is desirable that the said mixtures te covered by Regulation (EEC) No 426/86;

Whereas numerous regulations in the processed fruit and vegetables sector must be adapted to take account of use of the new nomenclature; whereas under Article 15 of Regulation (EEC) No 2658/87, the changes made may be of a technical nature only; whereas, accordingly, a provision should be introduced whereby all other adjustments to Council and Commission regulations on the common organization of the market in processed fruit and vegetables should be made in accordance with the procedure laid down in Article 22 of Regulation (EEC) No 426/86, provided that such adjustments are required solely as a result of the introduction of the harmonized system,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 426/86 is hereby amended as follows:

1. Article 1 is replaced by the following:

 - peaches preserved in syrup, falling within subheading 2008 70,
 - tomato juice falling within subheading 2009 50,
 - dried figs falling within subheading 0804 20 90;
- 15 July to 14 July for Williams pears preserved in syrup, falling within subheading 2008 40;
- d) 1 September to 31 August for:
 - dried grapes falling within subheading 0806 20,
 - prunes derived from dried 'prunes d'Ente' falling within subheading 0813 20 00.

The marketing year for other products shall be laid down, where required, in accordance with the procedure provided for in Article 22. Changes to be made to the marketing years as defined in the first subparagraph may be adopted in accordance with the same procedure.'

- 2. Article 10 (7) is replaced by the following:
 - '7. "Added sugars content" for the products listed in Annex III shall mean the reading obtained by using a refractometer, multiplied by 0,93 in the case of products falling within heading No 2008 with the exclusion of subheading 2008 11 10, 2008 91 00, 2008 99 85 and 2008 99 91 and by 0,95 in the case of other products and reduced by the figure appearing in column (2) of Annex III.'

- 3. Article 11 (1) is replaced by the following:
 - '1. A refund shall be granted to permit exports to non-member countries of:
 - white sugar and raw sugar falling within heading No 1701,
 - glucose and glucose syrup falling within subheadings 1702 30 51, 1702 30 59, 1702 30 91, 1702 30 99 and 1702 40 90,

used in the products listed in Article 1 (1) (b).

The refund fixed shall be granted on applicaiton.'

- 4. Article 17 (3) is replaced by the following:
 - '3. However, for citrus fruit juices falling within heading No 2009, with the exception of grapefruit juice, Member States may maintain the measures which were applicable until 1 January 1975 concerning imports of such products originating in non-member countries, but without making them more restrictive.'
- 5. Annexes I to IV are replaced by the Annex to this Regulation.

Article 2

The Commission, in accordance with the procedure provided for in Article 22 of Regulation (EEC) No 426/86, shall make the necessary adaptations to Council or Commission acts concerning the common organization of the market in processed fruit and vegetables which result from the application of Article 1.

Article 3

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

Article 1 shall apply with effect from 1 January 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community and in particular Articles 42 and 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament (1),

Having regard to the opinion of the Economic and Social Committee (2),

Whereas the Community is a Contracting Party to the International Convention on the Harmonized Commodity Description and Coding System, hereinafter referred to as the 'harmonized system', which is intended to replace the Convention of 15 December 1950 on Nomenclature for the Classification of Goods in Customs Tariffs;

Whereas Council Regulation (EEC) No 2658/87(3) established, from 1 January 1988, a combined goods nomenclature based on the harmonized system which will meet the requirements both of the Common Customs Tariff and of the external trade statistics of the Community;

Whereas, as a result, it is necessary to express the descriptions of goods and tariff heading numbers which appear in Regulation (EEC) No 1035/72 (4), as last amended by Regulation (EEC) No 2275/87 (5), according to the terms of the combined nomenclature, based on the harmonized system;

Whereas mixtures of nuts may be classified according to their essential character in various subheadings of Chapter 8 of the Common Customs Tariff at present in force; whereas, in the combined nomenclature, by way of simplification, a single subheading has been established to cover all mixtures of nuts; whereas it is desirable that the said mixtures be covered by Regulation (EEC) No 1035/72;

Whereas certain mixtures of dried fruits, or of dried fruits and nuts, are classified, according to their essential character, in subheadings of Chapter 8 of the Common Customs Tariff at present in force which are covered by Regulation (EEC) No 1035/72; whereas, in the combined nomenclature, by way of simplification, a single subheading has been established to cover all mixtures of dried fruits and of dried fruits and nuts; whereas it is desirable that the said mixtures be covered by Council Regulation (EEC) No 426/86 of 24 February 1986 on the common organization of the market in products processed from fruit and vegetables (6), as last amended by Regulation (EEC) No 3909/87 (7); whereas, as a result, they should no longer be covered by Regulation (EEC) No 1035/72;

Whereas numerous regulations in the fruit and vegetables sector must be adapted in the light of the new nomenclature; whereas, under Article 15 of Regulation (EEC) No 2658/87, the changes made may be of a technical nature only; whereas, accordingly, a provision should be introduced whereby all other adjustments to Council or Commission regulations on the common organization of the markets in fruit and vegetables should be made in accordance with the procedure laid down in Article 33 of Regulation (EEC) No 1035/72, provided that such adjustments are required solely as a result of the introduction of the harmonized system,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 1035/72 is hereby amended as follows:

Whereas, as a consequence, it is necessary to express the descriptions of goods and tariff heading numbers which appear in Council Regulation (EEC) No 827/68 (4), as last amended by Regulation (EEC) No 2966/80 (5), according to the terms of the combined nomenclature based on the harmonized system;
