COMMISSION REGULATION (EEC) No 127/88**of 19 January 1988****fixing the import levies on cereals and on wheat or rye flour, groats and meal**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals⁽¹⁾, as last amended by Regulation (EEC) 3989/87⁽²⁾, and in particular Article 13 (5) thereof,

Having regard to Council Regulation (EEC) No 1676/85 of 11 June 1985 on the value of the unit of account and the exchange rates to be applied for the purposes of the common agricultural policy⁽³⁾, as last amended by Regulation (EEC) No 1636/87⁽⁴⁾, and in particular Article 3 thereof,

Having regard to the opinion of the Monetary Committee,

Whereas the import levies on cereals, wheat and rye flour, and wheat groats and meal were fixed by Commission Regulation (EEC) No 4047/87⁽⁵⁾ and subsequent amending Regulations;

Whereas, if the levy system is to operate normally, levies should be calculated on the following basis:

— in the case of currencies which are maintained in relation to each other at any given moment within a band

of 2,25 %, a rate of exchange based on their central rate, multiplied by the corrective factor provided for in the last paragraph of Article 3 (1) of Regulation (EEC) No 1676/85,

— for other currencies, an exchange rate based on the arithmetic mean of the spot market rates of each of these currencies recorded for a given period in relation to the Community currencies referred to in the previous indent, and the aforesaid coefficient;

Whereas these exchange rates being those recorded on 18 January 1988;

Whereas the aforesaid corrective factor affects the entire calculation basis for the levies, including the equivalence coefficients;

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 4047/87 to today's offer prices and quotations known to the Commission that the levies at present in force should be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies to be charged on products listed in Article 1 (a), (b) and (c) of Regulation (EEC) No 2727/75 shall be as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 20 January 1988.

Whereas, if the levy system is to operate normally, levies should be calculated on the following basis:

- in the case of currencies which are maintained in relation to each other at any given moment within a band of 2,25 %, a rate of exchange based on their central rate, multiplied by the corrective factor provided for in the last paragraph of Article 3 (1) of Regulation (EEC) No 1676/85,
- for other currencies, an exchange rate based on the arithmetic mean of the spot market rates of each of

these currencies recorded for a given period in relation to the Community currencies referred to in the previous indent, and the aforesaid coefficient;

Whereas these exchange rates being those recorded on 18 January 1988;

Whereas, on the basis of today's cif prices and cif forward delivery prices, the premiums at present in force, which are to be added to the levies, should be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

1. The premiums referred to in Article 15 of Regulation (EEC) No 2727/75 to be added to the import levies fixed in advance in respect of cereals and malt coming from Portugal shall be zero.
2. The premiums referred to in Article 15 of Regulation (EEC) No 2727/75 to be added to the import levies fixed in advance in respect of cereals and malt coming from third countries shall be as set out in the Annex hereto.

THE COMMISSION OF THE EUROPEAN COMMUNITIES,
Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 569/86 of 25 February 1986 laying down general rules for the application of the supplementary trade mechanism (STM)⁽¹⁾, as last amended by Regulation (EEC) No 2297/86⁽²⁾, and in particular Article 7 thereof,

Having regard to Commission Regulation (EEC) No 574/86 of 28 February 1986 laying down detailed rules for the application of the supplementary trade mechanism (STM)⁽³⁾, as last amended by Regulation (EEC) No 2159/87⁽⁴⁾, and in particular Article 6 thereof,

days of January 1988, licences may, for certain products, be issued for the tonnages applied for and shall not be issued for the tonnages applied for in the case of other products,

HAS ADOPTED THIS REGULATION:

Article 1

Applications for STM licences, submitted during the first 10 days of January 1988 and notified to the Commission,

(a) shall be accepted for the tonnages applied for in the case of the following products:

meat of animals of the bovine species, frozen, and offal of animals of the bovine species;

(b) shall, in the case of the following products, be accepted up to the percentage shown:

fresh or chilled meat of animals of the bovine species :
1,028 %;

live animals of the bovine species, other than pure-bred breeding animals and animals for bull fights :
0,728 %.

COMMISSION REGULATION (EEC) No 133/88

of 19 January 1988

laying down protective measures on imports of hybrid maize for use as seed

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2358/71 of 26 October 1971 on the common organization of the market in seeds ⁽¹⁾, and in particular Article 7 (2) thereof,

Whereas, on 12 January 1988, the French Republic submitted to the Commission a request for the application of protective measures to imports into the Community of hybrid maize for use as seed; whereas the Commission has requested additional information regarding the type of measures desired by the French Government; whereas the reply to that question reached the Commission on 18 January and stated that a suitable measure should involve a measure suspending all imports of hybrid maize for use as seed under the so-called 'open market' system and the immediate convening of a working group with the task of determining the measures to be taken in forthcoming marketing years to enable the Community system for producing maize seed to be maintained;

Whereas the latter part of the French request comes within the normal management of the sector and therefore, irrespective of its validity, does not require immediate action in the way of protective measures;

Whereas, on the other hand, the data provided by the French authorities relating to the market situation for hybrid maize for use as seed show that Community production in the 1987/88 marketing year has fallen substantially after years of constant increase; whereas at the same time the quantities imported under contracts or freely have also increased substantially;

Whereas, therefore, while the trend in imports is in line with the trend in Community production, the Community market does not appear to be suffering from an imbalance; whereas, while imports in forthcoming months remain at the level reached last marketing year, the result for Community production in 1988/89 is a situation which is liable to jeopardize the objectives of Article 39 of the Treaty, particularly when it is considered that there appear to be substantial stocks of hybrid maize for use as seed on the Community market;

Whereas, according to information available, imports should be maintained at the level of the previous year, which could have a long-lasting effect on Community production; whereas, under those conditions, the Community market is liable to be seriously disturbed

owing to such imports; whereas, as a consequence, imports should be made subject to a surveillance system enabling the Commission to intervene at all times by virtue of its market management responsibilities;

Whereas the most suitable measure in this respect involves introducing a period of time for reflection between the date of the lodging of the application for an import licence and its issue in order to enable, where necessary, the Commission to take the measures required in the interim,

HAS ADOPTED THIS REGULATION:

Article 1

By way of derogation from Article 19 (1) of Commission Regulation (EEC) No 3183/80 ⁽²⁾, import licences for hybrid maize for use as seed shall be issued only on the fifth working day following the date of lodging of the application provided special measures are not taken during that time.

Article 2

1. The Member States shall notify the Commission:
 - of quantities of hybrid maize for use as seed for which import licences have been applied for,
 - of the country of origin,

broken down in accordance with the combined nomenclature (CN codes 1005 10, 11, 13, 15, 19). Such notification shall take place at the following intervals:

- each Wednesday for applications lodged on Monday and Tuesday,
- each Friday for applications lodged on Wednesday and Thursday,
- each Monday for applications lodged on Friday of the previous week.

If no application for an import licence has been lodged during any of the periods referred to in the first subparagraph, the Member State in question shall so inform the Commission by telex sent on the abovementioned days.

2. The Member States shall forward to the Commission each Monday the originals of the documents referred to in the first indent of Article 2 (1).

Article 3

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals⁽¹⁾, as last amended by Regulation (EEC) No 3989/87⁽²⁾, and in particular Article 14 (4) thereof,

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice⁽³⁾, as last amended by Regulation (EEC) No 3990/87⁽⁴⁾, and in particular Article 12 (4) thereof,

Having regard to Council Regulation No 1676/85 of 11 June 1985 on the value of the unit of account and the exchange rates to be applied for the purposes of the common agricultural policy⁽⁵⁾, as last amended by Regulation (EEC) No 1636/87⁽⁶⁾, and in particular Article 3 thereof,

Having regard to the opinion of the Monetary Committee,

Whereas the import levies on products processed from cereals and rice were fixed by Commission Regulation (EEC) No 4013/87⁽⁷⁾, as last amended by Regulation (EEC) No 117/88⁽⁸⁾;

Whereas Council Regulation (EEC) No 1906/87⁽⁹⁾ as amended by Council Regulation (EEC) No 2744/75⁽¹⁰⁾ as regards products falling within subheadings 2302 10, 2302 20, 2302 30 and 2302 40 of the combined nomenclature;

Whereas, if the levy system is to operate normally, levies should be calculated on the following basis:

— in the case of currencies which are maintained in relation to each other at any given moment within a band of 2,25 %, a rate of exchange based on their central rate, multiplied by the corrective factor provided for in the last paragraph of Article 3 (1) of Regulation (EEC) No 1676/85,

— for other currencies, an exchange rate based on the arithmetic mean of the spot market rates of each of these currencies recorded over a given period in relation to the Community currencies referred to in the previous indent, and the aforesaid coefficient;

Whereas these exchange rates being those recorded on 18 January 1988;

Whereas the aforesaid corrective factor affects the entire calculation basis for the levies, including the equivalence coefficients;

Whereas the levy on the basic product as last fixed differs from the average levy by more than 3,02 ECU per tonne of basic product; whereas, pursuant to Article 1 of Commission Regulation (EEC) No 1579/74⁽¹¹⁾ the levies at present in force must therefore be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies to be charged on products processed from cereals and rice covered by Regulation (EEC) No 2744/75 as fixed in the Annex to amended Regulation (EEC) No 4013/87 are hereby altered to the amounts set out in the Annex.

Article 2

This Regulation shall enter into force on 20 January 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Whereas the Community is a Contracting Party to the International Convention on the Harmonized Commodity Description and Coding System, hereinafter referred to as the 'harmonized system', which is intended to replace the Convention on Nomenclature of 15 December 1950 for the classification of goods in the customs tariff;

Whereas Council Regulation (EEC) No 2658/87⁽¹⁾ established from 1 January 1988 a combined nomenclature of goods based on the nomenclature of the harmonized system which will meet at one and the same time the requirements of the Common Customs Tariff; whereas the combined nomenclature also covers ECSC products;

Whereas it is accordingly necessary to establish the descriptions and tariff numbers of the products listed in the Annex to High Authority recommendation No

1/64⁽²⁾ in line with the combined nomenclature based on the harmonized system and thereby to take into account the resulting tariff adjustments,

HAS ADOPTED THIS RECOMMENDATION:

The Annex to High Authority recommendation No 1/64 is hereby replaced by the Annex hereto.
