COMMISSION REGULATION (EEC) No 1207/90

of 11 May 1990

fixing the monetary compensatory amounts applicable in the agricultural sector and certain coefficients and rates required for their application

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1677/85 of 11 June 1985 on monetary compensatory amounts in agriculture ⁽¹⁾, as last amended by Regulation (EEC) No 1889/87 ⁽²⁾, and in particular Article 12 thereof,

Having regard to Commission Regulation (EEC) No 3153/85 of 11 November 1985 laying down detailed rules for calculation of monetary compensatory amounts ⁽³⁾, as last amended by Regulation (EEC) No 3672/89 ⁽⁴⁾, and in particular Article 6 (3) thereof,

Having regard to Commission Regulation (EEC) No 3155/85 of 11 November 1985 providing for the advance fixing of monetary compensatory amounts ⁽⁵⁾, as last amended by Regulation (EEC) No 3247/89 ⁽⁶⁾, and in particular Article 6 (2) thereof,

Whereas, in accordance with Article 1 of Regulation (EEC) No 1677/85, if, for the currency of a Member State, there is a difference between the agricultural conversion rate and the central rate, or, where applicable, the market rate, that Member State must apply monetary compensatory amounts in intra-Community trade and in trade with third countries;

Whereas a Member State for which the central rate, or, where appropriate, the market rate indicates a value for the currency as expressed in ecus higher than the agricultural conversion rate charges monetary compensatory amounts on imports and pays them on exports; whereas

these amounts are called 'positive monetary compensatory amounts'; whereas a Member State for which the central rate, or, where appropriate, the market rate expresses a value for a Member State's currency as expressed in ecus lower than the agricultural conversion rate charges monetary compensatory amounts on exports and pays them on imports; whereas these amounts are called 'negative monetary compensatory amounts';

Whereas, however, the monetary compensatory amounts apply only where the differences between the agricultural conversion rate and the central rate, or, where appropriate, the market rate would cause disturbances in trade in agricultural products;

Whereas, pursuant to the second subparagraph of Article 5 (2) of Regulation (EEC) No 1677/85, the real monetary gap is equal:

- (a) in respect of those Member States whose currencies are maintained as between themselves within a spread at any given time of a maximum of 2,25 %, to the percentage representing, for the currency of the Member State concerned, the difference between:
- the agricultural conversion rate,
 - and
 - the central rate;
- (b) in respect of Member States other than those referred to in (a), to the average of the percentage differences between:
- the rate resulting from the relationship between the agricultural conversion rate for the currency of the Member State concerned and the central rates of each of the currencies of the Member States referred to in (a),
 - and
 - the rate corresponding to the average spot exchange rate of the currency of the Member State concerned in terms of each of the currencies of the Member States referred to in (a), recorded over a period to be determined; whereas that period, under Article 2 (1) of Commission Regulation (EEC) No 3153/85 runs from the Wednesday of one week to the Tuesday of the following week;

Whereas, notwithstanding the aforementioned Article 5, the central rates to be referred to for the calculation of the compensatory amounts are to be multiplied by a correcting factor, pursuant to Article 6 (1) of Regulation (EEC) No 1677/85;

Whereas the monetary gap to be applied is equal to the real monetary gap minus a neutral margin of:

- 10 points in the olive oil sector,
- 5 points in the wine and poultry sector,
- 1,5 points in all other sectors, except for the Netherlands where the neutral margin is 1 point;

Whereas, however, a percentage of:

- 0 is applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 0,50 but exceeds 0,
- 1 is applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 1 but more than 0,50;

Whereas, pursuant to Article 8 of Regulation (EEC) No 3153/85, where there are real monetary gaps differentiated according to product for a Member State, all the monetary compensatory amounts are to be adjusted if the applied monetary gap is adjusted for any one of the products concerned following adjustments of the conversion rates used for calculation of the monetary gaps; whereas the adjustment of the conversion rate for pigmeat pursuant to Article 6a of Regulation (EEC) No 1677/85 is to be considered such an adjustment;

Whereas, pursuant to Council Regulation (EEC) No 1678/85 ⁽¹⁾, as last amended by Regulation (EEC) No 1179/90 ⁽²⁾, new agricultural conversion rates for the milk and milk products and beef and veal sectors take effect from 14 May 1990;

Whereas, in view of the foregoing, the monetary compensatory amount must be calculated by reference to a gap of zero for the Member States maintaining their currencies as between themselves within a maximum spread at any one time of 2,25 %;

Whereas under Article 2 (1) of Regulation (EEC) No 3153/85, read with Article 9 (2) of Regulation (EEC) No 1677/85, the monetary compensatory amounts are calculated on the basis of the rates for the reference

period from 14 to 20 March for the Escudo and from 2 to 8 May 1990 for the other currencies; whereas this results in the following monetary gaps to be applied:

— *United Kingdom:*

milk and milk products	— 10,6
cereals, sugar	— 19,1
beef and veal	— 5,3
eggs, poultry and albumins	— 15,6
olive oil	— 10,6
pigmeat	— 10,9

— *Greece:*

milk and milk products, beef and veal	— 14,0
cereals, sugar	— 11,3
eggs, poultry and albumins	— 7,8
olive oil	— 2,8
wine	— 7,8
pigmeat	— 3,2

— *Spain:*

milk and milk products	+ 3,4
beef and veal	+ 4,0
cereals	+ 3,0
sugar	+ 3,0
other sectors	0

— *Portugal:*

olive oil	0
sugar	— 2,1;

Whereas for the basic products, the monetary compensatory amounts are equal to the amounts obtained by applying the monetary gap to the common prices;

Whereas for derived products, the monetary compensatory amounts are equal to the incidence, on the price of the product concerned, of the application of the monetary compensatory amount to the price of the basic product or products on which they depend;

Whereas poultry products are deemed to be derived from cereals;

Whereas, under Article 6a of Regulation (EEC) No 1677/85 the monetary compensatory amounts in the pigmeat sector are fixed on the basis of a price equal to 35 % of the basic price; whereas, however, the agricultural conversion rates of Member States are adjusted, so as to avoid the creation of new monetary compensatory amounts; whereas no adjustment may be made that would give a difference for a Member State of more than eight points between the monetary gap applicable in the pigmeat sector and that applicable in the cereals sector;

Whereas, under Article 4 (3) (a) of Regulation (EEC) No 3153/85, for sugar, the monetary compensatory amount is calculated on the basis of the intervention price increased by the amount of the levy charged on

price increased by the amount of the levy charged on sugar of Community origin under the storage cost offsetting scheme;

Whereas, under Article 4 (3) (b) of Regulation (EEC) No 3153/85, for beef and veal, the monetary compensatory amount is calculated on the basis of the intervention price for R3 carcasses of male animals in the Member State concerned, less 20 %;

Whereas, under Article 4 (3) (c) of Regulation (EEC) No 3153/85, for milk and milk products, the monetary compensatory amounts:

- are calculated on the basis of the intervention prices for butter and for skimmed-milk powder, less 5 %,
- for all products except skimmed-milk powder, butter and products falling within CN code 0405 00 90 are calculated without taking into account the processing costs included in the intervention prices for butter and for skimmed-milk powder;

Whereas, under Article 4 (3) (d) of Regulation (EEC) No 3153/85, for cereals, the monetary compensatory amounts are calculated on the basis of the intervention prices for the products concerned, less 7,5 %;

Whereas, under Article 4 (3) (e) of Regulation (EEC) No 3153/85, for wine, the monetary compensatory amount is calculated on the basis of the minimum guaranteed price;

Whereas, pursuant to Article 4 (3) (g) of Regulation (EEC) No 3153/85, as regards olive oil, the monetary compensatory amounts are calculated on the basis of the following prices:

CN code	Price used
1509 10 10	Intervention price for lampante olive oil with 5° acidity
1509 10 90	Intervention price for semi-fine olive oil
1509 90 00	Price used for CN code 1509 10 10, multiplied by a coefficient of 1,10
1510 00 10	Price used for CN code 1509 10 10, multiplied by a coefficient of 0,47 and reduced by ECU 9,1/100 kg
1510 00 90	Price used for CN code 1510 00 10, multiplied by a coefficient of 1,22

Whereas, for olive oils put up in a way meeting the requirements for the granting of the consumption aid and for the release to free circulation of olive oil from third countries, the monetary compensatory amount is to be calculated on the basis of the price as indicated above minus the consumption aid, after deduction of the amount withheld pursuant to Article 11 (6) of Council Regulation (EEC) No 136/66/EEC⁽¹⁾, as last amended by Regulation (EEC) No 2902/89⁽²⁾, for information and promotion purposes;

Whereas the prices fixed by the Council are to be reduced in accordance with Article 2 of Commission Regulation (EEC) No 784/90 of 29 March 1990 fixing the reducing coefficient for agricultural prices in the 1990/91 marketing year as a result of the monetary realignment of 5 January 1990 and amending the prices and amounts fixed in ecus for that marketing year⁽³⁾;

Whereas, pursuant to Article 5 of Regulation (EEC) No 3153/85, monetary compensatory amounts are not applicable for:

- products falling within CN codes 2007 91 10, 2007 91 30, 2007 91 90, 2007 99 20 and 2007 99 57 and covered by Council Regulation (EEC) No 426/86⁽⁴⁾, as last amended by Regulation (EEC) No 1202/90⁽⁵⁾, with a sugar content of more than 50 % by weight,
- goods covered by Regulation (EEC) No 3033/80⁽⁶⁾, as last amended by Regulation (EEC) No 3743/87⁽⁷⁾,

where the monetary compensatory amount is less than the equivalent of ECU 3 per 100 kg of goods;

Whereas the specific characteristics of certain products warrant the non-application of monetary compensatory amounts;

Whereas the monetary compensatory amounts apply in trade between the Member States and with third countries; whereas, however:

- in trade with a new Member State, the accession compensatory amounts, the fixed components and other amounts provided for under accession measures, and
- in trade with third countries, import charges, or parts thereof, and import subsidies and export refunds and levies

fixed in ecus and applicable to products subject to monetary compensatory amounts are multiplied by the monetary coefficient;

Whereas, according to Article 6 (3) of Regulation (EEC) No 3153/85, the monetary coefficient is to be established by taking the abovementioned neutral margins into consideration;

Whereas, for goods coming under Regulation (EEC) No 3033/80, the import charges are fixed in a single amount; whereas, on the other hand, the refunds to be granted are those applicable for the basic products from which those goods are obtained; whereas this should therefore be taken into consideration, by taking account of the neutral margins to be applied for the basic products concerned, when the monetary coefficients to be applied for those goods are fixed;

Whereas Article 6 (1) of Regulation (EEC) No 3155/85 provides that the monetary compensatory amounts fixed in advance must be adjusted where a new agricultural conversion rate, which has been announced publicly before the application for advance fixing is lodged, takes effect; whereas that situation has arisen and whereas the adjustments in question should be fixed;

Whereas the new monetary compensatory amounts must be applied in compliance with the date on which the changes in the basic factors for calculating the monetary compensatory amounts take effect;

Whereas, it should be made clear that the codes used are those of the combined nomenclature as defined in Council Regulation (EEC) No 2658/87 on the tariff and statistical nomenclature and on the Common Customs Tariff⁽¹⁾, as last amended by Regulation (EEC) No 1251/90⁽²⁾; whereas the additional codes are defined in the tables in the Appendix to Annex I to this Regulation and whereas the additional table numbers shown in the parts refer to the chapter indicated in the first two digits of the codes of the combined nomenclature; whereas, for the sake of clarity, certain tables should be provided with explanatory notes on the way they are to apply; whereas

This Regulation shall be binding in its entirety and directly applicable in all Member States.

the versions of Tables 4.3, 4.5, 4.6 and 4.7 applicable on 13 May 1990 must be adapted to take account of market developments for milk and milk products;

Whereas monetary compensatory amounts now applying and certain coefficients and rates required for their application were fixed by Commission Regulation (EEC) No 1876/89⁽³⁾, as last amended by Regulation (EEC) No 1128/90⁽⁴⁾; whereas that Regulation may be repealed;

Whereas the measures provided for in this Regulation are in accordance with the opinions of the relevant management committees,

HAS ADOPTED THIS REGULATION:

Article 1

The monetary compensatory amounts referred to in Article 1 of Regulation (EEC) No 1677/85 are hereby fixed for the Member States concerned as set out in Annex I.

Article 2

The coefficients referred to in Article 6 (3) of Regulation (EEC) No 3153/85 are hereby fixed as set out in Annex II.

Article 3

The coefficients used pursuant to Article 6 of Regulation (EEC) No 3155/85 to adjust monetary compensatory amounts fixed in advance are hereby fixed as set out in Annex III.

Article 4

Regulation (EEC) No 1876/89 is hereby repealed.

Article 5

This Regulation shall enter into force on 14 May 1990.

However, where a mixture of glucose and fructose is declared (in whatever form) or is found to be present in the goods, the amount of glucose to be included in the above calculation is that which is in excess of the fructose content of the goods.

Sucrose/Invert Sugar/Isoglucose

The content of the goods (as presented), in sucrose, together with the sucrose which results from expressing as sucrose any mixture of glucose and fructose (the sum of the amounts of these two sugars multiplied by 0,95), which is declared (in whatever form) or found to be present in the goods.

However, where the fructose content of the goods is less than the glucose content, the amount of glucose to be included in the above calculation shall be an amount equal, by weight, to that of fructose.

Note: In all cases, where a hydrolysis product of lactose is declared, and/or galactose is found to be present among the sugars, then the amount of glucose equal to that of galactose is deducted from the total glucose content before any other calculations are carried out.

Milk proteins

Milk proteins, excluding those contained in the whey, casein and/or caseinates, added to the product.

**fixing the conversion rates used for the calculation of monetary compensatory amounts
and to be applied for certain amounts in the agricultural sector**

THE COMMISSION OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European
Economic Community,

Having regard to Council Regulation (EEC) No
1677/85 of 11 June 1985 on monetary compensatory
amounts in agriculture ⁽¹⁾, as last amended by Regulation
(EEC) No 1889/87 ⁽²⁾, and in particular Article 12
thereof,

Whereas the monetary compensatory amounts
introduced by Regulation (EEC) No 1677/85 are fixed
by Commission Regulation (EEC) No 1207/90 ⁽³⁾ on the
basis of the central rates and, for certain Member States,
on the basis of the exchange rates referred to in Article 3
of Commission Regulation (EEC) No 3153/85 of 11
November 1985 laying down detailed rules for the calcu-
lation of monetary compensatory amounts ⁽⁴⁾, as last
amended by Regulation (EEC) No 3672/89 ⁽⁵⁾;

Whereas, in accordance with Article 3a of Commission
Regulation (EEC) No 3152/85 of 11 November 1985
laying down detailed rules for the application of Regu-
lation (EEC) No 1676/85 on the value of the unit of
account and the conversion rates to be applied for the
purposes of the common agricultural policy ⁽⁶⁾, as last

amended by Regulation (EEC) No 2300/89 ⁽⁷⁾, the rates
used to fix or, where appropriate, adjust the monetary
compensatory amounts are to be used for the conversion
into ecus of the amounts relating to world market data
and expressed in the national currency of a Member
State; whereas, pursuant to Article 2(4) of Council
Regulation (EEC) No 1676/85 ⁽⁸⁾, as last amended by
Regulation (EEC) No 1636/87 ⁽⁹⁾, those rates are also to
be used for the conversion of certain other agricultural
amounts; whereas the rates in question should be fixed
to make it easier to use them;

Whereas the measures provided for in this Regulation
are in accordance with the opinions of the relevant
management committees,

HAS ADOPTED THIS REGULATION:

Article 1

The conversion rates used to fix or, where appropriate,
to adjust the monetary compensatory amounts, as
referred to in Article 3a of Regulation (EEC) No
3152/85, shall be as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 14 May 1990.

This Regulation shall be binding in its entirety and directly applicable in all Member
States.
