COMMISSION REGULATION (EC) No 98/2007

of 1 February 2007

establishing the standard import values for determining the entry price of certain fruit and vegetables

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 3223/94 of 21 December 1994 on detailed rules for the application of the import arrangements for fruit and vegetables (¹), and in particular Article 4(1) thereof,

Whereas:

 Regulation (EC) No 3223/94 lays down, pursuant to the outcome of the Uruguay Round multilateral trade negotiations, the criteria whereby the Commission fixes the standard values for imports from third countries, in respect of the products and periods stipulated in the Annex thereto.

(2) In compliance with the above criteria, the standard import values must be fixed at the levels set out in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

The standard import values referred to in Article 4 of Regulation (EC) No 3223/94 shall be fixed as indicated in the Annex hereto.

Article 2

This Regulation shall enter into force on 2 February 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION REGULATION (EC) No 99/2007

of 1 February 2007

determining the extent to which applications lodged in January 2007 for import rights in respect of frozen beef intended for processing may be accepted

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1254/1999 of 17 May 1999 on the common organisation of the market in beef and veal (¹),

Having regard to Commission Regulation (EC) No 727/2006 of 12 May 2006 opening and providing for the administration of an import tariff quota for frozen beef intended for processing (1 July 2006 to 30 June 2007) (²), and in particular Article 5(4) thereof,

Whereas:

- Article 3(1) of Regulation (EC) No 727/2006 fixes the quantities of frozen beef intended for processing which may be imported under special terms in the period from 1 January to 30 June 2007.
- (2) Article 5(4) of Regulation (EC) No 727/2006 lays down that the quantities applied for may be reduced. The appli-

cations lodged relate to total quantities which exceed the quantities available. Under these circumstances and taking care to ensure an equitable distribution of the available quantities, it is appropriate to reduce proportionally the quantities applied for,

HAS ADOPTED THIS REGULATION:

Article 1

Every application for import rights lodged in accordance with Regulation (EC) No 727/2006 for the period 1 January to 30 June 2007 shall be granted to the following extent, expressed as bone-in beef:

- (a) 6,04342 % of the quantity requested for beef imports intended for the manufacture of 'preserves' as defined by Article 3(1)(a) of Regulation (EC) No 727/2006,
- (b) 33,499412 % of the quantity requested for beef imports intended for the manufacture of products as defined by Article 3(1)(b) of Regulation (EC) No 727/2006.

Article 2

This Regulation shall enter into force on 2 February 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION REGULATION (EC) No 100/2007

of 1 February 2007

amending Regulation (EC) No 877/2004 laying down detailed rules for applying Council Regulation (EC) No 2200/96 as regards notification of prices on the markets for certain fresh fruits and vegetables, by reason of the accession of Bulgaria and Romania to the European Union

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty of Accession of Bulgaria and Romania,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Article 56 thereof,

Whereas:

- (1) Article 28(1) of Council Regulation (EC) No 2200/96 of 28 October 1996 on the common organisation of the market in fruit and vegetables (¹) requires Member States to notify the Commission for each marketing day during each of the relevant marketing years of the prices recorded on their representative producer markets for certain products of defined commercial characteristics such as variety or type, class, size and packaging.
- (2) The Annex to Commission Regulation (EC) No 877/2004 (²) sets out a list of representative markets on which a substantial part of the national output of a given product is marketed throughout the marketing year or during one of the periods into which the year is divided.

- (3) By reason of the accession of Bulgaria and Romania to the European Union on 1 January 2007, representative markets should be established for them.
- (4) Regulation (EC) No 877/2004 should therefore be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

The Annex to Regulation (EC) No 877/2004 is amended as follows:

- (a) 'Sofia (BG)' is added to the list of representative markets for the following products: 'tomatoes', 'aubergines', 'watermelons', 'melons', 'apricots', 'peaches', 'table grapes', 'cerises', 'cucumbers', 'plums' and 'sweet peppers';
- (b) 'Bucharest (RO)' is added to the list of representative markets for the following products: 'tomatoes', 'aubergines', 'water melons', 'apricots', 'apples', 'cerises', 'cucumbers', 'garlic', 'carrots', 'plums', 'sweet peppers', 'onions' and 'beans'.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION DECISION

of 31 January 2007

amending Decision 2006/415/EC concerning certain protection measures in relation to highly pathogenic avian influenza of the subtype H5N1 in poultry in Hungary

(notified under document number C(2007) 325)

(Text with EEA relevance)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to Council Directive 89/662/EEC of 11 December 1989 concerning veterinary checks in intra-Community trade with a view to the completion of the internal market (¹), and in particular Article 9(4) thereof,

Having regard to Council Directive 90/425/EEC of 26 June 1990 concerning veterinary and zootechnical checks applicable in intra-Community trade in certain live animals and products with a view to the completion of the internal market (²), and in particular Article 10(4) thereof,

Having regard to Council Directive 2005/94/EC of 20 December 2005 on Community measures for the control of avian influenza and repealing Directive 92/40/EEC (³), and in particular Article 66(2) thereof,

Whereas:

Directive 2005/94/EC lays down measures for the control of avian influenza and repeals Council Directive 92/40/EEC of 19 May 1992 introducing Community measures for the control of avian influenza (⁴), as from 1 July 2007.

- (2) As the final date for transposition of Directive 2005/94/EC into national law is 1 July 2007, Commission Decision 2006/415/EC of 14 June 2006 concerning certain protection measures in relation to highly pathogenic avian influenza of the subtype H5N1 in poultry in the Community and repealing Decision 2006/135/EC (⁵) and Commission Decision 2006/416/EC of 14 June 2006 concerning certain transitional measures in relation to highly pathogenic avian influenza in poultry or other captive birds in the Community (⁶), were adopted pending the transposition of that Directive. Those Decisions are to apply until 30 June 2007.
- (3) Decision 2006/415/EC lays down certain protection measures to be applied in the event of an outbreak of highly pathogenic avian influenza in poultry in the territory of a Member State caused by the highly pathogenic A virus of subtype H5, in order to prevent the spread of the avian influenza into the disease free parts of the Community thorough the movement of birds as well as products thereof.
- (4) Hungary has notified the Commission of an outbreak of H5N1 in poultry on its territory and has taken the appropriate measures as provided for in Decision 2006/415/EC, including the establishment of Areas A and B as provided for in Article 4 of that Decision.

- (5) The Commission has examined those measures in collaboration with Hungary, and is satisfied that the borders of Areas A and B established by the competent authority in that Member State are at a sufficient distance to the actual location of the outbreak. Areas A and B in Hungary can therefore be confirmed and the duration of that regionalisation fixed.
- (6) It is therefore necessary to amend Decision 2006/415/EC accordingly.

The measures provided for in this Decision are in

accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

Article 1

The Annex to Decision 2006/415/EC is replaced by the text in the Annex to this Decision.

Article 2

This Decision is addressed to the Member States.
