COUNCIL IMPLEMENTING REGULATION (EU) No 170/2012

of 28 February 2012

implementing Article 8a(1) of Regulation (EC) No 765/2006 concerning restrictive measures in respect of Belarus

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 765/2006 (¹), and in particular Article 8a(1) thereof,

Whereas:

- On 18 May 2006, the Council adopted Regulation (EC) No 765/2006.
- (2) In view of the gravity of the situation in Belarus, certain persons should be included in the list of natural and legal persons, entities and bodies subject to restrictive measures as set out in Annex IB to Regulation (EC) No 765/2006.
- (3) The information relating to persons on the list in Annex IA to Regulation (EC) No 765/2006 should be updated.
- (4) Annexes IA and IB to Regulation (EC) No 765/2006 should be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

In Annex IA to Regulation (EC) No 765/2006, the entries for the following persons:

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Therefore this Regulation should enter into force on the day of its publication in the Official Journal of the European Union,

COUNCIL RECOMMENDATION

of 21 February 2012

concerning the discharge to be given to the Commission in respect of the implementation of the operations of the European Development Fund (eighth EDF) for the financial year 2010

(2012/127/EU)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the fourth ACP-EEC Convention, signed at Lomé on 15 December 1989 $(^1)$ and amended by the Agreement signed in Mauritius on 4 November 1995 $(^2)$,
