COUNCIL IMPLEMENTING REGULATION (EU) 2023/1563

of 28 July 2023

implementing Regulation (EU) No 269/2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) No 269/2014 of 17 March 2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine (¹), and in particular Article 14(1) thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 17 March 2014, the Council adopted Regulation (EU) No 269/2014.
- (2) The Union remains unwavering in its support for Ukraine's sovereignty and territorial integrity.
- (3) In its conclusions of 23 March 2023, the European Council reiterated the Union's resolute condemnation of Russia's war of aggression against Ukraine, which constitutes a manifest violation of the United Nations Charter. The European Council also reiterated that the Union remains committed to maintaining and increasing collective pressure on Russia, including through possible further restrictive measures. The European Council also stated that the Union will intensify its work with partners to counter false Russian narratives and disinformation about the war.
- (4) In the context of Russia's war of aggression against Ukraine, Russian actors have conducted a digital information manipulation campaign named 'RRN' (Recent Reliable News) aiming at manipulating information and disseminating propaganda in support of Russia's war of aggression against Ukraine. That campaign, in which government bodies or bodies affiliated to the Russian State have participated, relies on fake web pages usurping the identity of national media outlets and government websites as well as fake accounts on social media.
- (5) In view of the gravity of the situation, the Council considers that seven persons and five entities responsible for actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine should be added to the list of natural and legal persons, entities and bodies subject to restrictive measures set out in Annex I to Regulation (EU) No 269/2014.
- (6) Annex I to Regulation (EU) No 269/2014 should therefore be amended accordingly,

Article 1

Annex I to Regulation (EU) No 269/2014 is amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the date of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 215 thereof,

Having regard to Council Decision (CFSP) 2023/1568 of 28 July 2023 amending Decision 2010/788/CFSP concerning restrictive measures in view of the situation in the Democratic Republic of the Congo (¹),

Having regard to the joint proposal of the High Representative of the Union for Foreign Affairs and Security Policy and the European Commission,

Whereas:

- (1) Council Regulation (EC) No 1183/2005 (²) gives effect to Council Decision 2010/788/CFSP (³) and provides for certain measures directed against persons acting in violation of the arms embargo with regard to the Democratic Republic of the Congo (DRC), including freezing their assets.
- (2) In view of the gravity of the situation in the DRC, Decision (CFSP) 2023/1568 amends the criteria of Union autonomous listings to allow for the application of targeted restrictive measures against natural or legal persons, entities or bodies that provide support to any natural or legal person, entity or body responsible for sustaining the armed conflict, instability or insecurity in the DRC.
- (3) Regulatory action at the Union level is therefore necessary to give effect to Decision (CFSP) 2023/1568 in particular with a view to ensure uniform application by economic operators in all Member States.
- (4) Regulation (EC) No 1183/2005 should therefore be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

In Article 2b(1) of Regulation (EC) No 1183/2005, point (d) is replaced by the following:

'(d) providing support to natural or legal persons, entities or bodies responsible for sustaining the armed conflict, instability or insecurity in the DRC.'.

Article 2

This Regulation shall enter into force on the date of its publication in the Official Journal of the European Union.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 17 March 2014, the Council adopted Decision 2014/145/CFSP (1).
- (2) The Union remains unwavering in its support for Ukraine's sovereignty and territorial integrity.
- (3) In its conclusions of 23 March 2023, the European Council reiterated the Union's resolute condemnation of Russia's war of aggression against Ukraine, which constitutes a manifest violation of the United Nations Charter. The European Council also reiterated that the Union remains committed to maintaining and increasing collective pressure on Russia, including through possible further restrictive measures. The European Council also stated that the Union will intensify its work with partners to counter false Russian narratives and disinformation about the war.
- (4) In the context of Russia's war of aggression against Ukraine, Russian actors have conducted a digital information manipulation campaign named 'RRN' (Recent Reliable News), aiming at manipulating information and disseminating propaganda in support of Russia's war of aggression against Ukraine. That campaign, in which government bodies or bodies affiliated to the Russian State have participated, relies on fake web pages usurping the identity of national media outlets and government websites as well as fake accounts on social media.
- (5) In view of the gravity of the situation, the Council considers that seven persons and five entities responsible for actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine should be added to the list of persons, entities and bodies subject to restrictive measures set out in the Annex to Decision 2014/145/CFSP.
- (6) Further action by the Union is needed in order to implement certain measures.
- (7) Decision 2014/145/CFSP should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

The Annex to Decision 2014/145/CFSP is amended in accordance with the Annex to this Decision.

COUNCIL DECISION (CFSP) 2023/1568

of 28 July 2023

amending Decision 2010/788/CFSP concerning restrictive measures in view of the situation in the Democratic Republic of the Congo

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 20 December 2010, the Council adopted Decision 2010/788/CFSP (¹), concerning restrictive measures in view of the situation in the Democratic Republic of the Congo (DRC).
- (2) On 12 December 2016, the Council adopted Decision (CFSP) 2016/2231 (²) in response to the obstruction of the electoral process and to human rights violations in the DRC. Decision (CFSP) 2016/2231 amended Decision 2010/788/CFSP and introduced additional restrictive measures in Article 3(2) of Decision 2010/788/CFSP.
- (3) On 7 July 2023, the High Representative of the Union for Foreign Affairs and Security Policy issued a statement on behalf of the Union on the situation in the DRC, expressing grave concern over the worsening security and humanitarian situation and outrage over the levels of violence and atrocities that continue to be perpetrated against civilians by non-governmental armed groups.
- (4) In view of the gravity of the situation in the DRC, the Council considers that the designation criterion in Article 3(2), point (d), of Decision 2010/788/CFSP should be amended to allow for the application of targeted restrictive measures against natural or legal persons, entities or bodies that provide support to any natural or legal person, entity or body responsible for sustaining the armed conflict, instability or insecurity in the DRC.
- (5) Decision 2010/788/CFSP should therefore be amended accordingly.
- (6) Further action by the Union is necessary to implement certain measures in this Decision,

HAS ADOPTED THIS DECISION:

Article 1

In Article 3(2) of Decision 2010/788/CFSP, point (d) is replaced by the following:

'(d) providing support to natural or legal persons, entities or bodies responsible for sustaining the armed conflict, instability or insecurity in the DRC;'.

Article 2

This Decision shall enter into force on the date of its publication in the Official Journal of the European Union.
