DECISION OF THE EEA JOINT COMMITTEE No 109/2024
of 26 April 2024
amending Annex XX (Environment) to the EEA Agreement [2024/1934]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Decision (EU) 2022/1979 of 31 August 2022 on establishing the form and databases for communicating the information referred to in Articles 18(1) and 21(3) of Directive 2012/18/EU of the European Parliament and of the Council on the control of major-accident hazards involving dangerous substances and repealing Commission Implementing Decision 2014/895/EU ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Implementing Decision (EU) 2022/1979 repeals, with effect from 31 December 2025, Commission Implementing Decision 2014/895/EU ⁽²⁾, which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement with effect from 31 December 2025.
- (3) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XX to the EEA Agreement shall be amended as follows:

1. The following point is inserted after point 23d (Commission Implementing Decision 2014/895/EU):
‘23e. **32022 D 1979:** Commission Implementing Decision (EU) 2022/1979 of 31 August 2022 on establishing the form and databases for communicating the information referred to in Articles 18(1) and 21(3) of Directive 2012/18/EU of the European Parliament and of the Council on the control of major-accident hazards involving dangerous substances and repealing Commission Implementing Decision 2014/895/EU (OJ L 272, 20.10.2022, p. 14).’
2. The text of point 23d (Commission Implementing Decision 2014/895/EU) shall be deleted with effect from 31 December 2025.

Article 2

The text of Implementing Decision (EU) 2022/1979 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 27 April 2024, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
