(The sitting opened at 9 a.m.)

1. Approval of Minutes

Mr Klironomos had informed the Chair that he had intended to vote against the referral back to committee of the Newman report (A4-0124/94) and not for (Item 6).

The following spoke:

– Mr Langer, who referred to item 6 (agenda), in particular the PPE Group's request to refer the Newman report (A4-0124/94) back to committee, and noted he had asked for the floor on behalf of the Green Group but that the President had not given him it (the President replied that in such cases the Rules of Procedure provided only for one speaker in favour of the request and one against, and that Mr Langer's request for the floor had been the fourth or fifth request received);

– Mr Martens, who referred to item 10 (situation in Burundi) and pointed out that he also had spoken on behalf of the PPE Group (the President replied that the necessary correction would be made);

– Mr Posselt, who noted that, as recorded in the Minutes, many Members did not take part in the first vote of the previous day's sitting, and pointed out that this was because rue Belliard had been blocked by a demonstration which had caused many Members to arrive late; he asked that in future items on the agenda likely to give rise to demonstrations should be taken in Strasbourg where access to Parliament's buildings was easier.

Mr Elliott noted that the draft agenda for the part-session mistakenly recorded only Mrs Pack as rapporteur on 'Socrates', a mistake he noted had been rectified in the final agenda, in which his own name and that of Mr Vallvé had been added, and sought an assurance that the three co-rapporteurs would be allocated the same speaking time (the President confirmed they would).

2. Interpretation of Rules of Procedure

The President announced that the Committee on the Rules of Procedure, the Verification of Credentials and Immunities had been asked for its opinion on the application of Rule 40(4) and had given the following interpretation pursuant to Rule 162(3):

'The author of the question is entitled to use the whole period of speaking time mentioned.'

If this interpretation was not contested before the approval of these Minutes pursuant to Rule 162(5) it would be deemed to have been adopted.

Should however, a political group or at least 29 Members contest the committee's interpretation, the matter would be put to the vote in Parliament. Adoption of the text would be by simple majority provided that at least one third of Parliament's Members were present. In the event of rejection, the matter would be referred back to the committee.

**DECLARATION BY THE EUROPEAN PARLIAMENT, THE COUNCIL
AND THE COMMISSION**

**on the incorporation of financial provisions
into legislative acts**

THE EUROPEAN PARLIAMENT, THE COUNCIL AND THE COMMISSION,

Whereas the Joint Declaration of 30 June 1982 ⁽¹⁾ states: 'In order that the full importance of the budget procedure may be preserved, the fixing of maximum amounts by regulation must be avoided, as must the entry in the budget of amounts in excess of what can actually be expended';

Whereas, according to a statement annexed to the Interinstitutional Agreement of 29 October 1993 ⁽²⁾, the budgetary procedure provisions should be reviewed 'at the Intergovernmental Conference scheduled for 1996 in order to achieve interinstitutional cooperation on a partnership basis';

HEREBY DECLARE AS FOLLOWS:

1. Legislative acts concerning multiannual programmes adopted under the codecision procedure

These acts shall contain a provision in which the legislative authority shall lay down the financial framework for the programme for its entire duration.

That amount shall constitute the principal point of reference for the budgetary authority during the annual budgetary procedure.

The budgetary authority and the Commission, when drawing up its preliminary draft budget (PDB), undertake not to depart from this amount unless new, objective, long-term circumstances arise for which explicit and precise reasons are given.

2. Legislative acts concerning multiannual programmes not subject to the codecision procedure

These acts shall not contain an 'amount deemed necessary'.

Should the Council wish to include a financial reference, this shall be taken as illustrating the will of the legislative authority and shall not affect the powers of the budgetary authority as defined by the Treaty. This provision will be mentioned in all acts which include such a financial reference.

If the amount concerned has been the subject of an agreement pursuant to the conciliation procedure provided for in the Joint Declaration of 4 March 1975⁽¹⁾, it will be considered a reference amount within the meaning of point 1 of the present Declaration.

3. The financial statement provided for in Article 3 of the Financial Regulation shall reflect in financial terms the objectives of the proposed programme and include a schedule covering the duration of the programme. It shall be revised, where necessary, when the PDB is drawn up, taking account of the extent of implementation of the programme. The revised statement shall be forwarded to the budgetary authority together with the PDB.

Resolution on the renewal of the EDF

The European Parliament,

- having regard to the outcome of the special negotiating meeting of the ACP-EU Council of Ministers of 30 November to 1 December 1994,
 - having regard to the outcome of the meeting of the General Affairs Council of 15 February 1995 and the meeting of the ACP-EU Council of Ministers of 16 February 1995,
 - having regard to the letter sent by the President of Parliament to the President of the Council on the size of the eighth EDF,
 - having regard to the statements by the Council and Commission of 28 February 1995,
 - having regard to the fact that the results of the Mid-Term Review will be subject to the assent procedure,
 - having regard to the final report and final resolution on the Mid-Term Review of Lomé IV adopted by the ACP-EU Joint Assembly at its meeting of 6 October 1994 in Libreville and its resolution on the progress of the negotiations adopted on 2 February 1995 in Dakar,
- A. whereas the EU-ACP negotiations are at a standstill because of Council failure to agree on the total amount to be allocated to the eighth European Development Fund for the period 1995 to 2000 and recalling that the EDF alone constitutes 54% of European cooperation for development,
 - B. stressing that, in its scope and provisions, the Lomé Convention is a unique cooperation instrument without equivalent in the world,
 - C. aware that it has not been possible during the fourth Lomé Convention to reach agreement on the financial protocol, a fact which is also preventing the conclusion of any global agreement,
 - D. noting the decrease in real terms of aid to developing countries, which are bearing enormous costs for democratization processes at a time when the external expenditure of the Union, as provided for under the financial perspective for the period 1994 to 1999, is increasing substantially,
 - E. whereas the financial assistance given by the European Union to the countries of the South, particularly those which are signatories of the Lomé Convention, should remain a priority in line with the undertakings given,
 - F. whereas the lack of political will to assist the ACP partner countries shown by certain Member State governments is not only jeopardizing the common cooperation policy but is also undermining the Union's credibility on the international stage,
 - G. whereas the annual OECD report on development aid clearly shows that the industrialized countries are devoting less and less aid to the developing countries and that their contribution has fallen to 0,3% of GDP, the lowest level for 20 years, as against the established objective of 0,7% of GDP,

- H. concerned that the Council has rejected the budgetization of Lomé Convention funding which might have provided democratic control by the European Parliament,
- I. aware of the efforts of the French Presidency to arrive at an acceptable offer on the size of the eighth EDF,
- J. whereas it would be contradictory to the stated objectives of the European Union's policy if the Union were to reduce its commitment to the development of ACP nations at a time when some of those are embarking on or making significant progress towards democratization and respect for human rights,
1. Deeply regrets the failure of the General Affairs Council to reach an appropriate global agreement on the eighth EDF, as well as the severe setback this has caused to the overall negotiations on the Mid-Term Review of Lomé IV; considers that reducing Lomé IV funding in real terms defies belief;
 2. Demands therefore that the volume of the EDF be determined according to the following factors:
 - enlargement of the European Union;
 - population increase in the ACP countries;
 - the rate of inflation;
 - the inclusion of new elements proposed by the ACP countries and the European Union under the Mid-Term Review (eg. timber, bananas, etc);
 - the economic difficulties faced by the ACP countries, resulting from structural adjustment policies and the Uruguay Round;
 - the debt burden;
 3. Stresses its great concern at the risk of development aid being renationalized in favour of bilateral relations and to the detriment of the Union's commitment to its ACP partners;
 4. States categorically that it will not accept a decrease in real terms of the amount allocated under the previous Financial Protocol and will take any measures within its power to ensure that the EU's commitment to the ACP countries is upheld;
 5. Issues a strong appeal to those Member States which have stated that they wish to reduce their financial contribution to economic development policy to reconsider their position;
 6. Considers the allocation proposed by the French Presidency to be the strict minimum for the funding of the eighth EDF;
 7. Calls upon the French Presidency to ensure that an acceptable offer is made to the ACP countries in sufficient time to allow the conclusion of the negotiations before 6 May 1995;
 8. Makes its assent conditional on the fixing of funding at levels which meet the criteria set out in paragraph 2 of this resolution;
 9. Calls for the EDF to be made an integral part of the budget of the Union;
 10. Asks the negotiating parties to incorporate in the ongoing negotiations the document adopted by the ACP-EU Joint Assembly on 'Capacity building for an Effective Utilisation of Lomé through Regional and National Education and Training Centres' to ensure a better implementation of the Lomé Convention;
 11. Instructs its President to forward this resolution to the Council, the Commission, the governments of all the states signatory to the Lomé Convention and the Co-Presidents of the ACP-EU Joint Assembly.

Resolution on a strategy for climatic protection in the EU

The European Parliament,

- having regard to its resolutions of 13 June 1991 on energy and the environment ⁽¹⁾,
 - having regard to its resolution of 13 June 1991 on economic and fiscal instruments of environment policy ⁽²⁾,
 - having regard to its resolution of 13 February 1992 on European Community participation in the United Nations Conference on the Environment and Development (UNCED) ⁽³⁾,
 - having regard to its resolution of 15 May 1992 on the United Nations Conference on the Environment and Development (UNCED) ⁽⁴⁾,
 - having regard to its resolution of 9 July 1992 on the outcome of the United Nations Conference on the Environment and Development (UNCED) ⁽⁵⁾,
 - having regard to the Commission proposal for a Council Directive introducing a tax on carbon dioxide emissions and energy (COM(92)0226) ⁽⁶⁾,
 - having regard to the Framework Convention on Climate Change which was signed at the Rio de Janeiro Conference and entered into force on 21 March 1994, constituting the first binding provision of international law in the field of global climatic protection,
 - having regard to the communique issued following the discussion held by the European Council at Essen in December 1994,
 - having regard to the outcome of the Environment Council meeting in December 1994,
 - having regard to the Conference of the Parties to the Framework Convention on Climate Change to be held from 28 March to 7 April 1995 in Berlin,
 - having regard to the draft protocol drawn up on behalf of the Conference of the Parties on behalf of the Alliance of the Small Island States (AOSIS) on Greenhouse Gas Emissions Reduction,
 - having regard to the resolution of the ACP-EU Joint Assembly in Dakar (February 1995) on the Conference of the Parties,
- A. whereas the Council adopted a resolution on 29 November 1990 setting as an objective the stabilisation of carbon dioxide emission levels by the year 2000 at 1990 levels and that this position established worldwide leadership on the issue,
- B. noting that according to all estimates the Union is not on course even to achieve its modest objective of stabilizing CO₂ emissions by the year 2000 at 1990 levels, taking into account all the present national and European measures to combat climate change,
- C. whereas the objective of the UN Framework Convention on Climate Change is to achieve a stabilization of greenhouse gas concentrations in the atmosphere at a level that would prevent dangerous anthropogenic interference with the climatic system,

- D. whereas the International Panel on Climate Change long ago established that we must reduce carbon dioxide emissions by 60% if we are to avoid the dangerous climatic effects of the greenhouse gases; acknowledging that such a reduction obviously requires the use of coordinated instruments by all parties concerned,
- E. whereas, although the problem of climate change must be dealt with at international level, it must also be recognized that it is the responsibility of developed countries such as EU Member States to take the lead by reducing their greenhouse gas emissions, including CO₂,
- F. whereas, at the Rio follow-up conference in Berlin in March, which is the first opportunity to give precise content to the UN Framework 1995 Convention on Climate Change, the Union will have to demonstrate the credibility of the measures it is taking to meet its Rio targets in order to convince the other participating countries to honour their commitments,
- G. having regard to the efforts already undertaken in some Member States (Sweden, Denmark, Finland and the Netherlands) to reduce non-renewable energy use and carbon dioxide emissions by national special taxes,
- H. whereas it is essential for the UN Framework Convention to be implemented, given substance and further developed as a result of the Conference of the Parties in Berlin,
1. Deplores the fact that the Council and the Commission after many years of debate, still have not reached any agreement on a coherent and effective strategy on how to combat CO₂ emissions in spite of all their declarations;
 2. Reaffirms its belief in the need to reduce energy consumption through energy efficiency at global and national level and finds that conservation of resources is a valid way to achieve the proposed objectives;
 3. Reiterates that, although determined action needs to be taken not only at Community level, but also worldwide, the European Union has an obligation to take a lead, both internationally and at Community level;
 4. Calls on the Commission and Member States to urge all the other parties to the Rio Convention to take the opportunity offered by the first Conference of Parties to agree on the stabilization of CO₂ emissions by the year 2000 at 1990 levels (Annex 1 States) within the framework of a binding declaration jointly adopted by the Parties;
 5. Calls on the Commission and the Council to accept on behalf of the European Union the Protocol of the 36 AOSIS countries (small island states), which states that the developed countries commit themselves to reducing their yearly carbon dioxide emissions by 20% in the year 2005 compared to 1990 levels as the next step to a global reduction of carbon dioxide emissions;
 6. Calls on the Commission immediately to bring forward proposals concerning the application, preferably by all Member States, of fiscal instruments to control and limit energy use and carbon dioxide emissions;
 7. Calls on the Council, prior to the Berlin conference, to commit itself to the early adoption of such proposals;
 8. Instructs its President to forward this resolution to the Commission and the Council.

4. World Summit on Social Development

B4-0367/95**Resolution on the European Union's priorities for the World Summit for Social Development
(Copenhagen, March 1995)***The European Parliament,*

- having regard to the UN Charter,
 - having regard to the Community Charter of Fundamental Social Rights of Workers,
 - having regard to its resolution of 9 March 1994 on the Commission White Paper on Growth, Competitiveness and Employment ⁽¹⁾,
 - having regard to its resolution of 27 October 1994 on a medium-term action programme to combat exclusion and promote solidarity: a new programme to support and stimulate innovation (1994 to 1999) ⁽²⁾,
 - having regard to its resolution of 19 January 1995 on the White Paper on European Social Policy – a way forward for the Union ⁽³⁾,
- A. whereas social development aims to achieve the practical satisfaction of the spiritual, cultural and material, individual or collective needs of all human beings by encouraging their emancipation; whereas the specific combination of the three topics adopted for the conference – combating poverty, social integration and increasing the number of environmentally compatible and socially useful jobs – constitutes a concrete approach to the question of social development,
- B. whereas, however, these three topics result from an approach to social development which is exclusively economically oriented, and whereas the social policy aspects of the question should not be neglected, and it should, in particular, be realized that measures to combat poverty and achieve social integration are primarily issues relating to respect for the dignity of the individual and human rights,
- C. whereas respect for human rights and democracy, including dialogue between the two sides of industry, cannot be dissociated from social development and whereas social justice and social development are essential in the achievement and preservation of peace, whilst poverty and social exclusion are a source of tension which may destabilize peace and democracy,
- D. whereas economic development should be at the service of social development; whereas economic phenomena such as the globalization of trade, the international division of labour and national budgetary policy should therefore be considered from the point of view of their social consequences,
- E. whereas the possible introduction of a social clause in international trade agreements should not, under any circumstances, serve to increase protectionism towards developing countries; whereas, on the contrary, it will enable the objectives of social justice and fair competition to be achieved,
- F. whereas the globalization of economies, as the work of the UN has shown, leads to accentuated differences between the poorest and the richest regions of the world, a hastening of the disintegration of traditional social structures, widespread poverty and uncontrolled urban development, but also may provide for increased human mobility, better communications and exchanges of values, increased trade, employment and capital flows as well as important technological developments,
- G. whereas the globalization of economies is nevertheless increasing the complex of problems relating to poverty, exclusion and the lack of productive jobs, since the wealth of 'developed' societies does not of itself protect them from these problems,

- H. whereas the European Union, which is not immune to difficulties of this nature, may nevertheless become the bearer of a message of hope, both as a rich region, because of its history and because it represents an ambitious tradition of social and cultural development,
- I. whereas the European Union can only affirm its identity if it can prove both to the rest of the world, and to its own citizens, that it is not only an economic but also a social union,
- J. whereas the Treaty on European Union has given both sides of industry new responsibilities, and they have a duty to play an active part in social development both within the Union and with our economic partners,
- K. whereas over one billion people worldwide constantly live in abject poverty and, according to UN statistics, 18 million deaths annually are caused by factors directly related to poverty,
- L. whereas one tenth of the world's population have no form of employment which could provide them with even basic nutrition,

1. Notes the increase in world summits and considers that if such summits, including the Copenhagen World Summit for Social Development, are to be successful, a sustained effort must be made at the level of the United Nations with the full cooperation of the member states to ensure that the commitments entered into by national governments are speedily put into effect and regularly monitored;

2. Considers that the European Union, which has set itself as one of its prime objectives 'the promotion of economic and social progress which is balanced and sustainable' is in a unique position to contribute positively to the successful outcome of the Copenhagen Conference and, in this regard, highlights the agreement made by the Labour and Social Affairs Council in December to examine positively the commitments to be proposed to the Summit, including the commitment to increase significantly resources for social development and allocate them more efficiently, through national action and international cooperation;

3. Recognizes that the subjects considered are of crucial importance for the future of our troubled societies;

Measures to be taken at national level

4. Approves the declarations which the UN member states, according to the Draft Final Declaration and Action Programme, propose to take in the context of the Copenhagen Summit to create an economic, political and legal environment favourable to social development, to combat poverty and all forms of social exclusion, to increase the number of productive jobs, to promote social integration, to implement full equality between men and women, to ensure that structural adjustment programmes include social development objectives, to increase the resources allocated for social development, and to enhance international cooperation on social development;

5. Stresses in particular the individual importance of programmes in favour of women and measures to achieve social development, without which no lasting prosperity and no sustainable mutually supportive communities can be maintained; underlines the importance of measures for young people, the elderly and the disabled;

6. Calls for the ratification and implementation by the year 2000 of all the provisions of the Convention on the Elimination of All Forms of Discrimination against Women, the Nairobi programme of action for women, the Geneva declaration concerning women in rural sectors and the programme of action adopted by the international conference on population and development in Cairo;

7. Recognizes that debt represents a huge obstacle to development, particularly as regards the poorest countries; and calls accordingly for the alleviation of debt to be tackled as a top priority; considers that the European Union should take debt reduction and rescheduling measures, in particular for the Lomé countries, for whom the European Union has a particular responsibility;

Measures to be taken with regard to international solidarity

8. Considers that the European Union, whose economy depends to a far greater extent on trade with the rest of the world than do those of the other great economic areas, consequently has a special responsibility in this field; considers it important for the European Union, as a regional cooperation organization, to give the right example and also make a clearly-defined contribution to the follow-up process of the summit conference by selecting a number of measures for the purposes of job creation, combating poverty and promoting social integration;

9. Stresses that a further contribution towards social development should come from the expansion of free and fair trade; in this regard, believes that access to the EU market should be improved for goods of countries that, with a view to combating the spread of ecological and social dumping, make concrete steps towards respecting the agreements of the International Labour Organization especially concerning:

- (a) child labour;
- (b) forced labour;
- (c) freedom of association of workers and the right to organize and bargain collectively;
- (d) elimination of discrimination;
- (e) social minimum standards;

10. Calls for a reduction in the arms trade and in arms exports; expects developing countries to cut their military and arms expenditure and devote the funds to better medical care and education for their peoples;

11. Considers that the trend towards the globalization of economies and the emergence of a world market provides a positive environment for social development through trade and the free flow of financial resources but can only serve social development if sufficient financial resources are made available to developing countries and in this context:

- stresses that, to maximize the beneficial effects of this new environment, adequate funding should be directed towards productive investment of which 20% should be social-oriented; it should enhance the competitive advantage of developing countries and create the premises for sustainable development; such a development policy should promote the selection of projects that are labour-intensive and the evaluation of those projects to reduce environmental damage;
- supports a new multiannual development programme;
- calls on the industrialized nations to demonstrate their willingness to contribute through development aid to the alleviation of poverty and the elimination of its causes and to earmark at least 1% of their GNP for this purpose;

12. Calls on the Commission to examine ways in which the Union can take the initiative in introducing a levy of 0,05% on speculative currency movements with a view to generating new financial resources for an international social development fund;

13. Considers the existence of political stability within a democratic institutional framework an essential condition of sustainable economic and social development; acknowledges that the absence of a stable institutional environment based on the rule of law is a powerful deterrent against productive investment in developing countries and countries with economies in transition;

14. Considers that the governments and organizations represented at the Copenhagen Summit should adopt as a common goal the creation of secure, sustainable and properly-paid employment; to this end, account must be taken of the basic principles and fundamental rights embodied in the ILO conventions; priority must be given to prohibiting forced labour and child labour, the right of association and collective bargaining and the principle of non-discrimination;

15. Considers that the Union should call for resources for developing countries to be used to fund the creation of environmentally compatible and socially useful jobs in those countries, particularly those linked to environmental protection, rural and urban employment, SMEs and very small enterprises, education, training, lifelong learning, health and public works and to tackling the problems associated with social exclusion;
16. Requests a closer coordination of policies between the main bodies involved in development funding, like the World Bank and the International Monetary Fund, with the other relevant bodies of the UN, as well as an improvement in their functioning, in order to have a better implementation of the goals and commitments agreed to by the Summit;
17. Urges the EU to set up an 'export guarantee scheme' providing sufficient insurance coverage against 'country-risk' in developing countries, as a concrete incentive for steering more financial resources to these countries; strongly suggests that such a scheme be funded by Member States according to the basis of their contributions to the EU budget; calls on the Member States of the EU to provide guarantees for productive investments in developing countries;
18. Welcomes the fact that the General Affairs Council of 19 December 1994 agreed to include the following additional provisions in the Union's new system of generalized tariff preferences for the period 1995 to 1998:
 - the launching, as of 1 January 1998, of special incentive schemes in the form of an additional preferential margin for all countries respecting certain social provisions concerning the rights of association and collective bargaining (social incentive clause);
 - the possibility of total or partial temporary withholding of benefits under the generalized system of preferences from countries engaging in any form of slavery or exporting products manufactured in prisons (social penalty clause);
19. Declares its willingness to support, within the framework of the WTO, an in-depth discussion between all contracting parties on the link between respect for fundamental social rights and international trade and, to this end, requests the Commission and Member States of the Union to take all necessary steps to launch a serious dialogue on this subject with the developing countries and, on the other hand, calls on the developing countries not to reject the idea of such a dialogue; calls also on the Secretary-General of the WTO to set up as soon as possible within the WTO a task-force on social development to be concerned with poverty and social exclusion;
20. Considers that further thought is necessary on the indicators of social development along the lines established by the OECD and the European Union;
21. Calls on the European Union, for the purposes of granting development aid programmes, firstly to bear in mind that developing countries, in particular the poorest among them, must be assisted – in addition to employer organizations and trade unions, the NGOs, agricultural organizations and cooperatives also have an important role to play – and secondly to establish specific social development objectives in accordance with a timetable based on the level of development, and objectives in respect of nutrition, primary education, housing, drinking water supplies, basic health infrastructures, education, sanitation, employment, fair access to the market and the means of production, progressively developing welfare arrangements, higher education and continuing training;
22. Recognises the important and additional contribution made by NGOs, especially voluntary organizations, in dealing with poverty, social exclusion and homelessness, and in helping to alleviate the economic, social and health problems related to famine and civil wars; believes that these groups should be supported in every possible way at national and European Union level to enable them to continue to carry out their invaluable humanitarian work;

23. Asks that special attention be paid to the needs of small island communities and land-locked developing countries in implementing the outcome of the Social Summit;
24. Welcomes the commitment in the draft Copenhagen Final Declaration and Action Programme to address the problems of crime, violence and illicit drugs as factors of social disintegration but regrets that it is limited to actions to be undertaken at national rather than international level;
25. Urges the United Nations and other countries involved to closely follow-up the implementation of the commitments and particularly the Action Programme adopted in Copenhagen and to strengthen the role of the Economic and Social Council in this context;
26. Supports Jacques Delors' proposal to create a security council for economic and social issues, by analogy with the UN Security Council;
27. Believes that, given their know-how and availability, it is essential for NGOs to be fully involved as equal partners in implementing the recommendations contained in the final declaration of the Copenhagen Summit;
28. Urges that the International Labour Organization play a central role in the follow-up to the summit conference in view of its impressive record of achievement, in terms of not only employment but also support for social progress;
29. Considers that the dialogue between the two sides of industry must be promoted at international level, a suitable instrument for this purpose being the tripartite consultation referred to in ILO Convention No 144 which should be adopted by all ILO member countries;
