**COUNCIL RESOLUTION****of 17 June 1999****on equal employment opportunities for people with disabilities**

(1999/C 186/02)

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community,

- (1) an essential objective of the Community, as identified in the coordinated European employment strategy, is to promote a high level of employment;
- (2) in the 1999 employment guidelines<sup>(1)</sup>, guideline 9 acknowledges the need for the Member States to 'give special attention to the needs of the disabled, ethnic minorities and other groups and individuals who may be disadvantaged, and develop appropriate forms of preventive and active policies to promote their integration into the labour market';
- (3) in its recommendation of 24 July 1986<sup>(2)</sup>, the Council recognised the key issues of the integration of people with disabilities in vocational training and employment;
- (4) the Community Charter on the fundamental social rights of workers of 9 December 1989 stipulates in point 26: 'All disabled persons, whatever the origin and nature of their disability, must be entitled to additional concrete measures aimed at improving their social and professional integration. These measures must concern, in particular, according to the capacities of the beneficiaries, vocational training, ergonomics, accessibility, mobility, means of transport and housing';
- (5) in their resolution of 20 December 1996 on equality of opportunity for people with disabilities<sup>(3)</sup>, the Council and the representatives of the Governments of the Member States meeting within the Council reaffirmed their commitment to the principle of equality of opportunity in the development of comprehensive policies in the field of disability;
- (6) the Commission of the European Communities formulated fundamental policy issues concerning the disabled and employment in a document of 22 September 1998 entitled 'Raising employment levels of people with disabilities — the common challenge', taking into account the European employment strategy and the analysis of some key elements of the 1998 national action plans; the Commission also concluded that there must be a move away from piecemeal initiatives and that a coordinated strategy must be established;
- (7) in order to establish equal opportunities for people with disabilities with regard to securing, retaining and advancing in employment,
  - Convention 159 and Recommendation 168 of the International Labour Organisation concerning vocational rehabilitation and employment (disabled persons) of 20 June 1983,
  - the Council of Europe Recommendation No R(92) 6 of 9 April 1992 for a coherent policy for disabled people, and
  - the standard rules on the equalisation of opportunities for persons with disabilities which were adopted in a United Nations General Assembly resolution on 20 December 1993,call upon the Member States to develop, evaluate and review support programmes for the integration of people with disabilities in various ways, in particular in the field of employment;
- (8) people with disabilities, despite individual successes and improvements, are still more likely to face barriers and disadvantages in finding and maintaining suitable employment and in fully participating in the economic and social life of their communities,

HEREBY ADOPTS THIS RESOLUTION:

1. The Council acknowledges and welcomes the serious efforts made and planned by the Member States to develop and implement policies aimed at integrating people with disabilities into the labour market, in particular within the

framework of the European employment strategy; it welcomes equally the new impetus by the annual employment guidelines.

goal of equal employment opportunities by sharing and exchanging their experience with all those involved in the labour market.

2. The Council underlines that the national action plans for employment provide a comprehensive platform within which the abovementioned policies should be strengthened. Member States are therefore called upon:

(a) within the framework of their national employment policies, and in cooperation with the social partners and non-governmental organisations for people with disabilities, to place particular emphasis on the promotion of employment opportunities for people with disabilities and to develop suitable preventive and active policies for the specific promotion of their integration into the labour market in the private sector, including self-employment, and in the public sector,

(b) to make full use of the existing and future possibilities of the European Structural Funds, in particular the European Social Fund, and relevant Community initiatives, to promote equal employment opportunities for people with disabilities,

(c) also in the above context, to attach particular attention to the possibilities offered by the development of the information society for opening new employment opportunities but also challenges for people with disabilities.

3. The Council welcomes the initiative of the social partners at European level to identify good practices and invites the social partners at all levels to play an increasing role in creating improved employment opportunities and negotiated work organisation changes in cooperation with people with disabilities.

4. The Council invites people with disabilities themselves and their organisations to make their contribution towards the

5. The Council encourages the Community Institutions to promote equal employment opportunities for people with disabilities within their own services, by enacting rules while taking full advantage of existing legal instruments and practices.

6. The Council calls upon the Commission to work together with the Member States, in particular within the framework of the European employment guidelines and in accordance with the mainstreaming principle, to monitor and analyse the development of the employment of people with disabilities on the basis of comparable data and to develop new strategies and campaigns, taking into consideration national, regional and local differences.

7. The Council affirms that, in the framework of a coherent global policy, equal employment opportunities for people with disabilities will be enhanced if specific attention is given to recruitment and retention of employees, promotion, training, life-long learning and development, and protection against unfair dismissal, and appropriate support provided in areas such as:

— workplace accommodation, such as technical equipment including access to new information and communication technologies,

— access to the place of work,

— qualifications and skills required at work, and

— access to vocational guidance and placement services.

8. The Council notes the Commission's intention to make a proposal for a legal instrument covering equal employment opportunities for people with disabilities.

### Prior notification of a concentration

(Case No IV/M.1588 — Tyco/Raychem)

(1999/C 186/05)

(Text with EEA relevance)

1. On 22 June 1999, the Commission received notification of a proposed concentration pursuant to Article 4 of Council Regulation (EEC) No 4064/89 <sup>(1)</sup>, as last amended by Regulation (EC) No 1310/97 <sup>(2)</sup>, by which the undertaking Tyco International Ltd (Tyco), acquires within meaning of Article 3(1)(b) of the Regulation control of Raychem Corporation (Raychem) by way of purchase of shares.

2. The business activities of the undertakings concerned are:

- Tyco: amongst others, disposable medical supplies, fire detection and suppression systems, security systems, electronic components,
- Raychem: materials science, electronic components, process engineering.

3. On preliminary examination, the Commission finds that the notified concentration could fall within the scope of Regulation (EEC) No 4064/89. However, the final decision on this point is reserved.

4. The Commission invites interested third parties to submit their possible observations on the proposed operation.

## CARNOT

**Call for proposals for actions related to the promotion of the clean and efficient use of solid fuels (1999)**

(1999/C 186/08)

1. Following Council Decision 199/24/EC of 14 December 1998 <sup>(1)</sup> concerning a multiannual programme of technical actions promoting the clean and efficient use of solid fuels (1998 to 2002), the Commission pursuant to Article 5 thereof, invites interested bodies and persons qualified to do so under the terms of paragraph 3 hereunder, to submit proposals for the implementation of actions and measures relating to the clean and efficient use of solid fuels.

2. Carnot is the programme to promote:

— the use of clean and efficient technologies in plants using solid fuels in order to limit emissions, including carbon dioxide emissions, from such use,

— the encouragement of the development of advanced clean solid fuels technologies in order to achieve improved BAT (best available technologies) at affordable cost.

3. Legal entities, organisations, individuals, public and private enterprises, as well as existing Union-wide networks, or temporary grouping of organisations and/or enterprises formed for the purpose of carrying out particular projects, are invited to submit proposals for the implementation of the following actions and measures:

3.1. Measures to foster cooperation aimed at promoting better market and technical information:

— setting up of a documentation and database on European installations for clean and efficient use of solid fuels.

This source of information will be used to 'bottle feed' the specific dissemination activities covered by Carnot and to avoid repeated consultations of 'technology-owners',

— brochure on Carnot technology.

Compilation of a brochure with a visual presentation of a summary of the best European examples of CCT <sup>(2)</sup> (several sectors, different Member States) outlining the main points of Carnot and giving a friendly image for CCT for reliable, cost effective and environmentally compatible use of solid fuels,

— Carnot Project File.

Presentation of European technology in a Project File containing a series of 'flag brochures', classified under process subject headings, describing installations which make clean and efficient use of solid fuels. The Project File will also contain CD-ROMs,

— creation of a website as a showcase for European technology in the clean and efficient use of solid fuels.

This is an important long-term action, intended for a large number of customers, manufacturing industry, power operators, technicians and decision-makers.

The aim is to present commercially operational examples of European CCT plants using modern and accessible tools of communication. This website must be regularly updated. Its main beneficiary, the European CCT industry, must be closely associated to it.

When developing the Carnot website particular attention should be paid to maintaining a balance between the different technologies on the market,

— video-cassette on the contribution of CCT's friendly image.

This is targeted at the general public: schools, television channels, energy agencies, press agencies

and others. In particular presentation on Euronews and other European broadcasts,

- setting up of a One-Stop-Export-Shop designed to promote clean coal technology and equipment on international markets,

The shop aims to support EU-CCT during the pre-investment stages, in particular for SMEs which have neither the financial means nor the necessary infrastructure to enable them to take part in international ventures. The One-Stop-Shop will provide a single contact point where people can obtain information on financial support for projects. It will reduce the 'soft costs' of projects, particularly in the pre-investment phase.

Industry should work closely with the Shop and take responsibility for it.

### 3.2. Measures to foster industrial strategic cooperation

- field trip by Chinese industrialists to the EU

in cooperation with the World Bank clean coal initiative for China and in the context of the clean coal technology (CCT) assessment and environmental control options in China project, a group of Chinese engineers and industry representatives will visit model clean coal plants in Europe,

- field trips by European experts to international cooperation programmes

Carnot experts will take part in field trips organised by the European Union-USAID climate technology cooperation. These joint field trips have been planned following the cooperation actions agreed between the European Commission and the USA Government in order to promote the objectives of the Buenos Aires COP4 in developing countries,

- Carnot-workshops

two workshops are foreseen:

A one-day workshop with industry representatives to inform them about Carnot's objectives and to define strategies;

A one-day workshop on 'The European potential for job creation in the technological and commercial coal chain within Europe', to analyse the scope for job creation (goals mentioned in the Carnot preambles)

in the consultancy, design and coal processing/utilisation plant construction sectors,

- Carnot-studies/-workshops

- study of the size and type of existing electricity-generating capacity using solid fuels within an enlarged EU

This study will help to appraise the current situation of power stations, their technical lifespan and the potential market for CCT in EU and accession countries,

- study/workshop on the renovation options for plants utilising indigenous solid fuels in an enlarged European Union, taking into account environmental and economic factors.

This action is intended to guarantee that the decisions taken are based on economic and environmental factors. Options should take into account the cost/profit aspects of the best available technologies.

- 3.3. The level of funding for the measures under 3.1 shall be between 50 % and 100 % of their total cost. The level of funding for the measures under 3.2 shall be between 30 % and 50 % of their total cost.

In generale, proposals should involve at least two non-affiliated partners from different Member States or the European Economic Area (EEA).

Legal entities in associated central and east European countries may submit proposals and participate in accordance with the conditions, including financial provision, laid down in the additional protocols to the Association Agreements or in the Associated Agreements themselves relating to participation in Community programmes. The Carnot programme shall also be open to Cyprus on the basis of additional appropriations, under the same rules as those applied to the EFTA/EEA countries, in accordance with procedures to be agreed with that country.

Proposals must arrive at the Commission at the address given below before 6 September 1999 (12 noon, Brussels time). No proposal received after the closing date will be considered.

Information given to Community institutions relating to a proposal and to any application or contract will be treated as confidential.

4. Detailed information on the terms of reference of the 1999 actions, procedures and eligibility for the submission of proposals, on the selection criteria, on the principles governing the Community's contribution, and the type of

contract that will be drawn up with successful candidates is available on request from the Commission.
