On 26 August 2011, the Commission received a notification of a proposed concentration pursuant to Article 4 of Council Regulation (EC) No 139/2004 ⁽¹⁾ by which the undertaking 'The Procter & Gamble Company' (USA) acquires within the meaning of Article 3(1)(b) of the Merger Regulation control of parts of the OTC business of Teva Pharmaceutical Industries Ltd (Israel) by way of acquiring shares in a newly created company to which both parties will contribute assets.

2. The business activities of the undertakings concerned are:

— for The Procter & Gamble Company: Beauty and health care,

— for Teva Pharmaceutical Industries Ltd: Manufacture of pharmaceutical preparations.

3. On preliminary examination, the Commission finds that the notified transaction could fall within the scope the EC Merger Regulation. However, the final decision on this point is reserved.

4. The Commission invites interested third parties to submit their possible observations on the proposed operation to the Commission.
