Notice concerning the anti-subsidy measures in force on imports of certain rainbow trout originating in Turkey: change of name of a company subject to the countervailing duty rate for cooperating non-sampled companies

(2019/C 15/03)

Imports of certain rainbow trout originating in Turkey are subject to a definitive countervailing duty, imposed by Commission Implementing Regulation (EU) 2015/309 (1).

Abalıoğlu Yem-Soya Ve Tekstil San A.Ş., TARIC (2) additional code B968, a company subject to the countervailing duty rate for cooperating non-sampled companies of 7,6 %, informed the Commission that it had changed its name to Lezita Balik A.Ş.

The company asked the Commission to confirm that the change of name does not affect the right of the company to benefit from the duty rate applied to the company under its previous name.

The Commission examined the information supplied and concluded that the change of name in no way affects the findings of Implementing Regulation (EU) 2015/309.
