Proceedings of the sitting

IN THE CHAIR: Mr GIL-ROBLES GIL-DELGADO

President

(The sitting opened at 3 p.m.)

1. Resumption of session

The session, adjourned on 17 January, was resumed.

2. Approval of Minutes

Mrs Guigou had informed the Chair that she had intended to vote for the resolution on the revision of the Treaties (B4-0040/97) (Minutes of 16.1.1997, Part I, Item 7(b)).

The following spoke:

- Mrs Oomen-Ruijten, who protested, as Mr Corrie had done on 27 November 1996 (see Minutes of that sitting, Item 2) against the fact that lifts were often blocked before the opening of the sitting by groups of visitors, which meant that Members reached the Chamber late; she asked the President to take measures to rectify the problem;
- Mrs Crawley, who announced that Mr Goldsmith had distributed propaganda in the United Kingdom saying that

Brussels issued 100 regulations every week; she asked the Bureau to examine the accuracy of this information (the President replied that common sense would enable people to understand that such propaganda should not be allowed to succeed);

- Mr Balfe, Quaestor, who noted with regard to Mrs Oomen-Ruijten's remarks that the College of Quastors had already adopted a decision forbidding access to the lifts to visitors during plenary sittings; he asked the President to ensure this decision was implemented;
- Mr Provan, who agreed with Mrs Crawley and added that the media did not always report the Community institutions' work accurately and asked the Bureau to consider ways of remedying this problem;
- Mr Kenneth D. Collins, on Mrs Crawley's remarks;
- Mr Berthu who, with regard to the remarks concerning his group's chairman, pointed out that the word used in the propaganda should not be understood literally but rather as meaning 'acts' (the President said the Bureau would take action to ensure that the truth was known about Parliament's position, and expressed the hope that Mr Oreja, Commissioner responsible, would do the same regarding the Commission).
