#### Proceedings of the sitting

IN THE CHAIR: Mr GIL-ROBLES GIL-DELGADO

President

(The sitting opened at 5 p.m.)

# 1. Resumption of session

The session, adjourned on 6 November 1997, was resumed.

The President welcomed the release the previous day of the Chinese dissident, Wei Jingsheng, who had been awarded the 1996 Sakharov Prize. He also referred to reports just in of a devastating bomb attack perpetrated by extremists in Luxor on two tourist coaches, which had claimed numerous victims. He said that he would send a message of condolences, on behalf of Parliament, to the families of the victims and the authorities of their countries of origin.

# 2. Approval of Minutes

The Minutes of the previous sitting were approved.

The following spoke:

 Mr Corbett, who referred to the arrest of nine Liverpool football fans during a match in Strasbourg the previous month and the eight-month prison sentence to which three of them had been condemned; he felt that this sentence was excessive and called for the President to contact the French Justice Minister, Mrs Guigou, asking her to consider the law applicable in this case (the President replied that it was not Parliament's job to become involved in legal questions in a Member State; all he could do was to consider the matter and possibly ask for them to be treated more leniently);

- Mrs Bloch von Blottnitz, who referred to her remarks on 14 July 1997 (Minutes of that sitting, Item 3) and 17 September 1997 (Minutes of that sitting, Part I, Item 1) in which she had said that she was awaiting a reply following a Council presidency speech at a meeting in Zimbabwe claiming that Parliament had not adopted any position on the CITES, when in fact it had adopted a resolution on the subject; she said that she had still not received any reply (the President said that he would ask the Council why no reply had yet been sent);
- Mrs Diez de Rivera Icaza, who referred to the frequent timetable changes to which the special Air France flight for Spanish Members to Strasbourg was subjected by the authorities at Madrid-Barajas Airport, and asked the President to take action with these authorities; she also thanked Air France for having made it possible for Spanish Members to arrive in Strasbourg on time (the President observed that this state of affairs apparently applied in other cases as well, adding that he would ask the Secretary-General to look into the matter before taking any further action);

- Mr McMillan-Scott who, in his capacity as rapporteur for China, referred to the President's announcement at the opening of the sitting concerning the release of Wei Jingsheng, and then referred to the Labour Party's ban on British members of the PSE Group from making comments on the electoral procedure for European elections (the President cut him off as this subject was not on the agenda and had in any case been referred to the committee responsible which had already dealt with it);
- Mr Andrews, who raised a human rights problem (the President cut him off as this subject was not on the agenda);
- Mr Dupuis, who referred to the President's announcement at the opening of the sitting, asked for Wei Jingsheng, who had not been able to receive his award the previous year, to be enabled to take part in the 1997 Sakharov Prize award ceremony at the next part-session in Strasbourg (the President replied that he would raise the issue at the Conference of Presidents with a view to reaching an agreement on the most appropriate time to invite Wei Jingsheng to Parliament);
- Mr McGowan, on the President's reply to Mr Corbett;
- Mr Fabre-Aubrespy, who referred to the new reference in the final draft agenda to committee meetings 'authorized by the President'; he commented that the reference was no doubt included following the conclusions drawn by the President from the Court of Justice judgement of 1 October 1997 and expressed disappointment that the President had not done likewise for the 1997 part-session calendar. He saw in this a dual interpretation of the Court's judgement (the President replied that it was the Conference of Presidents which had drawn the appropriate conclusions from this judgement: it had decided that it was not feasible to organize an extra part-session in November and had complied with the Edinburgh decision as far as committee meetings were concerned);
- Mr Gallagher, who criticized the President for not allowing Mr Andrews the floor, given that the latter had intended to speak on a question of citizens' rights just as Mr Corbett and Mr McGowan had done.

## Reason for request

For internal reasons, the Commission had been unable to adopt the written procedures concerning these proposals before 22 and 23 October 1997. The time taken to do so meant that there was a risk of the problem of payment being raised and obligations arising from the fisheries agreements being suspended, i.e. in the case of the third countries a suspension of fishing which would be disastrous for the third countries which received financial compensation and the fleets which had been fishing since the date when the new protocols came into force. Such an occurrence would seriously damage the Community's credibility.

Parliament would vote on these requests at the beginning of the following day's sitting.
