# COMMISSION REGULATION (EC) No 24/2007

of 12 January 2007

# establishing the standard import values for determining the entry price of certain fruit and vegetables

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 3223/94 of 21 December 1994 on detailed rules for the application of the import arrangements for fruit and vegetables (1), and in particular Article 4(1) thereof,

Whereas:

(1) Regulation (EC) No 3223/94 lays down, pursuant to the outcome of the Uruguay Round multilateral trade negotiations, the criteria whereby the Commission fixes the

standard values for imports from third countries, in respect of the products and periods stipulated in the Annex thereto.

(2) In compliance with the above criteria, the standard import values must be fixed at the levels set out in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION:

#### Article 1

The standard import values referred to in Article 4 of Regulation (EC) No 3223/94 shall be fixed as indicated in the Annex hereto.

### Article 2

This Regulation shall enter into force on 13 January 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

fixing the minimum selling prices for butter for the 23rd individual invitation to tender under the standing invitation to tender provided for in Regulation (EC) No 1898/2005

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1255/1999 of 17 May 1999 on the common organisation of the market in milk and milk products (1), and in particular Article 10 thereof,

#### Whereas:

(1) In accordance with Commission Regulation (EC) No 1898/2005 of 9 November 2005 laying down detailed rules for implementing Council Regulation (EC) No 1255/1999 as regards measures for the disposal of cream, butter and concentrated butter on the Community market (²), the intervention agencies may sell by standing invitation to tender certain quantities of butter from intervention stocks that they hold and may grant aid for cream, butter and concentrated butter. Article 25 of that Regulation lays down that in the light of the tenders received in response to each individual invitation to tender a minimum selling price shall be fixed for butter and maximum aid shall be fixed for cream, butter and concentrated butter. It is further

laid down that the price or aid may vary according to the intended use of the butter, its fat content and the incorporation procedure. The amount of the processing security as referred to in Article 28 of Regulation (EC) No 1898/2005 should be fixed accordingly.

(2) The measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS REGULATION:

#### Article 1

For the 23rd individual invitation to tender under the standing invitation to tender provided for in Regulation (EC) No 1898/2005 the minimum selling prices for butter from intervention stocks and the amount of the processing security, as referred to in Articles 25 and 28 of that Regulation respectively, are fixed as set out in the Annex to this Regulation.

### Article 2

This Regulation shall enter into force on 13 January 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1255/1999 of 17 May 1999 on the common organisation of the market in milk and milk products (1), and in particular Article 10 thereof,

### Whereas:

(1) In accordance with Commission Regulation (EC) No 1898/2005 of 9 November 2005 laying down detailed rules for implementing Council Regulation (EC) No 1255/99 as regards measures for the disposal of cream, butter and concentrated butter on the Community market (²), the intervention agencies may sell by standing invitation to tender certain quantities of butter of intervention stocks that they hold and may grant aid for cream, butter and concentrated butter. Article 25 of that Regulation lays down that in the light of the tenders received in response to each individual invitation to tender a minimum selling price shall be fixed for butter and maximum aid shall be fixed for cream, butter and concentrated butter. It is further laid down

that the price or aid may vary according to the intended use of the butter, its fat content and the incorporation procedure. The amount of the processing security as referred to in Article 28 of Regulation (EC) No 1898/2005 should be fixed accordingly.

(2) The measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS REGULATION:

### Article 1

For the 23rd individual invitation to tender under the standing invitation to tender provided for in Regulation (EC) No 1898/2005 the amount of the maximum aid for cream, butter and concentrated butter and the amount the processing security, as referred to in Articles 25 and 28 of that Regulation respectively, are fixed as set out in the Annex to this Regulation.

### Article 2

This Regulation shall enter into force on 13 January 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EC) No 1255/1999 of 17 May 1999 on the common organisation of the market in milk and milk products (1), and in particular Article 10 thereof,

### Whereas:

- (1) In accordance with Article 47 of Commission Regulation (EC) No 1898/2005 of 9 November 2005 laying down detailed rules for implementing Council Regulation (EC) No 1255/1999 as regards measures for the disposal of cream, butter and concentrated butter on the Community market (²), the intervention agencies are opening a standing invitation to tender for the granting of aid for concentrated butter. Article 54 of that Regulation provides that in the light of the tenders received in response to each special invitation to tender, a maximum amount of aid is to be fixed for concentrated butter with a minimum fat content of 96 %.
- (2) An end-use security provided for in Article 53(4) of Regulation (EC) No 1898/2005 is to be lodged to

- ensure the taking over of the concentrated butter by the retail trade.
- (3) In the light of the tenders received, the maximum aid should be fixed at the appropriate level and the end-use security should be determined accordingly.
- (4) The measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS REGULATION:

### Article 1

For the 23rd individual tender under the standing invitation to tender opened in accordance with Regulation (EC) No 1898/2005 the maximum amount of the aid for concentrated butter with a minimum fat content of 96 %, as referred to in Article 47(1) of that Regulation, is fixed at 19,27 EUR/100 kg,

The end-use security provided for in Article 53(4) of Regulation (EC) No 1898/2005 is fixed at 21 EUR/100 kg.

### Article 2

This Regulation shall enter into force on 13 January 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

### Whereas:

- (1) Pursuant to Article 21 of Commission Regulation (EC) No 2771/1999 of 16 December 1999 laying down detailed rules for the application of Council Regulation (EC) No 1255/1999 as regards intervention on the market in butter and cream (²), intervention agencies have put up for sale by standing invitation to tender certain quantities of butter held by them.
- (2) In the light of the tenders received in response to each individual invitation to tender a minimum selling price shall be fixed or a decision shall be taken to make no

- award, in accordance with Article 24a of Regulation (EC) No 2771/1999.
- (3) In the light of the tenders received, a minimum selling price should be fixed.
- (4) The Management Committee for Milk and Milk Products has not delivered an opinion within the time limit set by its chairman,

HAS ADOPTED THIS REGULATION:

#### Article 1

For the 55th individual invitation to tender pursuant to Regulation (EC) No 2771/1999, in respect of which the time limit for the submission of tenders expired on 9 January 2007, the minimum selling price for butter is fixed at 236,50 EUR/100 kg.

### **COMMISSION DECISION**

of 22 December 2006

amending Appendix B of Annex VII to the 2005 Act of Accession as regards certain establishments in the meat, milk and fish sectors in Romania

(notified under document number C(2006) 6801)

(Text with EEA relevance)

(2007/23/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Annex VII, Chapter 5, Section B, Subsection I, (e) thereto,

### Whereas:

- (1) Regulation (EC) No 852/2004 of the European Parliament and of the Council of 29 April 2004 on the hygiene of foodstuffs (¹) and Regulation (EC) No 853/2004 of the European Parliament and of the Council of the 29 April 2004 laying down specific hygiene rules for food of animal origin (²) provide for certain structural requirements for establishments falling within the scope of those regulations.
- (2) As Romania is due to accede to the Community on 1 January 2007, Annex VII, Chapter 5, Section B, Subsection I, (a) to the Act of Accession of Bulgaria and Romania provides that certain structural

requirements laid down in those regulations are not to apply to the establishments in Romania listed in Appendix B of Annex VII to the Act of Accession ('the list of establishments') until 31 December 2009, subject to certain conditions.

- (3) In Romania, certain establishments in the meat and milk sectors have completed their upgrading process and are now in full compliance with Community legislation. In addition, certain establishments have ceased their activities. Accordingly, the list of establishments should be amended to take account of such changes.
- (4) Furthermore, in Romania certain meat, milk and fish establishments have difficulties in complying with the relevant structural requirements laid down in Regulations (EC) Nos 852/2004 and 853/2004 due to technical constraints. Those establishments need more time to finalise their upgrading process in order to be in full compliance with the relevant structural requirements laid down in those regulations. Those establishments have to be added to the lists of establishments in transition.
- (5) Many of those establishments in Romania have been funded by the Special Accession Programme for Agriculture and Rural Development. They have all now provided guarantees that they have the necessary funds to remedy their outstanding shortcomings within the transitional period. The detailed information regarding the shortcomings for each establishment is available. Therefore it is also justified to grant a transitional period to these establishments.

- (6) In the interests of clarity of Community legislation, it is appropriate to replace the list of establishment set out in Appendix B of Annex VII to the Act of Accession of Bulgaria and Romania by the list set out in the Annex to this Decision.
- (7) The measures provided for in this Decision are in accordance with the opinion with the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

### Article 1

Appendix B to Annex VII to the Act of Accession of Bulgaria and Romania is replaced by the text in the Annex to this Decision.

### Article 2

This Decision shall apply subject to and as from the date of the entry into force of the Treaty of Accession of Bulgaria and Romania.

### Article 3

This Decision is addressed to the Member States.

### **COMMISSION DECISION**

### of 22 December 2006

### approving contingency plans for the control of avian influenza and Newcastle disease

(notified under document number C(2006) 6806)

### (Text with EEA relevance)

(2007/24/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Article 56 thereof,

Having regard to Council Directive 92/40/EEC of 19 May 1992 introducing Community measures for the control of avian influenza (1), and in particular the second subparagraph of Article 17(4) thereof,

Having regard to Council Directive 92/66/EEC of 14 July 1992 introducing Community measures for the control of Newcastle disease (²), and in particular the second subparagraph of Article 21(4) thereof,

### Whereas:

- (1) Directives 92/40/EEC and 92/66/EEC set out the control measures to be applied in the event of an outbreak of avian influenza and Newcastle disease respectively, as well as certain preventive measures aimed at increasing the awareness and preparedness of the competent authorties and the farming community concerning those diseases. Pursuant to these Directives the contingency plans of the Member States for the control of avian influenza and Newcastle disease are to be approved by the Commission.
- (2) Commission Decision 2004/402/EC of 26 April 2004 approving contingency plans for the control of avian influenza and of Newcastle disease (3) approves those contingency plans for the present Member States. The Annex to that Decision lists the Members States whose plans have been approved.
- (3) Bulgaria and Romania are due to accede to the Community on 1 January 2007. Accordingly, Bulgaria

and Romania have submitted their contingency plans for the control of avian influenza and Newcastle disease to the Commission for approval.

- (4) Those contingency plans as amended by Bulgaria and Romania following the suggestions made during their evaluation, fulfil the criteria laid down in Directives 92/40/EEC and 92/66/EEC and, subject to a regular update and an effective implementation, permit the desired objectives of those Directives to be attained and should therefore be approved.
- (5) For the sake of clarity of Community legislation, Decision 2004/402/EC should be repealed and replaced by this Decision.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

### Article 1

The contingency plans submitted by Bulgaria to the Commission on 7 November 2006 for the control of avian influenza and Newcastle disease are approved.

### Article 2

The contingency plans submitted by Romania to the Commission on 9 November 2006 for the control of avian influenza and Newcastle disease are approved.

### Article 3

The Annex sets out the list of Member States having approved contingency plans for the control of avian influenza and Newcastle disease.

### Article 4

Decision 2004/402/EC is repealed.

as regards certain protection measures in relation to highly pathogenic avian influenza and movements of pet birds accompanying their owners into the Community

(notified under document number C(2006) 6958)

(Text with EEA relevance)

(2007/25/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Regulation (EC) No 998/2003 of 26 May 2003 of the European Parliament and of the Council on the animal health requirements applicable to the non-commercial movement of pet animals and amending Council Directive 92/65/EEC (1), and in particular Article 18 thereof,

Whereas:

- (1) Following the outbreak of avian influenza in southeastern Asia in 2004, caused by a highly pathogenic strain of the virus, the Commission adopted several protection measures in relation to that disease. Those measures include in particular Commission Decision 2005/759/EC of 27 October 2005 concerning certain protection measures in relation to highly pathogenic avian influenza in certain third countries and the movement from third countries of birds accompanying their owners (2). Decision 2005/759/EC currently applies until 31 December 2006.
- (2) Avian influenza outbreaks caused by the highly pathogenic avian influenza strain H5N1 are still detected on a regular basis in certain member countries of the World Organisation for Animal Health (OIE), including countries not affected before. The disease is therefore not yet contained. Furthermore, human cases and even deaths resulting from close contact with infected birds continue to occur in countries around the globe.
- (3) Following a request by the Commission, the EFSA Panel on animal health and welfare (AHAW) adopted during its meeting on 26 and 27 October 2006 a Scientific Opinion on the Animal health and welfare risks associated with the import of wild birds other than poultry

into the Community. This opinion points to the risks of the spreading of viral diseases such as avian influenza and Newcastle Disease via the import of birds other than poultry and identifies possible tools and options which can reduce any identified animal health risk related to the import of these birds. Furthermore the opinion points out that it is seldom possible to distinguish with certainty between birds 'caught in the wild' and 'captive bred' birds, since methods of marking can be applied to the different types of birds without it being possible to distinguish between them.

- (4) These conclusions can also be applied to the movement of pet birds from third countries. In order to guarantee a clear distinction between captive birds caught in the wild for commercial importation and pet birds, movement of live pet birds should continue to be subjected to strict conditions, without distinction in country of origin, in order to ensure the status of the pet birds and to prevent the spreading of those viral diseases. It is therefore appropriate to extend the application of the measure established by Decision 2005/759/EC until 31 December 2007.
- (5) Since its coming into force Decision 2005/759/EC has been amended several times. For the sake of clarity of Community legislation, Decision 2005/759/EC should be repealed and replaced by this Decision.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

### Article 1

### Movement from third countries

- 1. Member States shall authorise the movement from third countries of live pet birds solely where the consignment consists of not more than five birds and:
- (a) the birds come from an OIE member country falling within the competence of a Regional Commission listed in Part A of Annex I, or

- (b) the birds come from an OIE member country falling within the competence of a Regional Commission listed in Part B of Annex I on condition that the birds:
  - (i) have undergone isolation for 30 days prior to export at the place of departure in a third country listed in Council Decision 79/542/EEC (¹), or
  - (ii) undergo quarantine for 30 days after import in the Member State of destination on premises approved in accordance with Article 3(4) of Commission Decision 2000/666/EC (²), or
  - (iii) have, within the last six months and not later than 60 days prior to dispatch from the third country, been vaccinated, and at least on one occasion revaccinated, against avian influenza using an H5 vaccine approved for the species concerned in accordance with the manufacturer's instructions, or
  - (iv) have been in isolation for at least 10 days prior to export and have undergone a test to detect the H5N1 antigen or genome as laid down in Chapter 2.1.14 of the Manual of Diagnostic Tests and Vaccines for Terrestrial Animals carried out on a sample taken not earlier than the third day of isolation.
- 2. Compliance with the conditions in paragraph 1 shall be certified by an official veterinarian, in the case of the conditions provided for in paragraph 1(b)(ii) based on owner's declaration, in the third country of dispatch in accordance with the model certificate provided for in Annex II.
- 3. The veterinary certificate shall be complemented by a declaration of the owner or the representative of the owner in accordance with Annex III.

### Article 2

### Veterinary checks

1. Member States shall take the measures necessary to ensure that pet birds moved into Community territory from a third country are subject to documentary and identity checks by the competent authorities at the traveller's point of entry into Community territory.

- 2. Member States shall designate the authorities referred to in paragraph 1 which is responsible for such checks and immediately inform the Commission thereof.
- 3. Each Member State shall draw up a list of points of entry as referred to in paragraph 1 and forward it to the other Member States and to the Commission.
- 4. Where such checks reveal that the animals do not meet the requirements laid down in this Decision, the third subparagraph of Article 14 of Regulation (EC) No 998/2003 shall apply.

### Article 3

This Decision shall not apply to the movement onto Community territory of birds accompanying their owners from Andorra, Croatia, the Faeroe Islands, Greenland, Iceland, Liechtenstein, Monaco, Norway, San Marino, Switzerland and the Vatican City State.

### Article 4

Member States shall immediately take the necessary measures to comply with this Decision and publish those measures. They shall immediately inform the Commission thereof.

### Article 5

Decision 2005/759/EC is repealed.

### Article 6

This Decision shall apply until 31 December 2007.

### Article 7

This Decision is addressed to the Member States.

# amending the Appendix to Annex VI to the Act of Accession of Bulgaria and Romania as regards certain milk processing establishments in Bulgaria

(notified under document number C(2006) 6960)

#### (Text with EEA relevance)

(2007/26/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular the first subparagraph of paragraph (f) of Chapter 4 of Section B of Annex VI thereto,

#### Whereas:

- (1) Bulgaria has been granted transitional periods by the Act of Accession of Bulgaria and Romania for compliance by certain milk processing establishments with the requirements of Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin (¹). Certain establishments which are authorised to process non-compliant milk are listed in Chapter I, and certain establishments which are authorised to process both compliant and non-compliant milk, provided that such processing is carried out on separate production lines are listed in Chapter II, of the Appendix to Annex VI to that Act.
- (2) A number of the establishments currently listed in Chapter I of that Appendix have ceased the activities covered by the transitional periods. Those establishments should therefore be deleted from that list.
- (3) In view of the evolution of the quality of the raw milk and the present proportion of production of raw milk in Bulgaria that does not comply with the requirements of Regulation (EC) No 853/2004, certain establishments should be included in the list set out in Chapter I of that Appendix to Annex VI of the Act of Accession.

- (4) Furthermore, certain milk processing establishments in Bulgaria have the capacity and equipment to process compliant and non-compliant milk on separate production lines. Those establishments should be included on the list set out in Chapter II of that Appendix.
- (5) Therefore, the Appendix to Annex VI to the Act of Accession should be amended. For the sake of clarity, that Appendix should be replaced by the text in the Annex to this Decision.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

# Article 1

The Appendix to Annex VI to the Act of Accession of Bulgaria and Romania is replaced by text in the Annex to this Decision.

#### Article 2

This Decision shall apply subject to and as from the date of the entry into force of the Act of Accession of Bulgaria and Romania.

adopting certain transitional measures concerning deliveries of raw milk to processing establishments and the processing of this raw milk in Romania with regard to the requirements of Regulation (EC) Nos 852/2004 and 853/2004 of the European Parliament and of Council

(notified under document number C(2006) 6963)

#### (Text with EEA relevance)

(2007/27/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Article 42 thereof,

Whereas:

- Regulation (EC) No 852/2004 of the European (1)Parliament and of the Council of 29 April 2004 on the hygiene of foodstuffs (1) lays down general rules for food business operators on the hygiene of foodstuffs, based on hazard analysis and critical control points principles. It provides that food business operators are to comply with the structural requirements based on those principles. Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin (2) supplements the rules laid down in Regulation (EC) No 852/2004. The rules laid down in Regulation (EC) No 853/2004 include specific requirements for milk processing establishments, as well as hygiene requirements concerning raw milk and dairy products.
- (2) Romania is due to accede to the Community on 1 January 2007. In preparation for that accession, milk processing establishments are undergoing the necessary structural improvements in order to comply with the

structural requirements laid down in Regulation (EC) No 852/2004. Since 2004 the number of establishments in compliance with Community structural requirements has increased from 12 to 123.

- (3) However, the proportion of raw milk that complies with the hygiene requirements, laid down in Regulation (EC) No 853/2004, delivered to milk processing establishments that comply with the structural requirements of Regulation (EC) No 852/2004 has only increased slightly. In 2005 out of the total production of 5,6 Mio t raw cow milk per year, 0,38 Mio t compliant raw milk was delivered to milk processing establishments.
- (4) Taking into account the current situation, it is appropriate to provide for transitional measures as regards the organisation of the milk sector in Romania.
- (5) In this respect, Annex VII, Chapter 5, Subsection I, point (c) of the Act of Accession of Bulgaria and Romania, authorises temporarily certain milk processing establishments that do not comply with the structural requirements laid down in Regulations (EC) No 852/2004 to receive deliveries of raw milk that does not comply with the relevant hygiene requirements laid down in Regulation (EC) No 853/2004 ('non-compliant milk').
- Milk production holdings that do not comply with the hygiene requirements set out in Regulation (EC) No 853/2004 and milk processing establishments that do comply with the structural requirements set out in Regulation (EC) No 852/2004 are spread over the whole territory of Romania. Accordingly, certain of the compliant establishments receive raw milk that complies with the relevant hygiene requirements set out in Regulation (EC) No 853/2004 ('compliant milk') as well as non-compliant milk. Therefore, the marketing of final products from the compliant establishments should be restricted to Romania. In addition, a list of those compliant establishments should be set out in this Decision.

- (7) Furthermore, certain compliant establishments intend to process separately compliant and non-compliant milk. It is therefore necessary to establish the conditions as regards the collection and treatment of such milk and the marketing of the final products thereof. A list of those compliant establishments processing those two types of milk should also be set out in this Decision.
- (8) The transitional period granted should be limited to 18 months. The situation of the milk sector in Romania is to be reviewed before the end of that period. Accordingly, it is appropriate that Romania submit annual reports to the Commission regarding progress in the upgrading of milk production holdings supplying raw milk to compliant establishments.
- (9) The measures provided for in this Decision are in accordance with the opinion with the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

#### Article 1

# Lists of compliant establishments

Chapters I and II of the Annex to this Decision set out lists of milk processing establishments in Romania that comply with the structural requirements of Regulation (EC) No 852/2004, Annex II, Chapter II ('compliant establishments') and are authorized to receive and process raw milk which is not in compliance with Chapter I Part III, 3 and Chapter II Part III of Section IX of Annex III to Regulation (EC) No 853/2004 (non-compliant milk).

# Article 2

# Deliveries of non-compliant milk and processing in compliant establishments listed in Chapter I of the Annex

- 1. The compliant establishments listed in Chapter I of the Annex to this Decision may receive and process non-compliant raw milk.
- 2. As long as the establishments referred to in paragraph (1) benefit from the provisions of that paragraph products originating from compliant establishments listed in Chapter I of the Annex shall:
- (a) only be placed on the domestic market or used for further processing in other compliant establishments listed in Chapter I of the Annex, irrespective of the date of marketing;

(b) bear a different identification mark from those provided for in Article 5(1) of Regulation (EC) No 853/2004.

#### Article 3

# Deliveries of compliant and non-compliant milk and processing in compliant establishments listed in Chapter II of the Annex

The compliant establishments listed in Chapter II of the Annex to this Decision may receive and process raw milk which complies with the requirements set out in Chapter I, Part III, 3 and Chapter II, Part III of Section IX of Annex III to Regulation (EC) No 853/2004 ('compliant milk') and non-compliant milk on separate production lines provided that the food business operators of such establishments:

- (a) comply with Article 5 of Regulation (EC) No 852/2004;
- (b) demonstrate their capacity to comply with the following conditions, including designating the separate production lines:
  - (i) to take all necessary measures to allow for the proper observance of in-house procedures for the separation of raw milk from collection up to the final production stage, including routes of milk collection, separate storage and treatment of both compliant and non-compliant milk and specific packaging and labelling of dairy products whether or not they are derived from compliant or non-compliant milk, as well as separate storage of such milk;
  - (ii) to establish a procedure ensuring raw milk traceability, including the necessary documentary evidence of product movements and the accountancy for dairy products and the reconciliation of compliant and non-compliant milk with the categories of dairy products produced;
  - (iii) to expose all raw milk to heat treatment at a temperature of minimum 71,7 °C for 15 seconds;
  - (iv) to take all appropriate measures to ensure that identification marks referred to Annex II, Section I of Regulation (EC) No 853/2004 are not used fraudulently.

#### Article 4

# Duties of competent authorities in Romania concerning compliant establishments listed in Chapter II of the Annex

- 1. The competent authorities in Romania shall:
- (a) ensure that food business operators of compliant establishments listed in Chapter II of the Annex take all necessary measures to allow for the proper observance of in-house procedures for the separation of raw milk and dairy products;
- (b) conduct tests and unannounced controls in compliant establishments listed in Chapter II of the Annex relating to their observance of raw milk and dairy products separation;
- (c) conduct tests in approved laboratories on all raw milk and finished products from compliant establishments listed in Chapter II of the Annex to this Decision to verify their compliance with the requirements of Chapter II of Section IX of Annex III to Regulation (EC) No 853/2004, including the microbiological criteria for dairy products.
- 2. The milk and dairy products originating in the compliant establishments listed in Chapter II of the Annex processed from non-compliant raw milk may only be placed on the domestic market or used for further processing in other such establishments or establishments listed in Chapter I and bear a different identification mark from those provided for in Article 5(1) of Regulation (EC) No 853/2004.
- 3. Only dairy products, produced in compliant milk establishments listed in Chapter II of the Annex to this Decision and complying with paragraphs 1 of this Article and the requirements of Annex III, Section IX of Regulation (EC) No 853/2004, may be marketed as compliant products complying with the provisions of that Regulation.

#### Article 5

# Compliance and reports

- 1. Romania shall ensure the gradual compliance by the milk production holdings, referred to in Article 2(1) of this Decision, with the requirements Annex III, Section IX, Chapter I, parts II and III of Regulation (EC) No 853/2004.
- 2. Romania shall submit annual reports to the Commission on progress made in upgrading milk production holdings and the milk collection system.

#### Article 6

Milk and milk products produced under the provisions referred to in Articles 3 and 4 of the present Decision shall only be granted support under Title I, Chapters II and III, except Article 11 thereof, and Title II of Council Regulation (EC) No 1255/1999 (¹) if they carry the oval identification mark referred to in Annex II, Section I, of Regulation (EC) No 853/2004.

#### Article7

# Applicability

This Decision shall apply subject to and as from the date of the entry into force of the Treaty of Accession of Bulgaria and Romania.

It shall apply until 30 June 2008.

# Article 8

#### Addressees

This Decision is addressed to the Member States.

# amending Decision 2005/393/EC as regards restricted zones in relation to bluetongue

(notified under document number C(2006) 6970)

## (Text with EEA relevance)

(2007/28/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Directive 2000/75/EC of 20 November 2000 laying down specific provisions for the control and eradication of bluetongue (¹), and in particular Article 8(3) thereof,

#### Whereas:

- (1) Directive 2000/75/EC lays down control rules and measures to combat bluetongue in the Community, including the establishment of protection and surveillance zones and a ban on animals leaving those zones.
- (2) Commission Decision 2005/393/EC of 23 May 2005 on protection and surveillance zones in relation to bluetongue and conditions applying to movements from or through these zones (²) provides for the demarcation of the global geographic areas where protection and surveillance zones ('the restricted zones') are to be established by the Member States in relation to bluetongue.
- (3) On 20 November 2006 Spain informed the Commission that serotype 4 virus has been detected as circulating in a peripheral area of restricted zone E. Consequently that zone should be extended, taking into account of the data available on the ecology of the vector and the current meteorological situation.
- (4) On 21 November 2006 Germany informed the Commission of new outbreaks of bluetongue in Lower Saxony. In view of those findings, it is appropriate to amend the demarcation of the restricted zone in Germany.
- (5) Following the notification of outbreaks of bluetongue in early November 2006 by Italy, due to a new serotype, by

Decision 2006/858/EC, a new restricted zone G has been added to Annex I to Decision 2005/393/EC to include the three concerned provinces of southern Sardinia. However, the reference to this zone in the respective provisions of Decision 2005/393/EC has not been added. Therefore, for the sake of clarity, the list of zones referred to in Article 2 of Decision 2005/393/EC should be completed.

- (6) Decision 2005/393/EC should be amended accordingly.
- (7) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health.

HAS ADOPTED THIS DECISION:

#### Article 1

Decision 2005/393/EC is amended as follows:

- 1. The first paragraph of Article 2 is replaced by the following:
  - 'Restricted zones shall be demarcated within the global geographical areas listed in the zones set out in Annex I.'
- 2. Annex I is amended in accordance with the Annex to this Decision.

# Article 2

laying down transitional measures for certain products of animal origin covered by Regulation (EC) No 853/2004 of the European Parliament and of the Council introduced into Bulgaria and Romania from third countries before 1 January 2007

(notified under document number C(2006) 7019)

#### (Text with EEA relevance)

(2007/29/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Article 42 thereof,

Whereas:

- (1) Bulgaria and Romania are to accede to the Community on 1 January 2007. Certain products of animal origin coming from third countries introduced into Bulgaria and Romania from third countries before that date do not comply with the relevant Community rules set out in Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin (1).
- (2) Some of those products have been released for free circulation in Bulgaria and Romania while others have not yet been placed under the customs procedure and are still under customs supervision in those two countries.
- (3) In order to facilitate the transition from the existing regime in Bulgaria and Romania to that resulting from the application of Community legislation, it is appropriate to lay down transitional measures for the marketing of those products.
- (4) It is also appropriate to provide that products that do not comply with Community legislation are not introduced into other Member States. They should only be placed on the domestic markets of Bulgaria and Romania or exported to a third country under appropriate conditions. Furthermore, taking into account, that the current traceability system is not sufficient, those non-compliant products should not be processed by establishments authorised to dispatch their products to the Community.

- (5) After one year from the date of Accession, products that have not yet been released for free circulation in those two countries or exported and remain in storage under customs supervision should be destroyed.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

#### Article 1

#### Scope

This Decision shall apply to products of animal origin which:

- (a) fall within the scope of Regulation (EC) No 853/2004 but do not comply with the requirement of that Regulation; and
- (b) were introduced into Bulgaria and Romania from third countries before 1 January 2007.

#### Article 2

# Products of animal origin released for free circulation before 1 January 2007

1. The products referred to in Article 1 ('products of animal origin') that have been released for free circulation in Bulgaria and Romania ('the new Member States') before 1 January 2007 may only be placed on their national markets until 31 December 2007.

The products of animal origin:

- (a) must not be processed by establishments authorised to dispatch their products to other Member States; and
- (b) must bear the national mark provided for by the national rules of that new Member State at the date of release for free circulation.

- 2. Member States shall ensure, in accordance with Council Directive 89/662/EEC ( $^1$ ), and in particular Article 3 thereof, that the products of animal origin are not traded between Member States.
- 3. By way of derogation from paragraph 1, the new Member States may, until 31 December 2007, authorise the export of the products of animal origin to a third country under the following conditions:
- (a) the export must be carried out in accordance with Article 12 of Regulation (EC) No 178/2002 of the European Parliament and of the Council (2);
- (b) each consignment must be transported directly to the third country under the supervision of the competent authority without crossing the territory of other Member States;
- (c) each consignment must be exported in a means of transport sealed by the competent authority and the seals must be checked at the point of exit of the new Member State.

#### Article 3

# Products of animal origin introduced into the new Member States but not released for free circulation before 1 January 2007

1. Products of animal origin introduced into the new Member States, but not released for free circulation in the new Member States before 1 January 2007, shall be subject to the rules laid down in paragraphs 2 and 3.

- 2. The products of animal origin may be released for free circulation in the new Member States or dispatched to a third country in accordance with the conditions set out in Article 2.
- 3. From 1 January 2008, any consignments of products of animal origin under customs supervision shall be destroyed under the control of the competent authority.

All costs of such destruction shall be chargeable to the owner of the consignment.

#### Article 4

#### Application

This Decision shall apply subject to and as from the date of the entry into force of the Act of Accession of Bulgaria and Romania.

#### Article 5

#### Addressees

This Decision is addressed to the Member States.

# laying down transitional measures for the marketing of certain products of animal origin obtained in Bulgaria and Romania

(notified under document number C(2006) 7028)

#### (Text with EEA relevance)

(2007/30/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania (1), and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania (2) and in particular Article 42 thereof,

Whereas:

- (1) From 1 January 2007, products of animal origin obtained in Bulgaria and Romania (the new Member States), will have to be placed on the market in compliance with the relevant Community rules in particular as regards the structure of and hygiene in establishments and the control and the health marking of the products.
- In particular, those products will be subject to the (2)requirements laid down in Regulation (EC) No 852/2004 of the European Parliament and of the Council of 29 April 2004 on the hygiene of foodstuffs (3) and Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin (4).
- (3) Certain products of animal origin obtained in Bulgaria and Romania before 1 January 2007 may be in stock after this date. However, those products of animal origin may not comply with all the Community veterinary requirements.

- In order to facilitate the transition from the existing regime in Bulgaria and Romania to that resulting from the application of the Community veterinary legislation, it is appropriate to lay down transitional measures for the marketing of those products.
- Those measures should take account of the origin of (5) those products of animal origin as well as the stocks of packaging and packing and labels material bearing printed marks.
- The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

# Article 1

This Decision shall apply to products of animal origin which:

- (a) fall within the scope of Regulation (EC) No 853/2004; and
- (b) were obtained in establishments in Bulgaria and Romania until 31 December 2006.

#### Article 2

- Products referred to in Article 1 may from 1 January to 31 December 2007 be placed on the market in the new Member States of origin provided that they bear the national mark prescribed in that new Member State before 1 January 2007 for products of animal origin fit for human consumption.
- Member States shall ensure, in accordance with Council Directive 89/662/EEC (5) and in particular Article 3 thereof, that products referred to in paragraph 1 are not traded between Member States.

#### Article 3

By way of derogation from Article 2(1), Member States shall from 1 January to 31 December 2007 authorise the trade in products referred to in Article 1 which are obtained in establishments authorised to export to the Community provided that the products:

- (a) bear the Community export health mark or identification mark as provided for in Article 5(1) of Regulation (EC) No 853/2004 of the establishments concerned;
- (b) are accompanied by a document as provided for in Article 14 of Regulation (EC) No 854/2004 of the European Parliament and of the Council (¹) in which the competent authority of the new Member States of origin certifies the following:

'Produced before 1 January 2007, in conformity with Commission Decision 2007/30/EC'.

#### Article 4

Stocks of reprinted wrapping and packaging material and labels bearing the mark prescribed in the new Member State of origin before 1 January 2007 for products of animal origin fit for human consumption, may be used until 31 December 2007, for the placing on the domestic market as provided for in Article 2.

#### Article 5

This Decision shall apply subject to and as from the date of entry into force of the Treaty of Accession of Bulgaria and Romania.

#### Article 6

This Decision is addressed to the Member States.

laying down transitional measures as regards the dispatch of certain products of the meat and milk sectors covered by Regulation (EC) No 853/2004 of the European Parliament and of the Council from Bulgaria to other Member States

(notified under document number C(2006) 7029)

(Text with EEA relevance)

(2007/31/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to the Treaty of Accession of Bulgaria and Romania, and in particular Article 4(3) thereof,

Having regard to the Act of Accession of Bulgaria and Romania, and in particular Article 42 thereof,

Having regard to Council Directive 89/662/EEC of 11 December 1989 concerning veterinary checks in intra-Community trade with a view to the completion of the internal market (¹), and in particular Article 9(4) thereof,

Whereas:

- Regulation (EC) No 852/2004 of the European (1)Parliament and of the Council of 29 April 2004 on the hygiene of foodstuffs (2) lays down general rules for food business operators on the hygiene of foodstuffs, based on hazard analysis and critical control points principles. It provides that food business operators are to comply with the structural requirements based on those principles. Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin (3) supplements the rules laid down in Regulation (EC) No 852/2004. The rules laid down in Regulation (EC) No 853/2004 include specific requirements for meat and milk processing establishments.
- (2) According to the results of a Food and Veterinary Office (FVO) mission to Bulgaria carried out from 27 November 2006 to 1 December 2006 certain processing estab-

lishments in the meat and milk sectors do not comply with the provisions of Regulations (EC) No 852/2004 and (EC) No 853/2004.

- (3) Furthermore, the current traceability system in Bulgaria is not sufficient to cover the needs of the situation in Bulgaria under conditions where meat coming from third countries and meat obtained in Bulgaria before 1 January 2007, and raw milk in Bulgaria, which do not comply with the requirements of those Regulations, are on the territory of Bulgaria.
- (4) Taking into account the current situation in Bulgaria, it is appropriate to provide for transitional measures as regards certain products of the meat and milk sectors.
- (5) During the transitional period the situation of all processing establishments in the meat and milk sectors has to be assessed in view to ensure the completion of the upgrading process of certain establishments to be in compliance with Community requirements. Furthermore the traceability system has to be improved to meet Community standards.
- (6) During the transitional period, it is necessary to provide for a prohibition on the dispatch of certain products of the meat and milk sectors from Bulgaria to other Member States. However, it is appropriate to provide for a derogation for certain processing establishments authorised under Community legislation to export those products to the Community before 1 January 2007, in the light of guarantees available for those establishments.
- (7) The transitional period provided for in this Decision should be limited to one year. The situation of the meat and milk sectors in Bulgaria is to be reviewed before the end of that period, in particular in view of the results of new FVO inspections to be carried out in January 2007.
- (8) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on the Food Chain and Animal Health,

HAS ADOPTED THIS DECISION:

#### Article 1

This Decision shall apply to products of the meat and milk sectors covered by the following Sections of Annex III to Regulation (EC) No 853/2004:

- (a) Section I (meat of domestic ungulates);
- (b) Section II (meat from poultry and lagomorphs);
- (c) Section III (meat of farmed game);
- (d) Section IV (wild game meat);
- (e) Section V (minced meat, meat preparations and mechanically separated meat);
- (f) Section VI (meat products); and
- (g) Section IX (raw milk and dairy products).

#### Article 2

- 1. The products referred to Article 1 ('the products') shall not be dispatched from Bulgaria to other Member States.
- 2. Member States shall ensure, in accordance with Directive 89/662/EEC and in particular Article 3 thereof, that the products are not traded between Member States.

#### Article 3

By way of derogation from Article 2(1), Member States shall authorise the trade in products which are obtained in a processing establishment listed in the Annex provided that the products:

- (a) bear the Community health mark or identification mark, as referred to in points (a) and (b) of Article 5(1) of Regulation (EC) No 853/2004, of the processing establishments concerned;
- (b) are accompanied by a document, as provided for in Article 14 of Regulation (EC) No 854/2004 of the European Parliament and of the Council (¹), in which the competent authority of Bulgaria certifies the following:

"Products in conformity with Commission Decision 2007/31/EC".

#### Article 4

This Decision shall apply subject to and as from the date of the entry into force of the Act of Accession of Bulgaria and Romania.

It shall apply until 31 December 2007.

This Decision will be reviewed before this date in particular in view of the results of new FVO inspections carried out in January 2007.

#### Article 5

This Decision is addressed to the Member States.

THE MANAGEMENT BOARD OF EUROPOL.

Having regard to the Protocol drawn up on the basis of Article K.3 of the Treaty on European Union and Article 41(3) of the Europol Convention, on the privileges and immunities of Europol, the members of its organs, the deputy directors and employees of Europol (1), and in particular Article 10 thereof,

#### Whereas:

- (1) The Council decided on 4 December 2006 to adapt the salaries and emoluments for Europol officials with 1,6 % with retroactive effect as of 1 July 2005.
- (2) The Management Board decided on 5 December 2006 to effect an increase in the amounts mentioned in Article 4 of the Appendix to the Decision of the Management Board of 16 November 1999 (²) by the same percentage and as of the same date as determined by the Council Decision of 4 December 2006 mentioned under point 1.
- (3) In accordance with the same decision of the Management Board of 5 December 2006, the values thus established should be published in the Official Journal of the European Union,

HAS DECIDED AS FOLLOWS:

#### Article 1

With effect from 1 July 2005:

- 1. The value mentioned in the first sentence of Article 4 of the Appendix to the Decision of the Europol Management Board of 16 November 1999 shall be replaced by EUR 112,00.
- 2. The values in euro units of the table included in Article 4 of the Appendix to the Decision of the Europol Management Board of 16 November 1999 shall be replaced by the following:
