Following the decision adopted by the Council at its meeting of 22 May 1978 to open negotiations with Algeria, Morocco, Tunisia, Egypt, Jordan, Lebanon and Syria, for the conclusion of agreements extending the interim agreements concluded with these countries, the Commission is forwarding via this communication the draft agreements, the texts of which have been approved by the delegations of the countries concerned.

The Commission recommends that the Council approve the results of these negotiations and initiate the signing and conclusion procedure. To this end, it is forwarding the following recommendations for regulations approving the agreements extending the interim agreements.

customs duties on imports into the Community shall be reduced by 80 %. Furthermore in derogation from paragraph 1 and within the limits of an annual volume of 500 000 hectolitres, the import prices, plus customs duty actually levied, must be not less than the reference prices less 15 % of the difference between the reference price and the guide price.

For the application of the preceding subparagraph:

- "guide price" shall mean the R I type guide price as regards red wine, and the A I type guide price as regards white wines;
- "reference price" shall mean the prices applicable to the wine in question, as established by the Community and in force at any given time during the period concerned.

3. The wine referred to in paragraph 1 and entitled under Algerian law to one of the following designations of origin:

- Aïn-Bessem — Bouïra,
- Médéa,
- Coteaux du Zaccar,
- Dahra,
- Coteaux de Mascara,
