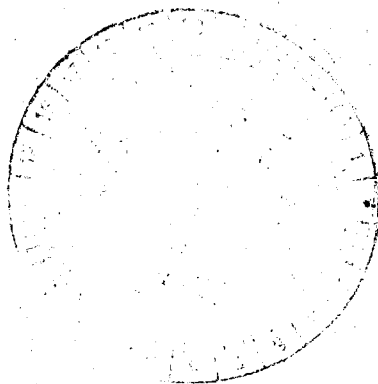

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals (1), as last amended by Regulation (EEC) No (2), and in particular Article 23(1) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 2749/75 of 29 October 1975 on the reduction in the levy applicable to certain imports of feed grain into the Italian Republic as from the 1973/74 marketing year (3) specified that the levy reduction on feed grain imported into Italy by sea would be progressively diminished in order to permit the Italian market to be adapted to the common organization; whereas, however, despite the efforts made, it has not been possible to complete the improvement of port facilities in Italy by the time anticipated; whereas, this measure should therefore be continued for the marketing year 1978/79,

HAS ADOPTED THIS REGULATION:

Article 1

The Italian Republic may reduce by 3 units of account per tonne the import levy on barley, oats, maize, sorghum and millet imported into Italy by sea during the marketing year 1978/79.

Article 2

Regulation (EEC) No 2749/75 is hereby repealed.

Article 3

This Regulation shall enter into force on 1 August 1978.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
