

**Communications from the Commission under Article 9 (9) of Council Regulation (EEC)
No 3286/80 of 4 December 1980**

By virtue of Article 9 (1) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change to the import arrangements applied in United Kingdom with regard to Czechoslovakia with effect from 17 July 1981:

- The amount of the quota for textile category No 100 in Annex VI (i) to Council Decision 80/1278/EEC is raised, as an exceptional measure for 1981, to 20 tonnes.

By virtue of Article 9 (3) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change(s) to the import arrangements applied in the Federal Republic of Germany with regard to State-trading countries with effect from 23 July 1981:

- Exceptional opening, for 1981, of an import quota of 1 000 cycles not motorized (CCT heading No 87.10).

By virtue of Article 9 (1) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change to the import arrangements applied in Italy with regard to the German Democratic Republic with effect from 30 July 1981:

- Exceptional opening, for 1981, of an additional quota of Lit 350 million for the importation of synthetic organic dyestuffs (CCT heading No 32.05).

By virtue of Article 9 (1) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change to the import arrangements applied in Italy with regard to the People's Republic of China with effect from 4 August 1981:

- Exceptional opening, for 1981, of an import quota of 5 700 cycles not motorized (CCT heading No 87.10).

By virtue of Article 9 (1) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change(s) to the import arrangements applied in Italy with regard to Poland with effect from 6 August 1981:

- Exceptional opening, for 1981, of additional quotas for imports of:
 - Diesel engines and parts (CCT heading No ex 84.06) Lit 100 million.
 - Pleasure craft and sports craft (CCT heading No ex 89.01) Lit 200 million.

By virtue of Article 9 (1) of Council Regulation (EEC) No 3286/80 of 4 December 1980 on import arrangements in respect of State-trading countries ⁽¹⁾, the Commission has adopted the following change(s) to the import arrangements applied in France with regard to Czechoslovakia with effect from 25 August 1981:

- the amounts given in Annex VI (i) to Council Decision 80/1278/EEC of 22 December 1980 in respect of textile categories Nos 35, 36, 37 and 50 are hereby amended as follows on an exceptional basis for 1981:
