You may submit a complaint against a decision, or lack thereof, that directly and immediately affects your legal status as a candidate, only if the rules governing the selection procedure have clearly been infringed. **The Executive Director of EUIPO cannot overturn a value judgment made by a selection board** (see section 6.4).

Arrangements for administrative complaints are as follows:
