COMMISSION REGULATION (EEC) No 411/83

of 22 February 1983

amending Regulations (EEC) No 3319/82, (EEC) No 3504/82, (EEC) No 3506/82, (EEC) No 294/83, (EEC) No 295/83 and (EEC) No 336/83 opening standing invitations to tender for the export of common wheat of bread-making quality held by intervention agencies

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 27,27/75 of 29 October 1975 on the common organization of the market in cereals (1), as last amended by Regulation (EEC) No 1451/82 (2), and in particular Article 7 (5) thereof,

Whereas Article 3 of Council Regulation (EEC) No 2738/75 of 29 October 1975 laying down general rules for intervention on the market in cereals (3) provides that cereals held by the intervention agencies shall be disposed of by invitation to tender;

Whereas Commission Regulation (EEC) No 1836/82 (4) lays down the procedure and conditions for the disposal of cereals held by intervention agencies;

Whereas Commission Regulation (EEC) No 3319/82 (5), as amended by Regulation (EEC) No 410/83 (6), opened a standing invitation to tender for the export of 500 000 tonnes of common wheat of bread-making quality held by the German intervention agency;

Whereas Commission Regulation (EEC) 3504/82 (7) opened a standing invitation to tender for the export of 75 000 tonnes of common wheat of bread-making quality held by the Danish intervention agency;

Commission Whereas Regulation (EEC) No 3506/82 (8), as amended by Regulation (EEC) No 358/83 (9), opened a standing invitation to tender for the export of 450 000 tonnes of common wheat of bread-making quality held by the French intervention

Whereas Commission Regulation (EEC) No 294/83 (10) opened a standing invitation to tender for the export of 100 000 tonnes of common wheat of bread-making quality held by the United Kingdom intervention agency;

Whereas Commission Regulation (EEC) No 295/83 (11) opened a standing invitation to tender for the export of 75 000 tonnes of common wheat of bread-making quality held by the Netherlands intervention agency;

Whereas Commission Regulation (EEC) No 336/83 (12) opened a standing invitation to tender for the export of 75 000 tonnes of common wheat of bread-making quality held by the Greek intervention agency;

Whereas the period of validity of export licences was fixed for France and Greece as running from the date of issue until the end of the second month following and for the other countries as running from the date of issue until the end of the third month following; whereas a special period of validity should be introduced for exports to the People's Republic of China;

Whereas the measures provided for in this Regulation are in accordance with the Management Committee for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

Article 3 of Regulation (EEC) No 3319/82 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined in Article 9 of Regulation (EEC) No 1836/82 until the end of the third month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

2. Article 3 of Regulation (EEC) No 3504/82 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined in Article 9 of Regulation (EEC) No 1836/82 until the end of the third month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

3. Article 3 of Regulation (EEC) No 3506/82 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined in Article 9 of Regulation (EEC) No 1836/82 until the end of the second month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

4. Article 3 of Regulation (EEC) No 294/83 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined in Article 9 of Regulation (EEC) No 1836/82 until the end of the third month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

5. Article 3 of Regulation (EEC) No 295/83 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined in Article 9 of Regulation (EEC) No 1836/82 until the end of the third month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

6. Article 3 of Regulation (EEC) No 336/83 is replaced by the following:

'Article 3

Export licences shall be valid from their date of issue as defined by Article 9 of Regulation (EEC) No 1836/82 until the end of the second month following.

For exports to the People's Republic of China, however, licences shall be valid until 31 July 1983.'

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
