Nõukogu määruse (EÜ) nr 1338/2001 artikli 2 punktis b nimetatud pädevad siseriiklikud asutused

Nõukogu määrusega (EÜ) nr 1338/2001, ⁽¹⁾ milles sätestatakse euro võltsimise takistamiseks vajalikud meetmed, on ette nähtud, et *Euroopa Liidu Teatajas* avaldataks pädevate siseriiklike asutuste nimekiri.

Nõukogu määrusega (EÜ) nr 1339/2001 ⁽²⁾ laiendati nõukogu määruse (EÜ) nr 1338/2001 mõju neile liikmesriikidele, kes ei ole eurot ühisrahana kasutusele võtnud.

Kooskõlas nende määrustega on liikmesriigid määranud asutused, kes on pädevad siseriiklikul tasandil võltsimise vastu võitlema.

Komisjon koostas nendest pädevatest siseriiklikest asutustest nimekirja. Alljärgnevalt esitatud nimekirjaga asendatakse *Euroopa Liidu Teatajas* (ELT C 264, 12.8.2015, lk 1–29) avaldatud pädevate siseriiklike asutuste nimekiri.
