

## JÄSENVÄLTIÖIDEN TIEDOTTEET

**Neuvoston asetuksen (EY) N:o 1005/2008 22 artiklan 2 kohdan mukaisesti julkaistu Euroopan komission tiedote neuvoston asetuksen (EY) N:o 1005/2008 20 artiklan 1, 2 ja 3 kohdan sekä liitteen III mukaisista lippuvaltioiden ilmoituksista (valtioiden ja niiden toimivaltaisten viranomaisten luettelo)**

Jäljempänä mainitut kolmannet maat ovat ilmoittaneet Euroopan komissiolle annetun neuvoston asetuksen (EY) N:o 1005/2008 (¹) 20 artiklan 1, 2 ja 3 kohdan sekä liitteen III mukaisesti ne julkiset viranomaiset, joilla on asetuksen 12 artiklassa käytöönnotetun saalistodistusjärjestelmän mukaisesti seuraavat valtuudet:

- a) lippuna alla purjehtivien kalastusalusten rekisteröinti;
- b) kalastuslisenssien myöntäminen kalastusaluksilleen ja niiden voimassaolon keskeyttäminen tai niiden peruuttaminen;
- c) 12 artiklassa tarkoitetuissa saalistodistuksissa annettujen tietojen todennäköisyyden todistaminen ja näiden todistusten varmentaminen;
- d) lakien, asetusten ja säilyttämisen- ja hoitotoimenpiteiden, joita niiden kalastusalusten on noudatettava, täytäntöönpano, valvonta ja noudattamisen valvonta;
- e) saalistodistusten tarkistaminen jäsenvaltioiden toimivaltaisten viranomaisten avustamiseksi 20 artiklan 4 kohdassa tarkoitettun hallinnollisen yhteistyön osana;
- f) liitteessä II olevan mallin mukaisten saalistodistuslomakkeiden toimittaminen; ja
- g) näiden ilmoitusten ajan tasalle saattaminen.
