KOMISIJOS ĮGYVENDINIMO REGLAMENTAS (ES) Nr. 1116/2011

2011 m. spalio 31 d.

kuriuo iš dalies keičiamas Tarybos reglamentas (EB) Nr. 2368/2002, įgyvendinantis Kimberley proceso sertifikavimo schemą dėl tarptautinės prekybos neapdorotais deimantais

EUROPOS KOMISIJA,

atsižvelgdama į Sutartį dėl Europos Sąjungos veikimo,

atsižvelgdama į 2002 m. gruodžio 20 d. Tarybos reglamentą (EB) Nr. 2368/2002, įgyvendinantį Kimberley proceso sertifikavimo schemą dėl tarptautinės prekybos neapdorotais deimantais ⁽¹⁾, ypač į jo 20 straipsnį,

kadangi:

(1) 2010 m. lapkričio mėn. Jeruzalėje įvykusiame plenariame posėdyje Kimberley proceso dalyviai priėmė sprendimą, kuriuo preliminariai pritarė, kad Svazilandas būtų įtrauktas į Kimberley proceso dalyvių sąrašą. Išsprendus tam tikrus likusius klausimus, šis pritarimas patvirtinamas Kimberley proceso sertifikavimo schemos pirmininko pareiškimu;

(2) 2011 m. gegužės 30 d. pareiškimu Kimberley proceso sertifikavimo schemos pirmininkas patvirtino, kad Svazilandas tapo Kimberley proceso dalyviu;

(3) Reglamento (EB) Nr. 2368/2002 II priedas turėtų būti atitinkamai iš dalies pakeistas,
