

KOMISIJAS ĪSTENOŠANAS REGULA (ES) 2020/130**(2020. gada 28. janvāris),****ar ko groza Padomes Regulu (EK) Nr. 2368/2002 par Kimberli procesa sertifikācijas sistēmas īstenošanu starptautiskajā tirdzniecībā ar neapstrādātiem dimantiem**

EIROPAS KOMISIJA,

ņemot vērā Līgumu par Eiropas Savienības darbību,

ņemot vērā Padomes 2002. gada 20. decembra Regulu (EK) Nr. 2368/2002 par Kimberli procesa sertifikācijas sistēmas īstenošanu starptautiskajā tirdzniecībā ar neapstrādātiem dimantiem ⁽¹⁾ un jo īpaši tās 20. pantu,

tā kā:

- (1) Regulas (EK) Nr. 2368/2002 II pielikumā ir uzskaitīti Kimberli procesa sertifikācijas sistēmas dalībnieki un to ieceltās kompetentās iestādes.
- (2) Vairāku Kimberli procesa sistēmas dalībnieku kompetento iestāžu adreses ir jāatjaunina.
- (3) 2019. gada septembrī Kimberli procesa sistēmas dalībnieki saņēma paziņojumu no Ķīnas Tautas Republikas, ka Ķīnas Tautas Republikas Makao Īpašās Pārvaldes Apgabals no 2019. gada 1. oktobra oficiāli īsteno Kimberli procesa sertifikācijas sistēmu.
- (4) Tādēļ būtu attiecīgi jāgroza Regulas (EK) Nr. 2368/2002 II pielikums. Lai Ķīnas Tautas Republikas Makao Īpašās Pārvaldes Apgabals varētu pēc iespējas drīz īstenot Kimberli procesa sertifikācijas sistēmu attiecībā uz Savienību, šai regulai būtu steidzamības kārtā jāstājas spēkā nākamajā dienā pēc tās publicēšanas *Eiropas Savienības Oficiālajā Vēstnesī*,

IR PIENĒMUSI ŠO REGULU.

Regulas (EK) Nr. 2368/2002 II pielikumu aizstāj ar šīs regulas pielikuma tekstu.
