Wara li kkunsidra t-Trattat li jistabbilixxi l-Komunità Ewropea ta' l-Energija Atomika, u b'mod partikolari l-Artikolu 167 tiegħu,

Wara li kkunsidra l-Att ta' l-Adeżjoni tal-Bulgarija u tar-Rumanija, u b'mod partikolari l-Artikoli 12 u 48 tiegħu,

Wara li kkunsidra l-proposti tal-gvernijiet tar-Repubblika tal-Bulgarija u tar-Rumanija,

Wara li kkunsidra l-opinjoni tal-Kummissjoni,

Billi:

- (1) Il-membri tal-Kumitat Ekonomiku u Soċjali Ewropew ġew nominati, għall-perijodu mill-21 ta' Settembru 2006 sa l-20 ta' Settembru 2010, bid-Deciżjonijiet tal-Kunsill 2006/524/KE ⁽¹⁾, Euratom, 2006/651/KE, Euratom ⁽²⁾ u 2006/703/KE, Euratom ⁽³⁾.
- (2) Konsegwentement għall-adeżjoni tar-Repubblika tal-Bulgarija u tar-Rumanija ma' l-Unjoni Ewropea, huwa meħtieġ li l-Kumitat Ekonomiku u Soċjali Ewropew jiġi
