DEĊIŻJONI TAL-KUNSILL (UE) 2015/190

tal-5 ta' Frar 2015

li taħtar il-membri u membri supplenti tal-Kumitat tar-Regġuni għall-perijodu mis-26 ta' Jannar 2015 sal-25 ta' Jannar 2020

IL-KUNSILL TAL-UNJONI EWROPEA,

Wara li kkunsidra t-Trattat dwar il-Funzjonament tal-Unjoni Ewropea, u b'mod partikolari l-Artikolu 300(3) u l-Artikolu 305 tiegħu,

Wara li kkunsidra d-Deciżjoni tal-Kunsill 2014/930/UE tas-16 ta' Dicembru 2014 li tiddetermina l-kompożizzjoni tal-Kumitat tar-Regġuni ⁽¹⁾,

Wara li kkunsidra l-proposti li saru minn kull Stat Membru,

Billi:

- (1) L-Artikolu 300(3) tat-Trattat jehtieg li membri jew membri supplenti tal-Kumitat tar-Regġuni, minbarra li jkunu rappreżentanti ta' korpi reġjonali jew lokali, jew ikollhom mandat elettoralu ta' awtorità reġjonali jew lokali jew ikunu politikament responsabbli quddiem assemblea eletta.
- (2) L-Artikolu 305 tat-Trattat jipprevedi li l-membri tal-Kumitat tar-Regġuni u numru ugwali ta' membri supplenti jinhatru mill-Kunsill għal hames snin skont il-proposti magħmula minn kull Stat Membru.
- (3) Ladarba l-mandat tal-membri u l-membri supplenti tal-Kumitat tar-Regġuni skada fil-25 ta' Jannar 2015, kien jehtieg li jinhatru membri u membri supplenti godda.
- (4) Fis-26 ta' Jannar 2015, il-Kunsill adotta d-Deciżjoni (UE) Nru 2015/116 ⁽²⁾ biex hatar il-membri u l-membri supplenti proposti mill-Gvernijiet tal-Belġju, tal-Bulgarija, tar-Repubblika Ċeka, tad-Danimarka, tal-Estonja, tal-Irlanda, tal-Greċja, ta' Spanja, ta' Franza, tal-Kroazja, tal-Italja, ta' Ċipru, tal-Latvja, tal-Litwanja, tal-Lussemburgu, tal-Ungerija, ta' Malta, tal-Pajjiżi l-Baxxi, tal-Awstrija, tal-Portugall, tar-Rumanija, tas-Slovenja, tas-Slovakkja, tal-Finlandja, u tal-Isvezja, 23 membru u 23 membru supplenti proposti mill-Gvern Ġermaniż u 18-il membru u 16-il membru supplenti proposti mill-Gvern Pollakk għall-perjodu mis-26 ta' Jannar 2015 sal-25 ta' Jannar 2020. Il-membri u l-membri supplenti li n-nomini tagħhom ma ġewx ikkomunikati lill-Kunsill sat-22 ta' Jannar 2015 ma setgħux jiġu inklużi fid-Deciżjoni (UE) Nru 2015/116.
- (5) Fit-2 ta' Frar 2015 u fit-3 ta' Frar 2015, il-lista tal-membri u l-membri supplenti proposta mill-Gvern tar-Renju Unit kif ukoll il-lista li fiha membru wiehed u membru supplenti wiehed proposti mill-Gvern Ġermaniż ġew ippreżentati lill-Kunsill. Dawk il-membri u l-membri supplenti għandhom jinhatru għall-istess perjodu mis-26 ta' Jannar 2015 sal-25 ta' Jannar 2020 bhala l-membri u s-supplenti mahtura mid-Deciżjoni (UE) Nru 2015/116. Din id-Deciżjoni għandha għalhekk tapplika retroattivament mis-26 ta' Jannar 2015. It-tielet Deciżjoni li taħtar il-membri u l-membri supplenti li jifdal tal-Kumitat tar-Regġuni għall-perijodu mis-26 ta' Jannar 2015 sal-25 ta' Jannar 2020 ser tkun adottata aktar tard,

ADOTTA DIN ID-DEĊIŻJONI:

Artikolu 1
