European Parliament legislative resolution on the proposal for a Council regulation amending Regulations (EC) No 6/2002 and (EC) No 40/94 to give effect to the accession of the European Community to the Geneva Act of the Hague Agreement concerning the international registration of industrial designs (COM(2005)0689 — C6-0058/2006 — 2005/0274(CNS))

The European Parliament,

- having regard to the Commission proposal to the Council (COM(2005)0689) ⁽¹⁾,
 - having regard to Article 308 of the EC Treaty, pursuant to which the Council consulted Parliament (C6-0058/2006),
 - having regard to Rule 51 of its Rules of Procedure,
 - having regard to the report of the Committee on Legal Affairs (A6-0167/2006);
1. Approves the Commission proposal;
 2. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
 3. Asks the Council to consult Parliament again if it intends to amend the Commission proposal substantially;
 4. Instructs its President to forward its position to the Council and the Commission, and to the governments and parliaments of the Member States.
