

Action brought on 22 February 2008 — Gippini Fournier v Commission

*Language of the case: French***Parties***Applicant:* Eric Gippini Fournier (Brussels, Belgium) (represented by: F. Ruggeri Laderchi)*Defendant:* Commission of the European Communities**The subject-matter and description of the proceedings**

First, annulment of the Commission's decision to award no priority points to the applicant in the 2003 Promotion procedure, refusing to award 'DG priority points' and refusing to award points for work in the interest of the institution pursuant to Article 9 of the General provisions for implementing Article 45 of the Staff Regulations. Secondly, an order that the defendant compensate the applicant for the economic loss which he has suffered and will suffer throughout his career because of the delays in his promotions arising from the contested decision and pay him the sum of EUR 2 500 as compensation for non-material damage.

Form of order sought

- Annul the decision to award no priority points to the applicant in the 2003 Promotion procedure, refusing to award 'DG priority points' and refusing to award points for work in the interest of the institution pursuant to Article 9 of the General provisions for implementing Article 45 of the Staff Regulations;
- order the defendant to compensate the applicant for the economic loss which he has suffered and will suffer throughout his career because of the delays in his promotions arising from the contested decision;
- order the defendant to pay the applicant the sum of EUR 2 500 as compensation for the non-material damage suffered;
- order the Commission to pay the costs.

Annulment of the decision of 17 April 2007 in so far as it awards the applicant no additional priority points and therefore upholds the award of two priority points and a total of 23 points in the 2003 Promotion procedure, and an order that the defendant pay compensation.

Form of order sought

- Annul the decision of 17 April 2007 in so far as it awards the applicant no additional priority points and therefore upholds the award of two priority points and a total of 23 points in the 2003 Promotion procedure;
- order the defendant to pay compensation of EUR 5 000;
- order the Commission of the European Communities to pay the costs.
