MINUTES

PROCEEDINGS OF THE SITTING

IN THE CHAIR: Mr VIDAL-QUADRAS ROCA

Vice-President

1. Opening of sitting

The sitting opened at 10.05.

The following spoke:

- Mr Rübig, who complained that the Council was no longer complying with the time limits for answering Members' questions and called on the President of Parliament to see to it that the Council fulfill its obligations in this respect (the President replied that we would take account of these remarks);
- Mr Lipietz, who referred to the petrol crisis facing the Union as a result of the sharp increase in oil prices and called for the Commission, and in particular the Commissioners responsible, to make a statement to Parliament as soon as possible concerning the action to be taken (the President replied this would be difficult to arrange as the week's agenda had already been established; he undertook, however, to try to find a solution).

Mrs Reding, Member of the Commission, stated that she would forward Mr Lipietz' request to Commissioners de Palacio and Monti, and that a suitable time for making the requested statement would be sought, together with the President of Parliament.

2. Agenda

The President announced that, owing to technical problems, a number of amendments tabled by the Verts/ALE Group within the deadlines to the Glase report on undeclared work (A5-0220/2000) had not yet been translated and distributed. The vote on that report, which had been scheduled for midday, had therefore been postponed to the next part-session (20/21 September).

3. Doping in sport and sport in society — Football player transfers (statements with debate) — Community support plan to combat doping in sport — Helsinki report on sport (debate)

The next item was the joint debate on a Council statement, a Commission statement and two reports drawn up on behalf of the Committee on Culture, Youth, Education, the Media and Sport.

Mrs Buffet, President-in-Office of the Council, made a statement on doping in sport and sport in society.

Mrs Reding, Member of the Commission, made a statement on football player transfers.

Mrs Zabell introduced her report on the communication from the Commission to the Council, the European Parliament, the Economic and Social Committee and the Committee of the Regions, on a Community support plan to combat doping in sport (COM(1999) 643 — C5-0087/2000 — 2000/2056(COS)) (A5-0203/2000).
