Expresses, nevertheless, its dissatisfaction with the additional surplus of EUR 2,7 billion for the 2004 budget; considers that the challenges that the European Union is facing today cannot justify such an underspending, in particular in Headings 3 and 4 of the financial perspective as well as pre-accession aid; therefore expects a better level of implementation to be obtained in 2005 in order to reduce significantly the level of EU surplus;
- 3. Has decided to accept Draft amending budget No 3/2005 unamended;
- 4. Instructs its President to forward this resolution to the Council and Commission.

The European Parliament,
